Brief Description

The muiltiyear AWP for 2020-2021 was revised in order to adjust planned budget with actual project implementation. Taking this into consideration, the Project Board met on 27 April 2020 and approved the proposed changes to the multiyear AWP for 2020-2021 and no-cost extension of the project to December 2021. The changes in the AWP reflect the current state of project implementation and the fact that some activities require more time than it was initially planned. During 2020, several major sctivities shall take place: introduction of e-parliament system in 3 LSGs, procurement of insurance services for LSGs in Central Serbia and Vojvodina, as well as initiation of the citizens' satisfaction survey. In 2021, the above mentioned activities shall be finalizes and the activities related to Civil Registers shall take place.

The following changes shall take place:

<u>Activity 1.1</u> MPALSG supported in improving its organizational structure and HRM function; staff skills enhanced

<u>Activity 1.2</u> MPALSG leadership implements improved financial management system and control shall be abolished and the next activity shall be introduced:
