The project is aimed at strengthening the capacity of the Kyrgyz Republic for integrated disaster risk management, as well as regional cooperation of Central Asian countries in this area through:

- Creating of an enabling environment for National Risk Assessment Framework to apply innovative tools;
- Strengthening of National Disaster Risk Monitoring and Early Warning systems as well as avalanche-risk reduction capacities alongside transport corridors;
- Strengthening of Disaster response and early warning capacities;
- Increasing regional cooperation of Central Asian countries Disaster Management Authorities facilitated under the “Central Asia plus Japan” Dialogue

In this regard, the draft does not affect the human rights sphere. In opposite, the project will increase the public service delivery to be protected and saved from disasters, which are fundamental rights.

The implementation of activities under the project is people-centered in particular the development of early warning systems whose warnings are timely and understandable to those at risk. This means that 100% of the total amount of the Project will for the benefit of men or women, including children and disabled. In carrying out activities aimed at improving the skills of MES staff, training to use GIS and remote sensing techniques will be conducted taking into account the gender characteristics of assistance to the population in emergency situations.

Project activities such as construction of avalanche station will be planned and implemented in strict compliance with environmental safety standards, and the design will use heat and energy-saving technologies to protect the environment.
