2.2 Project Result (table)

The project has produced several results, under output 1. The 4 project sites were prepared with groundwork, electricity, water and internet connection for fire station construction in 2020. 2 the preliminary design for fire stations have been improved with KOICA and PMC's inputs. The designs have been reviewed and confirmed by MES and the final design with details will be completed by the end of February 2020. In order to develop technical specifications of the fire station machinery and rescue equipment, UNDP hired an expert, the specifications are being developed and will be shared with KOICA and PMC for their review. Once the specification finalized and confirmed with a national partner, UNDP will conduct biddings to procure the machinery and equipment.

Under output 2. UNDP reviewed and analyzed the normative-legal framework of fire-rescue services in the Kyrgyz Republic with a lawyer, the report was presented to members of PMC and discussed with MES in September 2019. In cooperation with PMC, UNDP conducted several meetings with MES to improve the understating of the project, role, and responsibility, as well as coordination cooperation among the agencies.

This project is 4 years project periods, according to the implementation schedule the performance level will be achieved by 2022.

Findings	A kickoff meeting was held as of 26 April 2019 with representatives of MES, KOICA, and UNDP, where the agreement was reached on sharing information of activities being implemented and activities planned as well as sharing copies of legal documents for land plots. A construction expert (civil engineer) has been hired by UNDP who provides assistance and advice in technical matters related to the design of buildings for fire and rescue units.
	The Terms of Reference for development design-estimation documentation for the construction of fire-rescue services was developed. As a result of bidding (announced on April 30, 2019) two contractors were selected and contracts were signed with OJSC "Design Institute Kyrgyzgiprostroi" (northern region) and CJSC "Oshgiprostroi" (southern region) on July 17, 2019.
	Design companies presented the preliminary drawings for future fire- rescue services which were discussed intensively and shared with the Ministry of Emergency Situations of KR (MES) and Project Management Consulting (PMC). PMC and KOICA CM provided their feedback which was accepted by the project and design companies, while the detailed designs are developed.
	The completion deadline of the fire station design has been delayed due to the late issue of documents in relation to approval by the authorized state body. The request was made to the State Architectural and Construction Authority in September 2019 and the permission documents for construction the fire and rescue services were issued only at the end of November 2019. Therefore, the design companies made a request to extend their contract until the end of February 2020 (no-cost extension). As of date, contracts with design companies are extended till February 29, 2020.

The results of a review of legislation identified numerous discrepancies and inconsistencies are in place in current legislation, as well as the functions related to prevention and firefighting are not clearly restricted. Moreover, there is a collision between firefighting and rescue units due to reorganization. In this regard, it is recommended to conduct comprehensive legal expertise and develop a draft of normative-legal acts to eliminate the identified gaps and inconsistencies. The report was revised based on MES and PMC comments and recommendations and shared with KOICA and PMC. UNDP suggests further discussion on the findings and its applications.
