**Brief Description** 

In line with the conclusions of the Project Steering Committee held on 19 July 2022, amendment to the Project was adopted and approved by the donor (SIDA).

As reflected upon at the meeting, the Project managed to maintain a high delivery rate and successfully provide support to the beneficiary institution, the National Academy for Public Administration, despite short delays which were mainly caused by the COVID19 pandemic.

For the reasons mentioned above and in order to fully meet the objectives of the project and maximise the effect of provided support, the following adjustments to the project were made:

- 1. **Project duration was amended to reflect a 12 months' non-additional funding extension** in order to ensure that all project activities are implemented effectively, and project objectives are met (the activity period is extended until December 31, 2023).
- 2. **Budget modification** in order to achieve the same project impacts (in line with the attached table).

The following is an overview of adopted budgetary adjustments per project outputs:

1. Activity 2.3.2. "Support for establishing of a library, publishing and research activity", initially planned as a minor digitalization process, due to COVID effects, came to be the main modality of NAPA's work, hence we would like to propose reallocation of additional funds to this activity. The reallocation would include decrease of funds on budget lines such as Printing&Translation, Workshops and trainings, Travel and Company contracts. However, additional funds in the amount of \$35,051.24 should be transferred from the Output 2.3. Ensuring media outreach and visibility of the NAPA and the Kingdom of Sweden as a leading donor in the public sector management reform, to the budget line National consultants from the following budget lines: Company Contracts \$23,730.85; Printing&Translation \$7,000,00; Training, workshops and conferences \$3,112.90 and Travel \$1,207.49.

2. Activity 2.2.1 "Support to preparation and implementation of commercial trainings", with the initial budget of \$30,000.00 on International Consultants and \$20,000.00 on National consultants budget lines. We would like to propose to reallocate the entire amount to the new budget line Grants. With this intervention, we would introduce a grant modality for this activity and invite the Serbian Chamber of Commerce and Industry (SCCI) to submit a project proposal,

without change of the total amount planned for the implementation of this activity. The SCCI is a non-governmental and non-profit association, recognized as the unique association in Serbia with all necessary capacities for conducting this activity. Namely, the SCCI possess HR capacities and the unique network of business subjects that are of great importance for future market research and exploring of possibilities for introduction of the commercial function;

3. For the Activity 2.2.3 Establishment of the NAPA flagship course on professional public sector management for decision makers, we would like to propose to change the modality of implementation for this activity, from Company contracts to a Grant modality, without change of the total amount planned. Namely, benefits from the grant modality will be more in line with NAPA's goal to pilot trainings related to innovation. Also, processes related to company contracts are rigid procurement processes, where possibilities for new initiatives and innovation are limited, having in mind that all services must be defined by a ToR well in advance, with all technical and programmatic details. Through the modality of grants, applicants can submit project proposals for a clear purpose, but without precise definition of approach to work predefined by the end user.

4. For the Activity 2.1.2 - Strengthening and improving the network of trainers, within the Output 2.1. Introducing new methods of training and establishing a training quality assurance system, to be relocated \$24,000.00 to budget line National consultants from the following budget lines: \$16,000.00 from Training, workshops, and conferences and \$8,000.00 from Travel.

5. For the Activity 1.1.2 Development of standard operating procedures in line with the electronic processes, especially in the area of financial management and control, within the Output 1.1. Developing the capacities of the NAPA for effective coordination and implementation of the professional development management system, to be reallocated \$3,200.00 to National consultants budget line from the following: \$1,700.00 Printing and translation and US\$1,500.00 from Training, workshops and conferences.
