Brief Description

This project aims to enhance the technical and expert capacities of the foreign policy and ODA organizations of the MFA of Kazakhstan – Foreign Policy Research Institute and Kazakhstan Agency for International Development (KazAID) and strengthen Kazakhstan's international perception and national image in the global and regional spheres. It has three major outputs:

First, the project targets to enhance Kazakhstan's existing ODA practices by working with FPRI to identify the current challenges, gaps, and corresponding recommendations. Second, the project aims to accelerate the synergy of ODA practices through data integration with two digital tools for KazAID: a National ODA Accounting Dashboard and a Database of Kazakhstan Development Experts, with a specific focus on women professionals. Third, this project improves KazAID's executive capacity to implement projects by engaging in joint activities, sharing experiences as well as mainstreaming cross-cutting issues as gender in the programme cycles. The activity will focus on raising awareness of youth and strengthening women-led volunteering initiatives in UNDP's traditional area of engagement – energy and environment. Third component is financially supported by the Romanian Agency for International Development.

I. PURPOSE AND EXPECTED OUTPUT

This project expects to contribute to Kazakhstan's international position as a development actor through capacitation of its foreign policy and ODA organizations – FPRI and KazAID. It is expected to provide a portfolio of solutions targeting different levels of the challenges to achieve the nation's policy effectiveness and sustainable development, as outlined in UNDP's Country Program Document.

The project will be implemented in line with UNDP policies and procedures, rules and regulations.

Output 1: Evidence is available to the government of Kazakhstan to enhance its understanding and to strengthen its role of a regional development actor

This project expects to deliver a mapping of existing ODA-related policies and institutions in Kazakhstan as part of a broader research on Kazakhstan's soft power to identify existing challenges, gaps, and the according recommendations to the senior officials in collaboration with the FPRI. Additionally, given Kazakhstan's highest commitment to gender equality, the assessment will explore ways on mainstreaming promotion of women and girls' rights, or creating an enabling environment for women and girls in ODA approaches and frameworks as an essential principle to become leading development institution in the region.

Output 2: KazAID has increased technical capacity as a development agency

Second, development of digital ODA-related solutions for KazAID is also expected. This proposal aims to provide comprehensive support to KazAID, focusing on the development of two digital tools: a National ODA Accounting Dashboard and a Database of Kazakhstan Development Experts. A National ODA Accounting Dashboard is a digital platform that will map out, account, and visualize data on Kazakhstan's ODA. The platform will allow KazAID to visualize ODA and generate analytical reports and information by aid country, sector, and time. One of the key functionalities will be a process to collect data on ODA from different Ministries and government agencies in a unified manner. Additionally, a concept of assigning gender marker scores to each development assistance project will be presented. Secondly, UNDP offers to create an online Database of Kazakhstan Development Experts – a pool of local experts who are available for short-term assignments to the countries KazAID is supporting. The database will feature qualified Kazakhstani professionals from different sectors who can be deployed as KazAID consultants with an option to disaggregate specialists by gender. To ensure transparency of selection for roster positions and encourage wider participation of women professionals in the development agenda, a call for Expression of Interest will be announced and dedicated workshop will be held to train women professionals on how to apply and how to build strong proposal to be selected for consultancy. This activity will also create a platform for networking among women professionals, exchange experiences along their professional career tracks and peer support.

Output 3: KazAID has increased capacity to develop and implement youth-engagement and ecovolunteering projects through joint work with UNDP

Lastly, this project expects to create joint UNDP-KazAID intervention to help build project implementation capacity of KazAID. Together with the UN Volunteers Programme, UNDP proposes to mobilize and train civil society volunteers in different locations of Kazakhstan and Central Asia for the needs of its environmental projects, following the best international and national practices. A network of volunteers in several locations will be created and capacitated on the environmental agenda that UNDP promotes. The proposed activity will put specific focus on women-led initiatives to promote their active participation and equip with necessary skills and knowledge and become agents of change in their communities. Gender mainstreaming in programme cycles will be one of the main components of capacity building activities. To ensure cross-pollination of practices and experience exchange, a regional conference for volunteers from Central Asia will be organized.

II. MANAGEMENT ARRANGEMENTS

The project will be implemented through a direct implementation modality (DIM), fully managed by UNDP Kazakhstan. UNDP Project Manager will exercise overall oversight of implementation, lead coordination, and consultations with key national partners, KazAID, FPRI, and other stakeholders. The project will be supervised by the assigned project manager, that will also be responsible for

quality assurance and achieving results and procedures, and that the approved resources are used in line with the conditions and instructions by the Ministry of Foreign Affairs outlined in the allocation letter, as well as in accordance with UNDP financial rules and regulations and project management policy as set out in the Financial Resources Management Section of the Programme and Operations Policies and Procedures.

The project implementation will benefit from the existing project infrastructures of Kazakhstan ODA on a subnational level. It will strengthen Kazakhstan's existing ODA practices, consolidate and digitalize the ODA platform, and build Kazakhstan's ODA implementation capabilities. Close and regular communication will be ensured with key institutions and government partners, including the Ministry of Foreign Affairs, FPRI, KazAID, and local authorities for on-the-ground activities.

The project implementation will benefit from the existing project infrastructures of Kazakhstan ODA on a subnational level. It will strengthen Kazakhstan's existing ODA practices, consolidate and digitalize the ODA platform, and build Kazakhstan's ODA implementation capabilities.

Close and regular communication will be ensured with key institutions and government partners, including the Ministry of Foreign Affairs, FPRI, KazAID, and local authorities for on-the-ground activities.

III. MONITORING

Monitoring will be done against gender-sensitive targets and indicators, including through checking data on the spot from workshops, studies, and reviewing progress reports. All data generated as a result of accomplished activities will be gathered using gender-sensitive approach (participation, issues discussed, results achieved, etc.). UNDP Project Manager oversees and coordinates project work to ensure all targets are monitored.

UNDP Project Manager will prepare final consolidated narrative progress and financial reports based on delivered project activities and annual expenses as per annual CDRs. The narrative reports should describe in a coherent manner what is being done at outcome and output level and results achieved upon project implementation including extensive narrative on gender-related results.
