Dear Mexico CO Colleagues,

I hope this email finds you well. We have recently received a contribution from SIDA/Sweden for the ROLSHR Funding Windows, and we wanted to reach out to you in hopes of doing a reversal of the recently allocated funding via Dutch donor through the ROLSHR Pipeline Round 1 2022 to these new Swedish funds. As you may know, we have an obligation with the Dutch donor to have funding earmarked for priority regions with an 80/20 split, meaning 80% goes to the Dutch priority contexts and 20% goes to non-priority contexts, of which Mexico falls into the 20%. As of today, I see that there isn't any expenditure nor encumbrance against the ASL (screenshot below), so we hope you would agree to this arrangement and reversal.

If agreed, we would only need you to do a budget revision for the same project/activities but use donor code 00555 instead of 00182, and the rest of the COA can and should stay the same. Once the budget revision is done, we can then do the ASL, and between the funding windows colleagues and myself, we think this may be able to happen within a week or so. We would also ensure that the one year expenditure period is extended according to the date of the new ASL allocation and not the previous letter.

Please do revert back soonest and we hope this is not too much of an inconvenience for your operations and programming at this point in time.




