##### Briefly describe in the space below how the project mainstreams the human rights-based approach

El proyecto busca generar capacidades en los jóvenes para la reconciliación y la construcción de paz en dos territorios con altos índices de violencia y pocas oportunidades educativas y laborales. En ese sentido, cada uno de los ejes incorporan el enfoque basado en derechos. Las convocatorias comunitarias tendrán un enfoque participativo y rural, producto de los acercamientos del proyecto con institucionalidad local y organizaciones sociales. Todos los esfuerzos del fortalecimiento de capacidades en reconciliación y construcción de paz no solo incorporan el enfoque de Derechos Humanos, sino que buscan materializar acciones que den garantías al Ejercicio de los Derechos Humanos.

##### Briefly describe in the space below how the project is likely to improve gender equality and women's empowerment

Se adoptará un enfoque diferencial de género a lo largo de las etapas de formulación, implementación y evaluación. Más específicamente, los esfuerzos se dirigirán a garantizar la participación e impacto de las mujeres jóvenes en cada uno de los procesos propuestos.

Este objetivo se puede ver en los esfuerzos por identificar y fortalecer las redes y organizaciones de mujeres, así como mujeres líderes que contribuyan a los dos resultados propuestos en esta iniciativa: fortalecer la participación de las mujeres jóvenes en los espacios de participación y generar capacidades que reduce el riesgo de vulneración de derechos y violencia de género. En paralelo, se establecerá un diálogo con instituciones de ambos municipios para fortalecer su capacidad de asegurar la participación de los jóvenes, con énfasis en las mujeres jóvenes, así como priorizar la prevención de la violencia de género. Finalmente, se propone la creación de la Asamblea Regional de la Juventud, teniendo como condición de partida la representación y participación equitativa de las organizaciones y redes de mujeres jóvenes. El objetivo de lo anterior es enfocar las actividades en acciones que contribuyan a la igualdad de género, específicamente a la autonomía física y de decisión de las jóvenes residentes en Santander de Quilichao y Buenaventura.

Esto implica que desde el inicio del proyecto, se promoverán una serie de herramientas y espacios entre los grupos de interés y actores locales para involucrarlos directamente en la gestión y seguimiento de las acciones e iniciativas desarrolladas. Se seleccionarán y utilizarán herramientas de monitoreo participativo (mapeo de alcance o cambio más significativo) o el uso de herramientas TIC basadas en grupos de referencia comunitarios que faciliten la recolección de información que dé fe del avance de planes e iniciativas construidas a partir de los insumos de los participantes, grupos y actores. Esto representa un compromiso en materia de transparencia y rendición de cuentas, que garantiza la coherencia estratégica y programática y la articulación territorial entre las autoridades locales y comunitarias.*



