The project is mainstreaming the human rights approach by strengthening the institutional capacity for realization of digitalization and trade promotion. The project aimed at building trade capacity of the country through the development of institutional digital capacities in order to increase the competitiveness of national partner.

UNDP as well as the Ministry of Trade and Foreign Economic Relations of Turkmenistan (Implementing partner) have realized the importance and relevance of gender dimension of this project. The project aimed at strengthening the digital capacity of the Ministry through conducting a review of the process of analyzing information and data on trade and foreign economic activity, as well as the development and introduction of a digital analytical platform for export-import operations. The review will include the analysis of gender dimension, where possible, while the public employees' capacities will be strengthened to mainstream gender in the collection of data and evidence. In addition, collection of gender and sex disaggregated statistics and evidence via developed analytical platform helps fill critical knowledge gaps, essential to deliver on the principle of "leaving no one behind" and determine strategic decisions that enable and encourage women's economic participation and ensure women equally benefit from trade policy, which is integral to the overall sustainable and inclusive economic development.


