Project Result 1: Consultation and support for the development and implementation of the pilot project of electronic data interchange system (EDI) (EDI system will consist of Interagency Electronic Data Interchange system and Interagency Document Workflow system), and the organization of the EDI system operator.

The project hired the International Consultant-Chief Technical Adviser (IC-CTA) to support the project staff with development of the terms of reference (ToR) for the implementation of the EDI system based on the X-Road solution. The IC-CTA in consultations with the specialists from the Agency "Turkmenaragatnashyk" and project staff elaborated the ToR which was further used in preparation of the RFP-UNDP-TKM-00060 announced on November 13, 2023 (the initial deadline of December 11, 2023, was extended by January 8, 2024 due to limited number of bids).

Output indicators: 1.1.1 International experience in building systems of interdepartmental electronic interaction and systems of interdepartmental document management was studied.

The second project activity- a Study Tour was postponed to the next year due to the late start of project activities. The activity was discussed at the Project Board meeting on November 30, 2023. It was agreed that the study tour to Kyrgyzstan will be arranged in May-June 2024. The reason behind choosing Kyrgyzstan was explained by the level of digital maturity and Internet penetration of the country as well as infrastructure development and features of the culture of interaction according to the basic principles of information exchange. The initial agreement with the respective entities of the Kyrgyzstan was reached. During the study visit, the technical team of the national partner will visit the Ministry of Digital Development of Kyrgyzstan and the State Enterprise "Tunduk", which is the operator of the EDI system in Kyrgyzstan to share experience in the following areas:

- organizational structure of the authorized body on digital transformation,
- competencies and powers of the authorized body on digital transformation,
- specific aspects of interaction with state bodies,
- legal and regulatory framework for the authorized body's activities;
- experience of integration with state bodies.

The second study tour will be further discussed with national partner and will be organized to one of the European countries with a high level of digitalization of public administration, such as Estonia, Finland, Moldova.

2. Progress Reporting

Please summarize the main achievements during the project cycle:

Project Result 1: Consultation and support for the development and implementation of the pilot project of EDI system (EDI system will consist of Interagency Electronic Data Interchange system and Interagency Document Workflow system), and the organization of the EDI system operator

The project was launched on February 27, 2023. Two Project Board meetings were held: the first meeting was conducted on February 27, 2023, and the second on November 30, 2023. The main achievements of the project in the initial year of implementation were around preparation of the ToR for the implementation of the EDI system based on the X-Road solution. The project team supported by IC-CTA analyzed the IT infrastructure and the national partner's readiness to implement the EDI system. As an outcome of the joint efforts a detailed technical specification with certain milestones and a schedule for their implementation was elaborated. Based on this technical specification, a tender process was launched to hire a consulting company to carry out works on the ground on development and implementation of the pilot project of EDI system.

The UNDP project team also participated in several events organized by the national partners to raise awareness of UNDP's work in the framework of digital transformation, such as the International Youth Forum "Dialogue is a Guarantee of Peace" held on October 2, 2023, International conference and exhibition "Turkmentel 2023" conducted on November 9-10, 2023, as well events dedicated to the celebration of the World Day for Sustainable Transport on November 24-25, 2023.

3. Gender Equality and Women's Empowerment

Although the project does not have specific Gender Equality and Women's Empowerment (GEWE) components, certain activities were carried out to promote GEWE and youth empowerment at country level in line with the global goals and commitments for GEWE. For instance, on October 2, 2023, the project manager moderated the session Digital diplomacy and peace making: Using technology and social media for positive peacebuilding efforts in the International Youth Forum "Dialogue is Guarantee of Peace", where UNDP experts shared their experience in using the X-Road platform for electronic data exchange. Young female IT specialists were invited to the event to share their success stories in computer science and IT in the context of a significant transformation in perceptions of the role of women and girls in STEM, which has been effectively supported by international organizations, incl. UNDP. Also, during the international exhibition «Turkmentel – 2023», the project team had orientation meetings and discussions with young girls and women, students studying in computer/information science degrees in national universities.
