**AMENDMENT #03 to the Third-Party Cost-Sharing Agreement between Norwegian Ministry of Foreign Affairs (MFA), Represented by the Representative Office of Norway to the Palestinian Authority and the United Nations Development Programme (UNDP) Regarding "UNDP-Access Coordination and Monitoring Support, Gaza", State of Palestine**

**Subject: Amendment # 3 for Cost-Sharing Agreement (Grant 4)**

THIS AGREEMENT, between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP) and THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS, ("the Parties"), amends the Cost-Sharing Agreement, signed on 18 October 2015, and amendment number which was signed on 18 May 2016, and amendment number 02 which was signed on 9 May 2017, under which the parties agreed to cooperate in the implementation of the "Access Coordination and Monitoring Support, Gaza", project (the Project) in the Occupied Palestinian Territory (oPt), which stipulated a contribution of NOK 14,500,000 to the project.

WHEREAS the Parties agree to amend certain provisions to the Agreement;

NOW THEREFORE, the relevant provisions of the Agreement indicated below are hereby amended to read as follows:

**Article II the Contribution**

- **The paragraph** "MFA shall, subject to Parliamentary Appropriation and on the terms and conditions set forth in this Agreement, and Article II, Paragraph 5 of the Framework Agreement in accordance with the schedule of payments set out below, contribute to UNDP an amount not exceeding NOK 14 500 000 to be used exclusively to finance the Project and cover the costs covering the planned period 1<sup>st</sup> October 2015 to 31<sup>st</sup> August 2017. "

**Shall be replaced as follows:**

-"MFA shall, subject to Parliamentary Appropriation and on the terms and conditions set forth in this Agreement, and Article II, Paragraph 5 of the Framework Agreement in accordance with the schedule of payments set out below, contribute to UNDP an amount not exceeding NOK 14 500 000 to be used exclusively to finance the Project and cover the costs covering the planned period 1<sup>st</sup> October 2015 to 30 June 2018."

**Article IV Administration and Reporting**

- **Paragraph number 2** "Representatives of MFA and UNDP shall have consultations in July 2016, January 2017 and June 2017, in accordance with the Framework Agreement Article VIII in order to:

- a. Review the Progress Reports of the Project that must be prepared to cover the project implementation up June 2016, up to December 2016 and final report to cover the whole grant.
- b. Discuss possible revisions of plans and budgets.
- c. Discuss issues of special concern for the implantation of the Project."




**Shall be replaced as follows:**

"Representatives of MFA and UNDP shall have consultations in July 2016, January 2017, June 2017, and December 2017 in accordance with the Framework Agreement Article VIII in order to:

- a. Review the Progress Reports of the Project that must be prepared to cover the project implementation up June 2016, up to December 2016, and final report to cover the whole grant. And separate final report for the activities which will be conducted over the period from September 2017 to June 2018.
- b. Discuss possible revisions of plans and budgets.
- c. Discuss issues of special concern for the implantation of the Project."

All other terms and conditions of the Agreement, except as amended herein, shall remain unchanged and shall continue in full force and effect.
