1. HIGH LEVEL NARRATIVE

This section is used to highlight major achievements of the project to date. The content is also used for required reporting to UNDP's funding window on climate change and disaster risk reduction, through which UNDP articulates to donors how their contributions have had a catalytic effect, in terms of expanded partnerships, attracting other donors/resources, scaling up of initiatives, etc. In the case of the NDC Support Programme, our funding contributes directly toward zero-carbon development, in support of the overarching vision of UNDP's Strategic Plan to simultaneously achieve the eradication of poverty and the significant reduction in inequalities and exclusion.

Contribution to UNDP Strategic Plan

How did the project target the most vulnerable/ poor / disadvantaged people and communities and did it do that successfully?

During 2019, the Climate Change Office worked in the elaboration of an update proposal of NDC. It proposes that planning and implementation of adaptation actions will be guided through 4 crosscutting axes, and one of them is about iii) Inclusion of vulnerable groups, with special focus on gender. Additionally, with project support gender approach was incorporated in the NDC contributions of the Adaptation, Capacity Building and Technology Transfer components.

Between October 15th 2019 and December 2nd 2019, a public consultation period on the NDC updating proposal was opened. Available channels to receive citizen observations were:

- Offices of the Ministry of Environment (national and 16 regional);
- web platform: http://consultasciudadanas.mma.gob.cl

The public consultation process was complemented with 5 informative workshops in different cities and 3 webinars, which were opened for all public, in an effort to disseminate NDC proposal in all the country. Webinar-link was disseminated via a 1,800 contacts database.

This process was attended by representatives of private business associations, academics, scientists, public services, civil society organizations and networks of municipalities for climate change.

What did the project achieve in relation to the output and output indicators¹, and what specific interventions led to the change?

About output indicators, during 2019 the Climate Change Office of Chile was working on two principal climate change instruments: elaboration of a Climate Change Framework Law (CCFL) and the NDC update process. CCFL integrate all climate change instruments and also the governance, and propose a long term goal of carbon neutrality by 2050.

In this context NDC is one of the instrument aligned by long term goal of CCFL, that establish short term goal by 2030 in 4 components: i) mitigation (includes AFOLU), ii) adaptation, iii) Integration (circular economy and ocean) and iv) means of implementation (capacity building, technology transfer and finance). As result of the process a more ambitious version of the NDC was developed, where the Project gave technical assistance to integrate gender measures (at the level of contributions in some

components and in general chapters of this first version), conducted a forestry GHG prospective study, and gave technical support to contribution of adaptation and capacity building.

NDC SP Project supported the public consultation process of NDC update. Preliminary results of these process were:

- 255 observations (some with technical supports) were received for all components. Those should be analyzed and answered. It was requested to increase and improve clarifications on gender and climate change measures in the NDC, that would force the text to be strengthened in that sense.
- The social context in Chile has given the opportunity to analyze and incorporate a new component (It is still under construction and will reflect on the place it will take inside of the structure of the NDC).
- The process of citizen consultation will force the improvement of transparency of the data of the NDC proposal and especially to solve those aspects that could still be deficient or not very ambitious of this version, it is expected that by March 2020 it will be possible to have an improved version of the document.
- The implementation of the webinar for the NDC consultation process, allowed to open an unusual alternative in the interior of the Ministry, which allowed to complement the traditional mechanisms for disseminating information, allowing online queries and interactions to be carried out online, doubts that arise in all matters and related to the process.

Partner engagement

How did the project leverage partnerships, attract other donors/resources, and scale up pilot initiatives, etc. to support the government to advance NDC implementation?

Results of "Diagnostic to incorporate gender approach into climate change policies and governance" (June, 2019) allowed identifying short term activities to advance in gender and climate change agenda: a) interdisciplinary working group to integrate gender approach into climate change policies b) generate information about gender and climate change (sex-disaggregated data, new indicators) c) capacity building. This allowed during the last trimester of 2019:

- To identify dimensions for climate change and gender, with its related instruments and variables to recognize the relationship between gender and climate change in Chile.
- To implement a first version of the climate change and gender working group (September, 2019);
- To formulate a project, to generate information about gender and climate change (sex-disaggregated data, new indicators, etc.), with the support of Luxembourg government.
- To formulate a Cooperation Project between Chile and Uruguay to strengthen knowledge and experiences, to building a regional work agenda of gender and climate change.

Challenges encountered, solutions implemented and lessons learned

What were the challenges encountered, and how were they resolved? How did the project deal with the risks identified at the onset of the project? What were the lessons learned?

A challenge was to begin NDC public participation process, at the same time that begin social crisis in Chile. This issue forced to look alternatives to presence workshops, webinars were a good solution. Also, Ministry of Environment extended the period of the process. A lesson learned was that it is necessary to integrate new information mechanisms to communicate climate change initiatives or policies, into different stakeholders.

A lesson learned of HuellaChile Program was to ensure and integrate HuellaChile Program and its work lines, with other similar initiatives developed nationally and internationally. A challenge was the increase of organizations interest in the Program, so it was necessary to have technical support to conduct all activities.

Other lesson learned, was that for new topics (where there are not enough international experience) it is better to conduct studies with national teams with culture sensitives.

Gender-responsiveness

	On 21 st October 2019, the first dissemination meeting was held within the framework of the citizen participation process for the NDC Update, this activity was carried out in the Tarapacá region and was attended by 49 people. On 14 th November 2019, the first activity was carried out via webinar, in the context of the NDC citizen consultation process. The objective of the exhibitions was to present the contributions of the mitigation components through the transversal economy and forestry goals. On 15th November 2019, the third face-to-face activity was carried out in the context of the NDC citizen consultation. This was carried out in the city of Santiago and the objective was to convene the key agents of the metropolitan region. Approximately 50 people attended.

On 19th November 2019, the fourth face-to-face activity was carried out in the context of the NDC citizen consultation. This activity was carried out in the city of Valdivia in the Los Ríos region and approximately 50 people attended.

On 22nd November 2019, the fifth face-to-face activity was carried out in the city of Santiago. The objective was to replicate the version of the previous meeting to allow more actors to have access to the presentations. This activity had originally been considered as an activity destined to women decision-makers but it was determined to open it to all types of public. On the day, 45 people attended.

On 25th November 2019, the second version of the webinar program for the dissemination of the NDC was carried out. This time the objective was the presentation of the components of adaptation, integration and means of implementation. On 26th November 2019, the sixth face-to-face activity was carried out in the context of the NDC citizen consultation. This time it was carried out in the city of Punta Arenas in the Magallanes region. Approximately 55 people attended.

On 27th November 2019, the last session of the webinars for the dissemination of NDC contributions was held. On this occasion, the objective was to present answers to a summary of questions asked by the citizens during the consultation process initiated in October. On the day, approximately 60 people interacted via the webinar.

	- The holding of COP25 event in Chile encouraged the participation of public and private organizations in the HuellaChile Program, with more than 390 new organizations joining the program. The accumulated value of participants in the Program, at the end of 2019, is 980 organizations (91% private and 9% public).
	- The activity "Participatory planting of native trees - HuellaChile" was carried out, in the Mahuida Park located in the Commune of La Reina,

which corresponded to the fulfillment of the commitment assumed by HuellaChile, to plant and care for two native mediterranean trees for each recognition stamp delivered during 2018 (100 stamps). The activity was led by the Minister of the Environment, Carolina Schmidt, and was attended by the mayor of La Reina, José Manuel Palacios, and the resident representative of UNDP in Chile, Claudia Mojica, in addition to various civil society organizations. The initiative coordinated by HuellaChile, was sponsored by COP25, La Reina Municipality, Cultiva Corporation and voluntary participation of more than 100 people from HuellaChile and students.

- Due to the social explosion events, 2019 HuellaChile recognition event, planned for October 2019, was postponed until April 2020.
- The collaborative work between the HuellaChile Program and the Environmental Certification of Municipalities (SCAM), during 2019, resulted in:
- o Conduct of 6 HuellaChile workshops on topics of climate change and carbon footprint to more than 35 Municipalities in the Los Ríos, BíoBío, O'Higgins, Metropolitana, Valparaíso, Coquimbo and Atacama regions. They were taught in the cities Rancagua, Santiago, Viña del Mar, Coquimbo, Concepción and Valdivia. More than 80 professionals were trained
- o HuellaChile facilitated the carbon footprint verification process to 20 municipalities, successfully completing 15 of them. "
- The collaborative work between the HuellaChile Program and the Agency for Sustainability and Climate Change (ASCC), during 2019, resulted in:
- o Active participation in topics related to carbon footprint in Clean Production Agreements (APL), in the following themes: Dairy Industry, Sustainable Campus, Processed Foods (Chilealimentos AG), Transportation, Eggs, Olive Trees, Graphic Industry and Printers, Port Logistics Iquique, Pica Tourism, Pinto Commune Tourism, among others. Involving the permanent participation in technical tables implemented by the ASCC, definition of methodological guidelines for the quantification of carbon footprint and GHG reduction, permanent technical support to APL signatory organizations and participation in the field in training activities.
- o Field training was carried out in carbon management topics for more than 200 people, belonging to organizations of various economic sectors that are subscribed to APL, such as: Sustainable Campus, Logistic Consortium of Iquique, Tourism of Oasis de Pica, Printers 2, among others."
- The collaborative work between the HuellaChile Program and the LEDS LAC Regional Platform, during 2019, resulted in:
- o Participation in the second workshop of the Community of Practice on Private Sector and Climate Policies held in the city of Lima between 21-23.may. Its objective was to be a space to consolidate the lessons of the first year of the community and explore opportunities for the future.
- o Support to private initiatives for the carbon management of organizations and their value chains, such as: Zero Carbon 2019 Hotels and Aguas Andinas suppliers.
