

## **ADDENDUM NO 1 TO EUROPEAN UNION DELEGATION AGREEMENT NO. ENI/2016/374-421**

The European Union, represented by the European Commission, (the 'Contracting Authority'), of the one part, and

United Nations Development Programme (UNDP) with its Head Office at One United Nations Plaza, New York, NY 10017, which is represented for the purposes of signing this amendment by UNDP Programme of Assistance to the Palestinian People (UNDP/PAPP) hereinafter the '**Organisation**', of the other part,

(individually a "Party" and collectively the 'Parties') have agreed as follows:

The following provisions of the Delegation Agreement "*Rehabilitation and Consolidation of the Gaza Industrial Estate*" N° ENI/2016/374-421, concluded between the Contracting Authority and the Organization on 17/01/2016 (the "Agreement") are hereby amended as follows:

### **Special Conditions**

#### **Article 1 – Purpose**

The following article:

“Article 1.3 b) apply its own procurement procedures, as assessed in the ex-ante pillars assessment”

Is replaced as follows:

“Article 1.3 b) apply its own procurement procedures, as assessed in the ex-ante pillars assessment and its own rules for the award of Grants, as assessed in the ex-ante pillars assessment.”

The following article:

“Article 1.5 The Organisation shall send annually a management declaration to the European Commission Headquarters”

Is replaced as follows:

“Article 1.5 The Organisation does not have an arrangement with the European Commission to provide annually the management declaration nor to provide annually the management declaration together with the audit or control opinion.”

### **Annex I: Description of the Action**

#### **Section 2.2. Methodology, page 10**

The following sentence:

“To undertake the intervention in accordance with UNDP policies and procedures as set out in the UNDP Programming Manual and in the 2004 EU Project Cycle Management Guidelines;”

Is replaced as follows:

“To undertake the intervention in accordance with UNDP policies and procedures as set out in the UNDP Programming Manual;”

#### **Section 2.2 Methodology, page 12**

The following sentence:

“The implementation of the project Communication and visibility plan will be aligned to the Communication and Visibility Manual for EU External Actions ([http://ec.europa.eu/europeaid/sites/devco/files/communication\\_and\\_visibility\\_manual\\_en.pdf](http://ec.europa.eu/europeaid/sites/devco/files/communication_and_visibility_manual_en.pdf)) and the Joint Visibility Guidelines for EC-UN Actions in the Field”.

Is replaced as follows:

“The implementation of the project Communication and visibility plan will be aligned to the Joint Visibility Guidelines for EC-UN Actions in the Field”.

**Annex VI: Communication and Visibility Plan**

**Section A. 1. Overall communication objectives, page 1**

The following sentence:

“A detailed visibility action plan will be developed in line with the “Communication and Visibility Manual for EU External Actions” and the “Joint Visibility Guidelines for EC-UN Actions in the Filed””.

Is replaced as follows:

“A detailed visibility action plan will be developed in line with the “Joint Visibility Guidelines for EC-UN Actions in the Filed””.

All other terms and conditions of the Agreement remain unchanged. This Addendum shall enter into force on the later date of signature by the Parties.
