

**AMENDMENT N° 1
TO THIRD PARTY COST-SHARING AGREEMENT SIGNED ON 12/08/2017
BETWEEN THE GOVERNMENT OF SWITZERLAND, REPRESENTED BY
THE FEDERAL DEPARTMENT OF FOREIGN AFFAIRS (FDFA), ACTING
THROUGH THE SWISS AGENCY FOR DEVELOPMENT AND
COOPERATION (SDC) (DONOR) AND THE UNITED NATIONS
DEVELOPMENT PROGRAMME (UNDP)**

(A) Regarding the Donor's contribution to the implementation of the project "Prévenir l'extrémisme violent en Tunisie à travers des approches de développement basées sur les droits de l'homme -Tarabot", as described in the Project document no. 00099940;

(B) The parties agree to amend the following provision of the agreement:

Article I. The contribution


