3. New MLF Gender Mainstreaming Requirements

ExCom Decision 84/92 approved a new Operational Policy on Gender Mainstreaming for Multilateral Fund-supported projects, thereby affirming the importance of gender mainstreaming in MLF-supported projects. The new policy on gender mainstreaming will be applied throughout the MLF project cycle, beginning with projects that will be considered at the 85th ExCom Meeting in May 2020. UNDP MLF tools and reporting formats will be revised accordingly in order to ensure a gender-responsive approach to UNDP MLF projects. In the meanwhile, it is important to collect more and better sex-disaggregated data, especially on participation in meetings and trainings as information on the number of male and female participants in project meetings will be requested by the MLF going forward. Please also ensure that your gender focal points and/or other gender experts are consulted during the project design and implementation phases and that gender-responsive human resource management processes are undertaken.

4. Entering the Budget in ATLAS: Your office is requested to enter the budget in ATLAS, using the Annual Work Plan table, attached. Please note the Multilateral Fund guidelines do not give us flexibility to shift funds between specific budget categories. In line with the UNDP requirement for multi-year project budgeting, please ensure the total approved budget per the work plan table is entered in ATLAS for the current and future years as indicated.

Dear Mr. Tajrishi,

In light of the critical situation of the COVID-19 pandemic globally, the Executive Committee of the Multilateral Fund decided to postpone its 86^{th} meeting, which was originally scheduled from 2 to 6 November 2020, to March 2021.

Cognizant of the facts that the postponement of the meeting would *inter alia* delay consideration of funding requests for projects supported by the Multilateral Fund; slow down project implementation, posing a potential threat to the sustainability of the phase-out already achieved; and affect the operation of national ozone units, the Executive Committee agreed to continue implementing, on an exceptional basis and without setting a precedent, an intersessional approval process for the 86th meeting. Through this process (which was held from 16 November to 3 December 2020), the Executive Committee was able to consider *inter alia* progress reports of bilateral and implementing agencies, reports on projects with specific reporting requirements, tranche submission delays and project proposals submitted by bilateral and implementing agencies on behalf of Article 5 countries.

In this regard, I am pleased to inform you that the Executive Committee approved funding for the thirteenth phase of the institutional strengthening (IS) project requested by your Government at a cost of US \$222,094, to be implemented by UNDP. In approving the funding, the Executive Committee expressed the following observations:

The Executive Committee reviewed the report presented with the request for the renewal of the IS project for the Islamic Republic of Iran (phase XIII) and noted with appreciation that the country has reported 2018 and 2019 CP data to the Fund Secretariat and data under Article 7 of the Montreal Protocol to the Ozone Secretariat, indicating its compliance with the Montreal Protocol. The Committee also noted that the Government continued to work with relevant stakeholders to manage and monitor the consumption of ODS, has taken actions to sustain the zero consumption of ODS already phased out, and has established an HCFC licensing and quota systems that allows compliance with the HCFC phase out schedule. The Committee acknowledged the efforts of the Government and is, therefore, confident that the Government of the Islamic Republic of Iran will continue implementing its HCFC phase-out management plan (HPMP) and IS project in a timely and effective manner to enable the country to meet the 75 per cent reduction by 1 January 2023, in accordance with its Agreement with the Committee for stage II of the HPMP.

Mr. Mohammad Masoud Agha Mohammad Hossein Tajrishi Deputy Head Department of Environment for Human Environmental Affairs Environmental Research Center Tehran, Islamic Republic of Iran I would also like to inform you that the Executive Committee approved the third tranche of stage II of the HPMP for the Islamic Republic of Iran, and the corresponding 2020-2022 tranche implementation plan, in the amount of US \$2,286,989, to be implemented by UNDP (US \$1,307,980), UNIDO (US \$524,000), UNEP (US \$170,000) and the Government of Germany (US \$285,009). In approving the funding, the Executive Committee:

- (a) Noted that US \$375,701 would be deducted from the approval for UNIDO, in line with decision 84/74(a)(iv); and
- (b) Requested UNIDO, UNDP and the Governments of Germany and Italy to continue submitting, with each funding tranche request, a detailed report on the status of the conversion of each of the foam projects covered under stage II including the financial viability, the current level of HCFC-141b consumption, the alternative technology selected, the total cost from the Multilateral Fund and the level of co-financing, as applicable, in line with decision 84/74(c).
