Brief Description:

The Project for Strengthening Transparency and Code of Ethics for Enhanced Public Confidence in Court of Cassation (CoC) targets developing and implementing strategies in the CoC for "disseminating code of ethics," "strengthening transparency" and "increasing trust in the judiciary" in line with universal values, good practices and lessons learned in other countries. The Project implementation started on 1 March 2016, and the planned end date was defined as 31 December 2020. The implementation has been carried out very effectively, and almost all activities foreseen in Annual Workplans (AWPs) for 2016, 2017, 2018, 2019, 2020 and 2021 were finalized. Due to the Covid-19 conditions and as a result of currency fluctuations and effective utilisation of costs in all activities throughout the Project.. In the light of the achievements and newly emerging activities, a further extension of the Project duration became necessary. Additional activities can be planned to extend the multiplier effects and disseminate the Project's outcomes widely in Turkey and abroad and among practitioners and justice actors. Potential additional activities can be listed as 1- Finalization of Resource Guide/Evaluation Framework for the Istanbul Declaration on Transparency in the Judicial Process and the Measures for the Effective Implementation of the Istanbul Declaration, 2- Printing and publishing of the books within the scope of the project, 3- Printing and publishing of 6 English Books on CoC Codes of Judicial Conduct in English (200 units), 4- Printing and publishing of Self-Directed Course training materials out of the modules developed by the the Judicial Integrity Group to be distributed among facilitators and then adoption of the materials for the use of Judges and Prosecutors, printing and publishing (1000 units) (Upon the approval of the Judicial Integrity Group) 5- Printing of the Summit Book (1000 units) 6- Printing of the Handbooks on Law Clinics (600 units) 6- Conducting information and knowledge sharing on judicial ethics with academicians who are specialized in ethics 7-Organization of an international hybrid conference and closure event on the Evaluation Framework for the Istanbul Declaration on Transparency in the Judicial Process and the Measures for the Effective Implementation of the Istanbul Declaration

In this scope, in line with the consultations held between project partners at the 11th Project Steering Committee Meeting held on 30 November 2022, the project implementation period was decided to be extended from 31 December 2022 to 30 April 2023 with no additional budget.


