Brief Description:

The Project for Strengthening Transparency and Code of Ethics for Enhanced Public Confidence in Court of Cassation (CoC) targets developing and implementing strategies in the CoC for "disseminating code of ethics", "strengthening transparency" and "increasing trust in the judiciary" in line with universal values, good practices and lessons learned in other countries. The Project implementation is being carried out very effectively, even with additional activities which have not been foreseen in the Project Document, such as i) adopting comprehensive consultation processes to ensure participation and inclusiveness throughout the development of codes of conduct, ii) carrying out meetings for wide-dissemination and further elaboration of the Istanbul Declaration on Transparency in Judicial Process and iii) producing soft and hard copy publications for promoting transparency, raising awareness and strengthening ownership on the conducted studies. This fact resulted with the necessity to postpone some of the foreseen activities under the components on transparency and trust. Moreover, the results of the activities under the components on ethics and transparency are expected to provide inputs for the activities under the component on trust, therefore the initiation of the activities under the component on trust had also been subject to postponement. Furthermore, in order to adopt above referred comprehensive approach throughout all project activities and allocate a dedicated time for the technical and logistical preparation of the 4th International Summit of High Courts, the project implementation period is required to be extended. In this scope, in line with the agreement reached during the Third Project Steering Committee Meeting held on 25 October 2017, the Project implementation period has been decided to be extended from 31 December 2017 to 30 November 2018 with no additional cost.

I. OPENING REMARKS

- The Deputy Secretary-General of the Court of Cassation, Dr. Mustafa SALDIRIM, opened the meeting and provided information on activities realised in the scope of the project. He emphasized that the website of the Court of Cassation featured an "Ethics and Transparency" section, and the developments about the project are shared in this section. He further noted that the Ethics component of the project has nearly come to completion, and the Guidelines on Ethics has started to be prepared.
- He stated that Evaluative framework: Codes of Conduct questionnaire from the Implementation Guide and Evaluative Framework for Article 11 of UNODC has been included in "Assessment of Views on the Court of Cassation Draft Code of Judicial Conduct" booklet where institutional and non-institutional opinions on the code of conduct of Court of Cassation have been compiled.
- The Ministry of Development Planning Expert Hasan DURSUN made a brief opening speech noting that it was necessary to develop a code of conduct specific to judges, therefore the project is very important. He added that while constituting the code of conduct, the difference between judges and prosecutors, which are two different professional groups, has been sometimes overlooked; but he was happy that the two sets of ethics codes for the two groups were prepared in the context of the project.
- UNDP Turkey Assistant Resident Representative Seher ALACACI stated that while
 the project could be a good example to the other countries, Turkey could also be a
 promoter for them for its efforts on ethics. Ms. ALACACI added that they are keen on
 the inclusion of works of UNDP and the Court of Cassation in the Eleventh
 Development Plan of the Ministry of Development, and that they are awaiting an
 invitation on the issue. Further, the publications prepared under the project would
 continue to be very important after the project would come to an end, and will be an
 asset to the fund of knowledge.
- UNDP Rule of Law and Human Rights Cluster Lead Gözde ATA briefed on the project activities realised in the reporting period. Please refer to the presentation in the annex for further information.

II. PROCESS

Project Expert Prof. Dr. Gülriz UYGUR was absent for an excuse.

- The project activities, particularly in the context of the Transparency component in the upcoming period were mentioned.
- At the Experts Group Meeting, held with the participation of the foreign experts on 20 October 2017, elaboration of the Istanbul Declaration Action Plan has been completed. Experts from five different continents contributed to the meeting. Hon.Justice John DOWD of the Australian High Court; Prof. Dr. Nihal JAYAWICKRAMA, General Coordinator of UNODC Judiciary Integrity Group; Hon.Justice Shiranee TILAKAWARDANE of Sri Lanka High Court; Hon.Justice Kashim ZANNAH, President of Nigerian High Court, participated in the meeting from Ankara whereas Mr. Jeffrey APPERSON, Vice-President of the National Centre for State Courts of the United States of America and Mr. Michael BUENGER, the Administrative Director of Ohio High Court participated the meeting through video-conferencing. Judge Wojciech POSTULSKI, Secretary-General of European Judicial Training Network (EJTN) supported the work on detailing the Istanbul Declaration by providing views in written form. The Deputy Secretary-General of the Court of Cassation, Dr. Mustafa SALDIRIM emphasized that the meeting was very productive.
- It was decided that the finalised version of the Istanbul Declaration would be presented to the endorsement of the high court justices in the 4th International Summit of High Courts planned to be held in 2018.
- Preparations will be commenced for the 4th International Summit of High Courts.
- A satisfaction questionnaire will be prepared under the Transparency component.
- The contracts of project experts Barış SÜRÜCÜ and İnayet AYDIN will be commenced as of 17 December.
- The Deputy Secretary-General of the Court of Cassation Dr. Mustafa SALDIRIM stated that the project expert Barış SÜRÜCÜ would develop the satisfaction questionnaire to be administered at the front office of the Court of Cassation and to lawyers with the support of the Union of Bar Associations of Turkey and bar associations.
- A video was prepared under the Trust component of the project; more works will take place on this matter in the upcoming period.
- The Deputy Secretary-General of the Court of Cassation Dr. Mustafa SALDIRIM stated that they would like to introduce such reforms as multi-door court, mediation as realised by the Court of Cassation and note good practices from Turkey in the 4th International Summit of High Courts. In this context, it would have high significance that the 4th International Summit of High Courts be held in 2018 which would mark the 150th anniversary of the Court of Cassation. In addition, the project activities progressed efficiently, including the additional activities not foreseen in the project document. In this context, he stated that it would be appropriate to extend the project until the November 2018 in order to effectively realise the activities under Transparency and Trust components, and complete the preparations for the 4th International Summit of High Courts in a comprehensive manner.
- It was decided, by the joint decision of the Court of Cassation, Ministry of Development and UNDP to extend the project to 30 November 2018.
- UNDP Turkey Assistant Resident Representative Seher ALACACI noted that two months would be needed for the official finalisation of the project; therefore, it would be appropriate to hold the 4th International Summit of High Courts in October 2018.

- UNDP Rule of Law and Human Rights Cluster Lead Gözde ATA will communicate
 the formal correspondence on extension to the Planning Expert from the Ministry of
 Development Hasan DURSUN, following the signing of the document by the officials
 of the Court of Cassation and UNDP.
- In the scope of the project, one technical study visit will be held; thereby, a reduction will be made in the budget item.
- It was decided that the project expert Justice Shiranee TILAKAWARDANE of Sri Lanka High Court examine the French High Court and include it in her report.
- The project expert Prof.Dr.Rifat MİSER noted that ethics training was effectively
 delivered and the participation was high, noting that the works were productive. He
 added that it was very important that the initial sessions of the training to be taken into
 account.
- The Deputy Secretary-General of the Court of Cassation Dr. Mustafa SALDIRIM underlined that the Adult Education Guide prepared by the project expert Prof.Dr.Rifat MISER was effective. He noted that the fact that the code of conduct was adopted in the Board of Head of Chambers Meeting at the Overall Evaluation of the Draft Code of Conduct held on 22-23 September 2017 at Abant, Bolu was the biggest indicator of that.
- The National Conference on Introduction of the Code of Conduct will be realised in the format of an ethics panel with participation from the Court of Cassation, Ministry of Development and UNDP.

III. DECISIONS TAKEN AT THE MEETING

In the light of the items in the agenda, the following decisions were made at the Executive Board.

- 1) It was decided that the finalised version of the Istanbul Declaration would be presented to the endorsement of the high court justices in the 4th International Summit of High Courts planned to be held in 2018.
- 2) Preparations will be commenced for the 4th International Summit of High Courts.
- 3) A satisfaction questionnaire will be prepared under the Transparency component.
- 4) The contracts of project experts Barış SÜRÜCÜ and İnayet AYDIN will be commenced as of 17 December.
- 5) It was decided, by the joint decision of the Court of Cassation, Ministry of Development and UNDP to extend the project to 30 November 2018.
- 6) UNDP Rule of Law and Human Rights Cluster Lead Gözde ATA will communicate the formal correspondence on extension to the Ministry of Development Planning Expert Hasan DURSUN, following the document is signed by the officials of the Court of Cassation and UNDP.
- 7) In the scope of the project, one technical study visit will be held; thereby, a reduction will be made in the budget item.
