**AMENDMENT # 03 TO THE SPECIFIC AGREEMENT BETWEEN THE NORWEGIAN MINISTRY  
OF FOREIGN AFFAIRS, REPRESENTED BY THE REPRESENTATIVE OFFICE OF NORWAY TO THE  
PALESTINIAN AUTHORITY AND THE UNITED NATIONS DEVELOPMENT  
PROGRAMME/PROGRAMME OF ASSISTANCE TO PALESTINIAN PEOPLE,  
AGREEMENT PAL-17-0004**

With reference to the Specific Agreement between the Norwegian Ministry of Foreign Affairs (the Donor) and the United Nations Development Programme/Programme of Assistance to Palestinian People (UNDP/PAPP), signed on 15 August 2017 with agreement No PAL-17/0004, (UNDP Ref. 00106652), amendment number 01 dated 19 August 2019, and amendment number 02 dated 16 February 2020, under which the Parties agreed to cooperate in the implementation of the "Access Coordination and Monitoring Support, Project, Gaza" (the Project) in the Occupied Palestinian Territory (oPt)

WHEREAS the Parties agree to amend certain provisions to the Agreement;

NOW THEREFORE, the relevant provisions of the Agreement indicated below are hereby amended to read as follows ("Amendment 2"):

9.a. Coordination Levy	--	<p>Pursuant to paragraph 10(a) of United Nations General Assembly Resolution 72/279 of 31 May 2018, shall be paid to fund the United Nations Resident Coordinator System. This amount, hereinafter referred to as the "coordination levy" will be held in trust by the UNDP/PAPP until transfer to the United Nations Secretariat for deposit into the United Nations Special Purpose Trust Fund for the reinvigorated Resident Coordinator system, which has been established to fund the UN Resident Coordinator System and is managed by the United Nations Secretariat.</p> <p>The Donor acknowledges that once the coordination levy has been transferred by the UNDP/PAPP to the United Nations Secretariat, the UNDP/PAPP is not responsible for the use of the coordination levy and does not assume any liability. The fiduciary responsibility lies with the United Nations Secretariat as the manager of the Resident Coordinator system.</p> <p>The coordination levy does not form part of the UNDP/PAPPs cost recovery and is additional to the costs of the UNDP/PAPP to implement the activity or activities covered by the contribution. Accordingly, there is no normal obligation for the UNDP/PAPP to refund the levy, in part or in full, even where the activities covered by the contribution are not carried out in full by the UNDP/PAPP.
