1.1 Overall project progress to date

Briefly explain the **status of the project** in terms of its implementation cycle, including whether all preliminary/preparatory activities have been completed (1500 character limit): Up to now, the project has recruited a UNV Project Officer to join the implementation team; and most preliminary/ preparatory meetings have been conducted and the main project tools (AWP, Budget, etc.) have been drafted. With regards to the implementation of activities, at the end of May, a 2-day workshop/conference on JR and ADR took place, with important effects and results that will substantiate future activities within the project. Meetings with Voz di Paz/Interpeace have been held and an Agreement is about to be signed for them to cooperate with UNDP and UNICEF in the implementation of Activities 1.5; 2.1; 2.2; 2.3; 2.4

(1500 character limit) IIn Guinea-Bissau, due to the state's lack of capacity to provide adequate access to justice services to the population, there is a general decline in confidence in the modern state system of justice. Therefore, and since the project will support the national authorities in adopting innovative solutions for dispute resolution, namely for the more vulnerable populations in rural areas, it is still highly relevant and well placed to address potential conflict factors and tensions.

Although both formal and informal (traditional) justice systems co-exist and are used by the Bissau-Guinean population, there is neither a functional mechanism of cooperation between them nor a legal framework that sets the pace for it. Thus, through investing in the development of a legal framework and ultimately developing a mechanism for its implentation, while simultaneously capacitating individuals for its operationalization, this project proves very much unique and innovative. Furthermore, it is unprecedented in a sense that it aims to get all the justice sector actors to reflect and adopt a new model based on the local context for dispute resolution (particularly on cases involving women and children) in order to overcome the inefficiency of justice.

The workshop/conference of RJ and ADR had an significant peacebuilding effect, since it helped sensitize different national actors on ADR and RJ and strengthened their knowledge on alternative forms of conflict resolution already used in Guinea-Bissau. The workshop presented different approaches and experiences of ADR, nationally and internationally, compiled them, to help stakeholders understand the need to legalize ADR, and demonstrated how to elaborate an accurate draft law legalizing ADR within the formal justice system

Through the workshop/conference, around 200 people, over 2 days, were made aware of the importance of introducing the concept of RJ to people who had never heard the term and helped them understandthat there are different conceptualizations of justice. It helped sensitize top magistrates on RJ, opening up the possibility for justice reforms that are more humane and appropriate to specific cases. Moreover, it made the public aware of the importance of engaging women in justice processes, namely in RJ and ADR mechanisms, for the country's progress; and of the impact of nefarious practices affecting women and girls and how it violates international human rights conventions. Additionally, the Regulos (tribal chiefs/traditional authorities), were clearly pleased by the issues discussed, and shared specific cases that happened in their tabankas (villages), and were able to receive inputs from the invited experts.

One of the main challenges the project has encountered so far relates to the fact that it contributes to the introduction of a new concept of justice in a traditionally conservative environment. This can lead to some resistance among key actors – both in the traditional and formal systems. In order to overcome these challenges and bottlenecks the project will focus on; promoting activities and dialogue between all relevant parties in order to overcome their distrust and difficult cooperation, and adequately and inclusively defining a comprehensive alternative mechanism for dispute resolution for the country.

Another main challenge is the continued political instability and lack of a legitimate government until very recently. As a result, there were delays in determining integrated strategies and approaches to implement activities.

<u>Outcome 1:</u> The population benefits from enhanced access to justice through strengthened Alternative Dispute Resolution (ADR) systems within informal and formal justice systems, and a strengthened interface between both systems, in line with international standards of administration of justice and human rights

Under this outcome, the project has already held an awareness forum (output indicator 1.1.1), on ADR and RJ practices in the formal justice system, with particular attention to women and child rights (output 1), engaging more than 8 types of stakeholders — tribal chiefs, community leaders, judges, prosecutors, lawyers, law students, etc. Through this initiative, the knowledge of key stakeholders, both in the informal and formal justice sector, has been strengthened to enable them to work together in the near future. Apart from this planned activity, as a side effect, the visiting speakers to the RJ conference spoke about RJ and ADR at the Law School of Bissau, where there is a strong interest to set up a RJ centre. Meetings with Voz di Paz/Interpeace have been held and an Agreement is about to be signed for them to cooperate with UNDP and UNICEF in the implementation of Activities 1.5; 2.1; 2.2; 2.3; 2.4.

Important steps were made in order to push forward the elaboration of the Child Protection (CP) Code. Results from strong advocacy conducted with Government authorities led to the identification of the technical support needed to review civil and penal legislation, in line with the CRC and other child rights instruments. UNICEF assisted the MoJ in the recruitment of a national team of experts, which has conducted a desk review and is currently revising and developing legislation that includes restorative justice principles and practices. The Ministry of Justice (MoJ), together with the Parliament, developed key documents such as the road map and terms of reference for that process

The project is supporting community dialogue to promote human rights of children and women, both in rural and urban settings. More than 15,000 people from 85 communities, in 6 regions (Oio, Cacheu, Quinara, Tombali, Gabuand, SAB) are actively involved in community dialogue initiatives addressing prevention of violence and abuse against women and children. Within these communities, influent religious and community leaders, as well as important opinion leaders are engaged in educational and awareness sessions, where local mechanisms to address violence against children and women are being deeply discussed. These influent people are leading, in many cases, the community management committees. Around 150 local "promoters" (identified by the community) increased knowledge and skills to ensure quality of community dialogue interventions and improved reporting process. Local "promoters" have facilitated important inter-community exchanges to increase the wider promotion of social norms change on child and women's rights.
