5. CHALLENGES / LESSONS LEARNT

Key challenges and remedial measures taken:

- 1. Despite numerous reminders to national R2R teams, achieving timely delivery of good quality submission of national project workplans and progress and financial reports remains a challenge. The often poor quality of reports and, most importantly incomplete submissions of financial reports and supporting documents that serve as basis for cash advance acquittals, are causing delays in the processing of requested fund transfers. In attempting to remedy this, on top of the efforts of the Country Focal Points, all RPCU staff were involved in continuously providing mentoring session through face-to-face meetings and teleconferencing (Skype or FB messenger) in order to iron out planning and reporting gaps.
- 2. Some project managers and country host agencies remain confused in respect of the opportunity to seek no-cost extensions to national projects. The RPCU prepared simple guidance notes in this regard explaining the process and steps related to the request for a no-cost extension. The circular emphasised that justification for no-cost extensions rests on submission and approval of detailed work plans aimed at achieving national end of the project targets. Towards the end of the reporting period, there were indications that national project managers are beginning to grasp this concept and some have begun submitting revised logframes and related multi-year costed work plans. As of end December 2019, all participating countries requested no-cost extension to ensure delivery of the end of the project targets as indicated in the updated logframes. Letters of Variation were sent to the countries for counter-signing by the authorized representative of the implementing agency, with a deadline of 31 January 2020.
- 3. As previously reported, achieving an overall programmatic approach to implementation of R2R continues to challenge SPC, and remains a significant constraint to successfully achieving overall program outcomes. Although RPCU has provided the Harmonized Results Reporting tool for reporting results of the GEF Pacific R2R outcomes, GEF R2R child projects are yet to submit the data required for SPC to report on the results of GEF investments towards achievement of GEF-5 indicators. Considerable attention was given to this issue at RSC 4 and, while there was general agreement that such reporting should and will be actioned, compliance still requires direction and encouragement by all the GEF Pacific Regional R2R implementing agencies to their respective R2R STAR projects.
- 4. The loss of the IW R2R Project Accountant has provided a further challenge to project implementation, though at the end of the reporting period arrangements were made for temporary project accounting support and for recruitment of a permanent replacement. SPC recruitment process is underway.
- 5. SPC does not have a clear understanding of UNDP's intention, or otherwise, to work with the R2R project to develop a future Strategic Action Plan for the Pacific islands under GEF's International Waters portfolio.
