Brief Description

The overall goal of the project is to strengthen the capacities of national institutions on human rights and the rule of law to implement effectively and transparently the recommendations of UN Charter-based and Treaty Bodies in accordance with Uzbekistan's international legal obligations in the field of human rights.

The Project will also contribute to the implementation of the Action Strategy 2017-2021 of the Republic of Uzbekistan related to the drafting of new laws in compliance with the international human rights law, localisation of SDG No.16 on peace, justice and strong institutions, as well as Outcome 8 of UNDAF 2016-2020 on better protection of rights and freedoms of citizens.

The national implementing partner of the project is the National Human Rights Centre of the Republic of Uzbekistan.

The project will also partner with the Legislative Chamber and Senate of Oliy Majlis of Uzbekistan, General Prosecutor's Office, Constitutional Court, Supreme Court, MFA, Ministry of Interior, Ministry of Justice, other line ministries and agencies, universities as well as civil society institutions and the media.

UNDAF Outcome 8: Legal and judicial reforms further ensure strong protection of rights, freedoms and legitimate interests of citizens.

I. DEVELOPMENT CHALLENGE

Uzbekistan with a population of over 32 million people (two-thirds of the population is under 30 years old) is the most populous country in Central Asia with an almost equal share of people living in rural and urban areas. The Constitution of Uzbekistan covers all fundamental human rights and freedoms in accordance with the Universal Declaration of Human Rights. Legislation of Uzbekistan recognizes the priority of international law over national legislation.

Uzbekistan is a State party to more than 70 international human rights instruments, including 6 (ICERD, ICCPR, ICESCR, CEDAW, CAT, CRC) out of the nine core UN human rights conventions, as well as four optional protocols. After the ratification of these conventions, a number of legislative acts and organizational measures were adopted in Uzbekistan, taking into account the recommendations of the UN treaty bodies on human rights and the Universal Periodic Review (UPR). In particular, the Parliament of Uzbekistan has adopted more than 400 legislative acts regulating fundamental human rights and freedoms. Nevertheless, the issue of law enforcement is important for ensuring the protection of human rights in practice.

According to the final report of the 24th session of the UN Human Rights Council, Uzbekistan received 203 recommendations, 115 of which were adopted by the country during the Plenary session, 30 were identified as already implemented, and 58 were not adopted on the basis that these recommendations either did not meet international commitments taken by Uzbekistan, or did not correspond to reality.

Nowadays Uzbekistan is making reforms in public administration system, rule of law, enhancement of legal and judicial system, social economic development of society, high level of security, inter-ethnic harmony and religious tolerance, and constructive foreign policy.

These reforms are based on new relationships of government agencies and citizens, depending on the needs and complaints of population and aimed at the raising the accountability of government bodies to the civil society.

In line with Action Strategy on five priority areas of development of Uzbekistan for 2017-2021, the second priority area is to ensure rule of law and further reform of legal and judicial system aimed at the genuine independence of judiciary and guarantees for better protection of rights and freedoms of citizens, enhancement of administrative, criminal, civil and economic legislation, enhancing the efficiency of the system for countering crime and prevention of wrongdoings, full implementation of due process in court trials, and improvement of system for legal aid and legal services.

In the context of the recommendations UN HRC and Treaty Bodies as well as State Programme "Year of Dialogue with People and Citizen's Interest" aimed on implementation of Action Strategy on five priority areas of development of Uzbekistan for 2017-2021, it is essential to further strengthen the independence and capacity of the judiciary, enhancement of activities of national human rights institutions, as well as ensuring access of citizens to effective legal remedies and practical and progressive implementation of the norms and provisions of ratified treaties on human rights.

As a follow-up to the visit of High Commissioner for Human Rights to Uzbekistan in May 2017, the both Chambers of Oliy Majlis have approved Action Plan on further development of cooperation with OHCHR on human rights on 16 June 2017. Parliament has adopted a Roadmap on follow-up to the recommendations of Special Rapporteur on Freedom of Religion or Belief on 4 May 2018. President of Uzbekistan has adopted a Decree on 70th Anniversary of Universal Declaration on Human Rights on 5 May 2018.

This project will contribute to the implementation of these strategic documents of the Government of Uzbekistan upon coordination with national partners.

Key Challenges:

1) Strengthening the harmonization of national legislation and law enforcement practices in line with international human rights treaties.

In this regard, there is need for an integrated approach to the implementation of international agreements with the concluding recommendations of treaty bodies and their general comments, as well as international best practices and international standards.

Since ratification of core human rights conventions, such as ICERD, ICCPR, ICESCR, CEDAW, CAT, CRC, Uzbekistan has been gradually complying with normative framework of the international human rights law as observed by concluding observations of UN Treaty Bodies as well as Charter-Based bodies recommendations.

Shortcomings cover the "rule of law cycle" from legislative drafting process to implementation, enforcement and monitoring of legislation in practice. It includes the issues on improving the quality of legislation, adopting laws of direct action, limiting the discretionary space for by-laws and enabling environment for public control.

In addition to Executive, the Parliament and Judiciary play important role in harmonization of national legislation and domestic jurisdiction in line with international human rights standards. The preparation of country before and after the treaty accession, as well as systematic monitoring over the implementation of international treaties are key issues raised by the Senate Committee on International Affairs. In 2015, UNDP has supported the systemic inventory of international treaties and piloting of classification and compliance review of environmental conventions as well as creation of a depository room for the international treaties in MFA.

Besides, as a specific issue, the ratification and implementation of the UN Convention on the Rights of Persons with Disabilities (UN CRPD) signed in 2009 was highlighted as essential for bringing the national legislation and institutional arrangements in compliance with CRPD requirements.

2) Improving the monitoring mechanism for human rights.

The National Monitoring Mechanism for Human Rights is coordinated by the Interdepartmental Working Group, chaired by the Minister of Justice. In addition, the NHRC coordinates the compilation of Uzbekistan's periodic national reports to the human rights treaty and Charter bodies of the United Nations. In this regard, the issue of using disaggregated data, both quantitative and qualitative, is relevant to improve the quality and transparency of national reports. Publication of national country reports and concluding recommendations of treaty bodies in the portal www.lex.uz and the use of open public data from the portal www.data.gov.uz can enhance transparency of the monitoring process.

3) Increasing the institutional capacity of national human rights institutions in accordance with the international standards remains an urgent issue.

Bringing the powers, functions, organizational, technical, financial and human resources of national institutions for the protection of human rights in full accordance with the international standards will contribute to enhancing the role of the national institutions in the national mechanism for the protection of human rights. It is also necessary to update existing training courses and programs on human rights in higher education institutions, as well as in law enforcement training centers. Furthermore, it is necessary to significantly improve knowledge experts on the conventions on human rights and to strengthen the capacity to implement them. It is necessary to enhance the cooperation of national institutions for human rights with NGOs (e.g., Women's Committee of Uzbekistan, Trade Unions, NANNOUz etc) in the area of human rights protection.

Uzbekistan has taken a number of reforms to ensure the independence of the Judiciary and the Legislature. In particular, the Parliament has recently increased its mandate to scrutinize thoroughly bills and performance results of the Government in social and economic development issues, while the judicial system has been modernized with introduction of electronic justice tools to ensure transparency and efficiency in civil and economic trials as well as enforcement of court decisions. It is planned to introduce e-case management system in criminal courts.

To comply with international human rights law in the practice, it is important to strengthen the accountability, integrity, and transparency of duty-bearers responsible for human rights promotion and protection in the executive branch, including law enforcement agencies.

Procedures, system and existing curricula of law enforcement agencies (Police Academy, Lawyer Training Center, Academy of GPO, and Law University) and civil servants (Academy of Public Administration) need to be revised substantially from the point of international human rights law with focus on implementation practice, case studies, international best practices and action-oriented learning.

Uzbekistan's Constitution Preamble reflects the state's 'adherence to human rights', 'commitment to the ideals of democracy and social justice', and the 'priority of the generally accepted norms of the international law'. Ensuring rule of law and continuing the judicial reforms has become one of the five state current priorities of Uzbekistan – the basis for the *State Action Strategy of further development of Uzbekistan from 2017 to 2021*.

To enhance the state's international standing it is paramount for the country to translate its commitment for the progressive realization of human rights into practice. Thus, it is crucial for the state to put more effort into developing national mechanisms of protection of human rights through an improved justice system and involvement of national human rights institutions. Judicial independence, legal enforcement and legal aid mechanisms need enhancement to provide citizens with effective access to legal remedies. Knowledge of and capacity to use the UN human rights mechanisms by national human rights institutions, such as the National Human Rights Centre (NHRC), the Parliamentary Ombudsman and Business Ombudsman and others, require strengthening.

4) In order to form the modern and effective public administration system, Government is taking consistent measures on strengthening the public control over the performance of state authorities and to increase the public participation. These reforms will contribute to the effective model of public control on law enforcement agencies to ensure the rights of detainees, prisoners and arrested people as well as people in conflict with law.

To further promote the idea of protecting human rights, UNDP will provide consultative and technical support to national partners in developing appropriate policies and fulfilling their obligations under international conventions and treaty bodies of the United Nations. The Project in cooperation with the UNCT, OHCHR, UNDP IRH, and other UN agencies, bilateral international partners will provide its assistance to the country in measures to implement the recommendations of Charter-based and Treaty-based organizations and the National Action Plan for the implementation of the Charter-based and UN Treaty Bodies recommendations.

II. STRATEGY

The project aims to support the implementation of the National Action Plan for the Implementation of the Charter-based bodies Recommendations and the Treaty Bodies (hereinafter referred to as the "National Action Plan"), focused on concrete results in the implementation of the recommendations, in particular in such areas as rule of law and development of civil society, the rule of law, the reform of the judicial system, and the economic and social rights, with emphasis on vulnerable groups.

The activities mentioned in the Annex 1 to this project document will also correspond to the Outcome 8 ("By 2020, legal and judicial reforms provide more reliable protection of the rights, freedoms and legitimate interests of citizens") of the United Nations Development Assistance Framework for Uzbekistan for 2016-2020. (UNDAF).

The project will facilitate the implementation of the activities specified in the Memorandum of Understanding between UNDP and the National Center for Human Rights of the Republic of Uzbekistan on October 20, 2016. In accordance with this Memorandum, the project will organize activities to assist the monitoring mechanism to ensure periodic review of progress in the implementation of the National Action Plan.

In addition, the project will provide technical assistance to key national institutions responsible for implementing the recommendations of the Charter-based and the UN treaty bodies. To provide analytical assistance to the Government and national institutions for the protection of human rights, the Project will carry out thematic studies to identify possible solutions for the implementation of recommendations, including through learning from the experiences of other countries, and to help strengthen the capacity of key national institutions involved in implementing the recommendations.

The project will facilitate an open platform for cooperation between national institutions and international partners to support the implementation of the National Action Plan. To this end, based on the study of international experience, quantitative and qualitative indicators for assess progress and results of the implementation of the adopted recommendations. The project will organize a regular review of the implementation of the National Action Plans and extended format for the thematic discussion "Round table" of implementation and the need to make adjustments to the National Action Plan, with the participation of all interested state Institutions, representatives of civil society, the United Nations and other international organizations. Conclusions and recommendations of the round tables will be presented to NHRC and the Interdepartmental working group on monitoring of observance of rights and freedoms Human rights by law enforcement agencies and others under the Ministry of Justice of the Republic of Uzbekistan.

Through the study of international best practices, the project will provide legal, methodological and informational support of the Coordinating Committee of the National Center of the Republic of Uzbekistan on Human rights in research on selected issues of human rights mentioned in the recommendations of the UN Human Rights Council.

In particular, in the framework of socio-economic rights of vulnerable groups, the Project will learn the basic principles, forms, mechanisms of formation and functioning of the social protection system in Uzbekistan, as well as based on the study of international experience to develop proposals to improve the efficiency of social protection of the population in Uzbekistan. At the same time, the international best practices on ratification and implementation of the UN Convention on the Rights of Persons with Disabilities will be analyzed. In addition, Uzbekistan's experience in the development and implementation of organizational and legal measures aimed at ensuring the reliable protection of human rights and freedoms in accordance with generally recognized international norms in this area will be analyzed and generalized, as well as to develop proposals for increasing the effectiveness of work in this direction on the basis of national priorities and objectives of the Action Strategy of Uzbekistan for 2017-2021. In addition, it is planned to conduct a comparative legal analysis of the creation and functioning of mechanisms for the protection of human rights in democratic countries, using the example of the activities of national human rights institutions in accordance with the international standards. In this regard, attention will be paid to the mechanisms for the development of social partnership, public control and the public participation of citizens.

The Government of Uzbekistan has invited the international community, in coordination with the UN Office in Uzbekistan to join the platform to support and monitor the implementation of UPR recommendations. In response, UN Office jointly with international and national partners, organized in October and December 2013 and in January 2014 a series of national roundtables to discuss the NAP project, contributions and comments of the international community and human rights comparability of indicators developed by OHCHR. This led to the adoption of the NAP in November 2014 and the organization in November 2015 of the first roundtable for monitoring in conjunction with national partners. Since then, the round tables for monitoring the implementation of the National Action Plan have been held regularly.

Implementing the UPR recommendations is a complex agenda for any country. This is due to the fact that many of the recommendations relate to the normative legal reforms, the involvement of several agencies and the need for changes in enforcement practices. Therefore, for an effective response to the recommendations of the UPR, the human rights issues and development programs should be addressed in a comprehensive and coordinated manner.

One UN approach: The project offers a platform of international donor support to accelerate the implementation of the recommendations in the framework of the Universal Periodic Review in Uzbekistan. The project will be implemented by UNDP in Uzbekistan in close coordination and consultation with the UN Resident Coordinator with the advice of several UN agencies, including OHCHR, to ensure an integrated and holistic approach. Finally, the project will facilitate dialogue with national partners, UN agencies and other multilateral and bilateral donor community present in Uzbekistan.

The scope of the project: the main concept and scope of the project will be determined by the volume of the Charter-based Bodies recommendations, as well as the treaty bodies and the National Action Plans. The project will specifically support these recommendations, which include specific targets and milestones, and are result-oriented. This project will complement existing projects and programs that are already supported by various thematic areas related to human rights.

The project will work with national agencies and NGOs responsible for the implementation of Charter-based and Treaty Bodies recommendations on the basis of joint work plans. The project's role is to support national efforts, including those carried out by law enforcement agencies and NHRIs, by providing analytical and technical assistance to implement key recommendations of the NAP, which significantly and transparently contributes to the progressive implementation of human rights in Uzbekistan.

The project will also provide progress reports to the Interagency Working Group on Monitoring of Human Rights in the Ministry of Justice, which would make an evidence-based constructive dialogue on the progress made on the recommendations of the UPR more meaningful with the support of disaggregation's data.

To effectively promote the implementation of the recommendations in the Charter-based and treaty bodies, the principles of human rights and the development of technical assistance measures should be applied in an integrated manner to solve the problems mentioned above, namely the strengthening of institutional capacities for coordination, implementation and monitoring of human rights. To this end, the project will focus on structural and institutional reforms, the harmonization of legislation in accordance with international treaties on human rights, the development of new draft laws in as per legislative drafting plans of national partners, as well as joint research and monitoring activities aimed at and institutional changes.

In this context, a key aspect is the modernization of public administration and the rule of law. Since the creation of a system's framework and improving institutional capacity of national partners is an important objective of ensuring adequate promotion and protection of human rights and freedoms, rights holders, the project will also cooperate with law enforcement authorities with an agreed set of governance measures. It will involve a functional analysis of duty bearers, improving the regulatory framework and institutional mechanisms for the strengthening of bilateral ties between the police and citizens and the media, the development of open data as per OHCHR's methodology on human rights data indicators and SDGs. It will be connected to measures of adjacent areas affecting human rights protection system, such as an e- governance, an administrative review of complaints from citizens and the national system of prevention of corruption, which provide support for reforms in the sectors related to human rights.

The project will focus on constructive engagement, including through negotiation and coordination with national stakeholders on key events in the development of human rights, in order to align them with national priorities and systemic changes. In addition, a multilateral partnership with the relevant public authorities (law enforcement bodies, Parliament, the Cabinet of Ministers, the judiciary and national institutions on human rights) will achieve lasting results, and provide transparent monitoring of progress on the implementation of the recommendations of the Charter-based and Treaty Bodies.

In case of interest and approval from the Government of Uzbekistan, Project also will provide technical assistance to the visits of Special Procedures in Uzbekistan and support in the development of national and alternative reports to the fourth cycle of the UPR and the forthcoming sessions of the Treaty Bodies.

III. RESULTS AND PARTNERSHIPS

Expected Results

In line with MoU between UNDP and NHRC 2016, this Project will provide a coordinated technical support for key national institutions that are responsible to take recommendations forward.

The implementation of the project will enhance the role of NHRC in the enhancement of public policy on human rights, development of strategic documents on implementation of Constitution and law as well as further implementation of international human rights treaties, to which Uzbekistan is party to.

In addition, it is expected that NHRC will strengthen its efficiency on systemic monitoring of legislation and law enforcement practice on human rights and on development of proposals on enhancement of the system to organize the implementation of international human rights standards by state bodies and CSOs.

Project activities will allow to enhance the forms and coordination functions of NHRC on informational, awareness raising, educational and printing activities on human rights and conducting research activities in this area. To raise the awareness of partners, project will conduct target research studies to identify the possible solutions for recommendations, including on the basis of the best foreign practices, and capacity development of key national institutions responsible for implementation of the UPR/Treaty Bodies recommendations.

The main output of the project: Increased capacities of national institutions on human rights to follow-up to UPR and Treaty Bodies recommendations based on the results of the review of national reports of Uzbekistan on human rights and freedoms.

Overall strategic goal of the Project is to strengthen accountability, transparency and efficiency of national human rights and rule of law institutions for implementation and monitoring of international human rights commitments. This the coordination of public administration on human rights will be strengthened and CSOs will receive expert and consultative support on organization of public oversight and monitoring in this area.

Objectives:

- 1. Enhance quality of national human rights monitoring system through the widening use of the UN human rights protection system in the work of national human rights institutions
- 2. Develop institutional capacities of rule of law state institutions for better protection of human rights through the implementation of international human rights treaties of Uzbekistan.

The project has four components:

1) Assistance to national partners in collaboration with OHCHR and regional organizations

This component will assist in strengthening international cooperation with Charter and Treaty Bodies of UN, OHCHR, European and other foreign institutions on human rights and freedoms.

Planned activities:

1.1. Support in participation of the delegation of Uzbekistan at sessions of the UN Human Rights Treaty Bodies, the UPR and the Human Rights Council (HRC) High-level Segment;

1.2. Methodological assistance for adaptation and implementation of human rights indicators in the process of the country's national reporting;

1.3. The study of the methodology of gender statistics in national reports on the UPR and UN Human Rights Treaty Bodies;

1.4. Assistance in the organization of official visits by the Special Procedures in Uzbekistan (as agreed);

1.5. Translation and distribution of selected OHCHR publications in Uzbek language;

1.6. Organization of joint activities and studies with OHCHR, including on issues of SDGs and Outcome 8 of UNDAF 2016-2020.

1.7. Organization of technical consultations and video conferences with relevant offices and departments of OHCHR

1.8. Conduct research activities on human rights in accordance with NAP and recommendations of Charter and Treaty Bodies based on analysis of international best practices on human rights protection within the framework of SDGs.

1.9. Assistance in organization of international conferences on human rights in Uzbekistan.

1.10. Assist in ensuring the participation of the delegation of Uzbekistan in regional events (workshops, seminars, conferences) UNDP Istanbul Regional Hub and OHCHR/ROCA etc.

Expected Results on component 1:

1.1. Improving the quality of national reports using disaggregated data

1.2. Strengthening partnership with OHCHR, as well as with UN human rights mechanisms (including the UPR, Special Procedures and Human Rights Treaty Bodies)

1.3. Adaptation and application of international best practices for the protection of human rights in Uzbekistan

2) Support for monitoring the implementation of the recommendations from the Charterbased and the Human Rights Treaty Bodies

Planned activities:

2.1. Joint research, referred to in the National Action Plans on the implementation of the recommendations of Charter-based and Treaty Bodies

2.2. Preparation of analytical information on positive experience on human rights protection in foreign countries

2.3. Organization of joint workshop on monitoring of implementation of NAPs.

2.4. Development of recommendations on open data in the area of human rights indicators and gender statistics in data.gov.uz portal

2.5. Monitoring on realization of social and economic rights of vulnerable groups, such as women, PWDs, elderly within the framework of national indicators for SDGs and Action Strategy;

2.6. Conduct review of implementation of NAPs in the form of extended and thematic discussions at roundtables regarding the progress and necessary amendments to NAPs with participation of all concerned parties.

2.7. Organization of a joint seminar on the implementation of the National Action Plans on the implementation of the recommendations of HRC and international UN Treaty Bodies

2.8. Joint publications on human rights and knowledge transfer activities

2.9. Preparation of PSAs, printed materials on interpretation of legislation on human rights, and regularly organize TV and radio programmes, presentations in International Press Club and mass media on human rights topics.

2.10. Technical assistance in development of national database on human rights in Uzbekistan (subject to resources availability):

- Preparation of Concept note on national information database

- Development of methodological recommendations for state bodies on collection, analysis and summarizing of quantitative and qualitative information on human rights

- Design of indicators on implementation of each categories of civil, political, economic, social and cultural rights

- Preparation of draft normative legal acts which would regulate data collection, analysis and assessment related to implementation of international human rights obligations of Uzbekistan.

- Development of draft Instructions on preparation of national and alternative reports on human rights

- Conduct awareness raising activities on collection and analysis of disaggregated date on realization of human rights and freedoms.

Expected Results of Component 2:

2.1. Implementation of the Charter-based/Treaty Bodies recommendations

2.2. Raising awareness of beneficiaries about the UPR mechanism

2.3. The mobilization of donor efforts and national partners to implement the National Action Plan

3) The development of institutional capacity to implement the provisions of international human rights law

Planned activities:

3.1. Assistance in improving the legislative process to incorporate the provisions of international human rights law

3.2. Designing a "roadmap" to prepare for the ratification of the Convention and Optional Protocol (Convention on the Rights of Persons with Disabilities, OPCAT etc)

3.3. Seminars and workshops for the deputies and state agencies involved in the development of draft legislative acts

3.4. Publication of national reports and concluding observations (with translation into state language) of HRC and Treaty Bodies in informational legal databases

3.5. Conduct analysis and development proposals on ratification of OPCAT.

Resources Required to Achieve the Expected Results

To accelerate the implementation of recommendations under the Charter-based and the relevant Treaty Bodies, the UNDP will assist Uzbekistan to involve more international partners and donor. The project will be implemented by UNDP Uzbekistan in close coordination and consultation with the UN Resident Coordinator with advisory support by several UN agencies, including OHCHR, to ensure an integrated and holistic approach. Finally, the project will facilitate dialogue with national counterparts and NGOs, and other multi-lateral and bilateral donor community present in Uzbekistan, on the basis of joint work plans.

Partnerships

The National Center for Human Rights of the Republic of Uzbekistan will ensure the active participation of all responsible state institutions and non-governmental organizations in the implementation of the National Plan of Action to implement the recommendations. In addition, the NCHR will ensure a clear division of responsibilities between the involved government agencies and non-governmental organizations in the implementation of relevant recommendations, as well as the wide participation of responsible government institutions and non-governmental organizations in the implementation of responsible government institutions and non-governmental organizations in governmental organizations in joint activities, including round tables, training and research. If necessary, the NCHR will convene responsible state bodies and public organizations to coordinate the

implementation of the recommendations of the Charter-based and the UN Treaty Bodies. Together with the Project Team, the NCHR will identify the capacity building needs of government agencies and non-governmental organizations responsible for implementing the recommendations.

If the necessary financial resources are available, the Project organizes short-term training for NCHR specialists, the secretariat of the Human Rights Commissioner of the Oliy Majlis of the Republic of Uzbekistan at the Office of the United Nations High Commissioner for Human Rights in Geneva. This internship will make it possible to get acquainted with the activities of the Office of the United Nations High Commissioner for Human Rights and other UN treaty bodies, raise awareness about the activities of international human rights bodies, exchange experience in improving the effectiveness of protection and observance of human rights.

In addition, the Project will contribute to improving the knowledge and practical skills of NCHR staff in monitoring human rights compliance, taking into account generally recognized international standards, and discussing and developing proposals for the further development of mechanisms for organizing and conducting monitoring.

Briefly, the context of anticipated work plans with key implementing partners will cover the following areas of cooperation:

Parliament: harmonization of legislation with UN conventions, SDGs nationalization and international legal expertise of draft laws;

MoJ: anti-corruption expertise, regulatory impact assessment of legislation on vulnerable groups, capacity building of Inter-Agency Working Group on Human Rights;

General Prosecutor office: National Action Plan on CAT, prevention of corruption in public sector, and transparency of prosecutor bodies;

NHRIs: joint monitoring exercise on selected human rights, UPR public monitoring sessions, capacity development of NHRIs.

Universities and training institutions (Law University, Lawyer Training Center, Academy of GPO, Police Academy etc): enhancing the curriculum on human rights, joint publications and research on legal subjects, moot courts and master classes with international experts.

This project involved programmatic and financial support from UNDP Istanbul Regional Hub on capacity development of NHRIs, including National Human Rights Center as well as for a number of public awareness raising activities and joint monitoring exercises on selected human rights. The regional partnership, exchange of experience and knowledge sharing on strengthening the national human rights institutions in Eastern Europe and CIS region will be the focus of this support.

The project will consult regularly with OHCHR on substantial human rights topics, human rights data indicators, joint events and capacity building of national counterparts.

The main tool for involving these bodies is to conduct joint monitoring of UPR implementation, research on human rights issues, preparation of analytical reports and development of draft legal acts in compliance with international human rights law. In addition, in the framework of the Project it is planned to organize human rights training courses and seminars with public servants as the main audience. International experts in different areas of human rights will be involved in order to strengthen NHRIs' and policymakers' capacity and disseminating knowledge on the best practices related to implementation of UPR and Treaty Bodies recommendations.

Finally, the project will actively participate in national and international events organized by national partners during which it is planned to exchange experience on human rights and views on the project's mandate.

South-South and Triangular Cooperation (SSC/TrC)

Project will support the participation of national partners in regional events to be organized by OHCHR/ROCA and UNDP IRH as well as other partners.

Knowledge

In addition to capacity building for government officials and other concerned parties through trainings, round tables and seminars, knowledge and experience sharing will be carried out by the project through:

Upgraded curriculum and education tools for law enforcement and academia will become a platform for ensuring transparent and equal access to all stakeholders for knowledge on human rights.

From organizational standpoint, after the project completion, the tools (methods, programs, and information exchanges, infographics, brochures and other literature) created with the Project's support and intellectual contributions of experts will remain with the national partners for their use.

The success of the project is highly interconnected with the human resource capacity of the NHRIs, ministries and agencies, the level of knowledge and the availability of appropriate skills to apply new methodologies. To ensure sustainability and scale-up of project results the Project will maintain a close relationship with NHRC and educational institutions in preparing training materials, textbooks and training of trainers, who could continue training and ensure wide dissemination of knowledge products on human rights produced during the project implementation. Activities aimed to enhance the implementation of UPR/Treaty Bodies recommendations and international treaties on human rights will be reinforced by scientific, research and practical workshops, consultations and discourses, training courses, and analytical materials, methodologies etc.

IV. PROJECT MANAGEMENT

Cost Efficiency and Effectiveness

• The project activities will be identified and endorsed by NHRC in consultation with relevant government agencies and UNDP in Uzbekistan.

• UNDP and NHRC jointly will mobilize other donors and international partners to cost-share the project activities, especially, with regard to study-tours and visiting experts, as well as preparation of knowledge products.

• Regarding all handbooks and analytical papers prepared by this project and to be published, NHRC will take all necessary measures to clear necessary endorsements and permits in line with national legislation of Uzbekistan, and with respect to copyright laws, including international copyrights and principles of academic integrity.

• UNDP will partner UNV as well as other international organizations in order to involve international volunteers on fully or partially cost-shared basis. In addition, UNDP will collaborate with multi-lateral and bilateral donors to share the costs of study tours and visiting international experts.

In-House, Multi-Disciplinary Approach will be used, which envisages UNDP's ability to leverage a range of in-house expertise within its Good Governance Unit diminishes the need to bring in international consultants, resulting in a significant reduction in overall project costs.

Cost-effectiveness has been factored into all planned project activities. Project will work to maximize the impact of each spent unit funds and to get quality results at the lowest possible cost.

Project Management

The Project Board will be responsible for making by consensus management decisions for a project when guidance is required by the Project Manager, including recommendations for UNDP/ NHRC approval of project plans and revisions. All other Project management roles are presented in ANNEX II. Project Management Roles.

Project Board contains three roles, including:

1) An Executive: individual (National Project Coordinator from NHRC) representing the project ownership to chair the group.

2) Senior Supplier: UNDP (1 representative): The Senior Supplier's primary function within the Board is to provide guidance regarding the technical feasibility of the project.

3) Senior Beneficiary: NHRC (1 representative) representing the interests of those who will ultimately benefit from the project. The Senior Beneficiary's primary function within the Board is to ensure the realization of project results from the perspective of project beneficiaries as listed in the Annex 1 to the project document.

In accordance with provisions of MoU signed in October 2016, approved Country Programme Document 2016-2020, as well as Letter of Agreement between UNDP and NHRC, the UNDP Country Office shall provide services for the Project as described below.

The NHRC will provide office premises for the project team as well as telephone communication lines, and the required expertise and services of their corresponding staff.

Direct UNDP Country office Support Services to the Programme Implementation

In accordance with signed Letter of Agreement, the UNDP and NHRC have agreed that the UNDP Country Office will provide the following support services for the project activities at the request of the NHRC:



This project document shall be the instrument referred to as such in Article 1 of the Standard Basic Assistance Agreement between the Government of Uzbekistan and UNDP, signed on 1993. All references in the SBAA to "Executing Agency" shall be deemed to refer to "Implementing Partner."

This project will be implemented by NHRC ("Implementing Partner") in accordance with its financial regulations, rules, practices and procedures only to the extent that they do not contravene the principles of the Financial Regulations and Rules of UNDP. Where the financial governance of an Implementing Partner does not provide the required guidance to ensure best value for money, fairness, integrity, transparency, and effective international competition, the financial governance of UNDP shall apply.

In accordance with the Letter of Agreement between UNDP and NHRC for the provision of support services, the UNDP Country Office in Uzbekistan may provide, at the request of the implementing partner, following support services:

- (a) Identification and/or recruitment of project and programme personnel and consultants;
- (b) Identification and facilitation of training activities, seminars and workshops;
- (c) Procurement of goods and services;
- (d) Processing of payments, disbursements and other financial transactions;
- (e) Administrative services including travel authorization, visa requests and other arrangements;

Detailed description of services is provided in the Annex-6 of this project document.

The goods procured within the framework of the Project and necessary for the implementation of its activities, in particular IT equipment, software & office furniture shall be transferred to the ownership of the NHRC, unless the Project Board decides otherwise or the goods have been procured from the funds provided by third parties and the agreements with them stipulate other arrangements. The relevant provisions of the Standard Basic Assistance Agreement (SBAA) between the Government of Uzbekistan & the UNDP, signed by Parties on 10 June 1993, incl. the provisions on liability and privileges & immunities, shall apply to the provision of such support services.

Annex 2. Project Board Terms of Reference

I. PROJECT BOARD

Overall responsibilities

The Project Board is the group responsible for making by consensus management decisions for a project when guidance is required by the Project Manager, including recommendation for UNDP/NHRC approval of project plans and revisions. In order to ensure UNDP's ultimate accountability, Project Board decisions should be made in accordance to standards that shall ensure best value to money, fairness, integrity transparency and effective international competition. In case a consensus cannot be reached, final decision shall rest with the UNDP Resident Representative. Project reviews by this group are made at designated decision points during the running of a project, or as necessary when raised by the Project Manager. This group is consulted by the Project Manager for decisions when (Project Manager tolerances (normally in terms of time and budget) have been exceeded.

Based on the approved annual work plan (AWP), the Project Board may review and approve project quarterly plans when required and authorizes any major deviation from these agreed quarterly plans. It is the authority that signs off the completion of each quarterly plan as well as authorizes the start of the next quarterly plan. It ensures that required resources are committed and arbitrates on any conflicts within the project or negotiates a solution to any problems between the project and external bodies. In addition, it approves the appointment and responsibilities of the Project Manager and any delegation of its Project Assurance responsibilities.

Composition and organization

This group contains three roles, including:

- 1) **An Executive**: individual representing the project ownership to chair the group.
- Senior Supplier: individual or group representing the interests of the parties concerned which provide funding and/or technical expertise to the project. The Senior Supplier's primary function within the Board is to provide guidance regarding the technical feasibility of the project.
- 3) Senior Beneficiary: individual or group of individuals representing the interests of those who will ultimately benefit from the project. The Senior Beneficiary's primary function within the Board is to ensure the realization of project results from the perspective of project beneficiaries.

Potential members of the Project Board are reviewed and recommended for approval during the LPAC meeting. Efforts should be made to extent possible to ensure gender balance among the members of the Project Board.

Specific responsibilities:

Initiating a project

- Agree on Project Manager's responsibilities, as well as the responsibilities of the other members of the Project Management team;
- Delegate any Project Assurance function as appropriate;
- Review and appraise detailed Project Plan and AWP, including Atlas reports covering activity definition, quality criteria, issue log, updated risk log and the monitoring and communication plan.

Running a project

- Provide overall guidance and direction to the project, ensuring it remains within any specified constraints;
- Address project issues as raised by the Project Manager;

- Provide guidance and agree on possible countermeasures/management actions to address specific risks;
- Agree on Project Manager's tolerances in the AWP and quarterly plans when required;
- Conduct regular meetings to review the Project Quarterly Progress Report and provide direction and recommendations to ensure that the agreed deliverables are produced satisfactorily according to plans.
- Review Combined Delivery Reports (CDR) prior to certification by the UNDP;
- Appraise the Project Annual Review Report, make recommendations for the next AWP, and inform the Project Board about the results of the review;
- Review and approve end project report, make recommendations for follow-on actions;
- Provide ad-hoc direction and advice for exception situations when project manager's tolerances are exceeded;
- Assess and decide on project changes through revisions.

Closing a project

- Assure that all Project deliverables have been produced satisfactorily;
- Review and approve the Final Project Review Report, including Lessons-learned;
- Make recommendations for follow-on actions to be submitted to the Outcome Board.

II. EXECUTIVE

The Executive is ultimately responsible for the project, supported by the Senior Beneficiary and Senior Supplier. The Executive's role is to ensure that the project is focused throughout its life cycle on achieving its objectives and delivering outputs that will contribute to higher level outcomes. The Executive has to ensure that the project gives value for money, ensuring a cost-conscious approach to the project, balancing the demands of beneficiary and supplier.

Specific responsibilities (as part of the above responsibilities for the Project Board):

- Ensure that there is a coherent project organization structure and logical set of plans;
- Set tolerances in the AWP and other plans as required for the Project Manager;
- Monitor and control the progress of the project at a strategic level;
- Ensure that risks are being tracked and mitigated as effectively as possible;
- Organize and chair Project Board meetings.

If the project warrants it, the Executive may delegate some responsibility for the project assurance functions.

III. SENIOR BENEFICIARY

The Senior Beneficiary is responsible for validating the needs and for monitoring that the solution will meet those needs within the constraints of the project. The role represents the interests of all those who will benefit from the project, or those for whom the deliverables resulting from activities will achieve specific output targets. The Senior Beneficiary role monitors progress against targets and quality criteria. This role may require more than one person to cover all the beneficiary interests. For the sake of effectiveness, the role should not be split between too many people.

Specific responsibilities (as part of the above responsibilities for the Project Board):

- Ensure the expected outputs and related activities of the project are well defined;
- Make sure that progress towards the outputs required by the beneficiaries remains consistent from the beneficiary perspective;
- Promote and maintain focus on the expected project output;
- Prioritize and contribute beneficiaries' opinions on Project Board decisions on whether to implement recommendations on proposed changes;

• Resolve priority conflicts.

The assurance responsibilities of the Senior Beneficiary are to check that:

- Specification of the Beneficiary's needs is accurate, complete and unambiguous;
- Implementation of activities at all stages is monitored to ensure that they will meet the beneficiary's needs and are progressing towards that target;
- Impact of potential changes is evaluated from the beneficiary point of view;
- Risks to the beneficiaries are frequently monitored.

Where the project's size, complexity or importance warrants it, the Senior Beneficiary may delegate the responsibility and authority for some of the assurance responsibilities.

IV. SENIOR SUPPLIER

The Senior Supplier represents the interests of the parties that provide funding and/or technical expertise to the project (designing, developing, facilitating, procuring, implementing). The Senior Supplier's primary function within the Board is to provide guidance regarding the technical feasibility of the project. The Senior Supplier role must have the authority to commit or acquire supplier resources required.

Specific responsibilities (as part of the above responsibilities for the Project Board)

- Make sure that progress towards the outputs remains consistent from the supplier perspective;
- Promote and maintain focus on the expected project output from the point of view of supplier management;
- Ensure that the supplier resources required for the project are made available;
- Contribute supplier opinions on Project Board decisions on whether to implement recommendations on proposed changes;
- Arbitrate on, and ensure resolution of, any supplier priority or resource conflicts.

The assurance responsibilities of the Senior Supplier are to:

- Advise on the selection of strategy, design and methods to carry out project activities;
- Ensure that any standards defined for the project are met and used to good effect;
- Monitor potential changes and their impact on the quality of deliverables from a supplier perspective;
- Monitor any risks in the implementation aspects of the project.

If warranted, some of this assurance responsibility may be delegated.

V. PROJECT MANAGER

Overall responsibilities

The Project Manager has the authority to run the project on a day-to-day basis on behalf of the Project Board within the constraints laid down by the Board. The Project Manager is responsible for day-to-day management and decision-making for the project. Project Manager's prime responsibility is to ensure that the project produces the results specified in the project document, to the required standard of quality and within the specified constraints of time and cost.

Prior to the approval of the project, the <u>Project Developer</u> role is the UNDP staff member responsible for project management functions during formulation until the PM is in place.

Specific responsibilities would include:

Overall project management:

- Manage the realization of project outputs through activities;
- Provide direction and guidance to project team/responsible parties;

- Liaise with the Project Board or its appointed Project Assurance roles to assure the overall direction and integrity of the project;
- Identify and obtain any support and advice required for the management, planning and control of the project;
- Responsible for project administration;
- Liaise with any suppliers;
- May also perform Team Manager and Project Support roles.

Running a project

- Plan the activities of the project and monitor progress against the initial quality criteria.
- Mobilize goods and services to initiative activities, including drafting TORs and work specifications;
- Monitor events as determined in the Monitoring & Communication Plan, and update the plan as required;
- Manage requests for the provision of financial resources by UNDP, using advance of funds, direct payments, or reimbursement using the FACE (Fund Authorization and Certificate of Expenditures);
- Monitor financial resources and accounting to ensure accuracy and reliability of financial reports;
- Manage and monitor the project risks as initially identified in the Project Brief appraised by the LPAC, submit new risks to the Project Board for consideration and decision on possible actions if required; update the status of these risks by maintaining the Project Risks Log;
- Be responsible for managing issues and requests for change by maintaining an Issues Log.
- Prepare the Project Quarterly Progress Report (progress against planned activities, update on Risks and Issues, expenditures) and submit the report to the Project Board and Project Assurance;
- Prepare the Annual Review Report, and submit the report to the Project Board and the Outcome Board;
- Based on the review, prepare the AWP for the following year, as well as Quarterly Plans if required.

Closing a Project

- Prepare Final Project Review Reports to be submitted to the Project Board and the Outcome Board;
- Identify follow-on actions and submit them for consideration to the Project Board;
- Manage the transfer of project deliverables, documents, files, equipment and materials to national beneficiaries;
- Prepare final CDR/FACE for signature by UNDP and the Implementing Partner.

VI. PROJECT ASSURANCE

Overall responsibility

Project Assurance is the responsibility of each Project Board member, however the role can be delegated. The Project Assurance role supports the Project Board by carrying out objective and independent project oversight and monitoring functions. This role ensures appropriate project management milestones are managed and completed. Project Assurance has to be independent of the Project Manager, therefore, the Project Board cannot delegate any of its assurance responsibilities to the Project Manager.

The following list includes the key suggested aspects that need to be checked by the Project Assurance throughout the project as part of ensuring that it remains relevant, follows the approved plans and continues to meet the planned targets with quality.

- Maintenance of thorough liaison throughout the project between the members of the Project Board;
- Beneficiary needs and expectations are being met or managed;
- Risks are being controlled;
- Adherence to the Project Justification (Business Case);
- Projects fit with the overall Country Programme;
- The right people are being involved;
- An acceptable solution is being developed;
- The project remains viable;
- The scope of the project is not "creeping upwards" unnoticed;
- Internal and external communications are working;
- Applicable UNDP rules and regulations are being observed;
- Gender mainstreaming policy embedded into project and implemented;
- Any legislative constraints are being observed;
- Adherence to RMG monitoring and reporting requirements and standards;
- Quality management procedures are properly followed;
- Project Board's decisions are followed and revisions are managed in line with the required procedures.

Specific responsibilities would include:

Initiating a project

- Ensure that project outputs definitions and activity definition including description and quality criteria have been properly recorded in the Atlas Project Management module to facilitate monitoring and reporting;
- Ensure that people concerned are fully informed about the project;
- Ensure that all preparatory activities, including training for project staff, logistic supports are timely carried out.

Running a project

- Ensure that funds are made available to the project;
- Ensure that risks and issues are properly managed, and that the logs in Atlas are regularly updated;
- Ensure that critical project information is monitored and updated in Atlas, using the Activity Quality log in particular;
- Ensure that Project Quarterly Progress Reports are prepared and submitted on time, and according to standards in terms of format and content quality;
- Ensure that CDRs and FACE are prepared and submitted to the Project Board and Outcome Board;
- Perform oversight activities, such as periodic monitoring visits and "spot checks";
- Ensure that the Project Data Quality Dashboard remains "green".

Closing a project

- Ensure that the project is operationally closed in Atlas;
- Ensure that all financial transactions are in Atlas based on final accounting of expenditures;
- Ensure that project accounts are closed and status set in Atlas accordingly.

VII. PROJECT SUPPORT

Overall responsibilities

The Project Support role provides project administration, management and technical support to the Project Manager as required by the needs of the individual project or Project Manager.

Specific responsibilities would include:

Provision of administrative services:

- Set up and maintain project files;
- Collect project related information data;
- Update plans;
- Administer the quality review process;
- Administer Project Board meetings.

Project documentation management:

- Administer project revision control;
- Establish document control procedures;
- Compile, copy and distribute all project reports.

Financial Management, Monitoring and reporting

- Assist in the financial management tasks under the responsibility of the Project Manager;
- Provide support in the use of Atlas for monitoring and reporting.

Provision of technical support services

- Provide technical advices;
- Review technical reports;
- Monitor technical activities carried out by responsible parties.
