

## **Project Performance and Results**

### **Overview**

Strengthening Capacity and Service Delivery of Local Administrations (GPAR SCSD) project was officially launched on 03 February 2012. This project is being implemented in alignment with other projects of the National GPAR Programme. The overall objective of this project is increased capacity in the local administration, leading to better delivery of services which improve the lives of the poor, especially in rural areas of Lao PDR. The strategy is to build around a series of interrelated outputs that take forward proven results and innovations to realise the overall outcome. These include the introduction of district level performance assessments and performance based Block Grants (capital and recurrent) that will provide incentives for improved overall performance linked to the local administration mandate, the project seeks to improve local MDG-targeted service delivery through increased capacity and long term reform.

The seven outputs of the project are:

1. Policies and regulatory frameworks for effective local administration at province and district level.
2. Improved capacities of local administrations to fulfill its service delivery mandates.
3. Improved MDG focused service delivery provided through formula based and equity focused block grants to the districts.
4. Improve Access to Citizens Service through One Door Service
5. GPAR Capacity Development and Modernisation Fund (CADEM) to support strategic innovations in Public Administration reforms
6. Citizens' Feedback and district mechanisms for responsive and accountable service delivery
7. Project administration and support.

### **Overview of activities during period**

The main activities carried out by the project during this start up period are listed below:

#### **1. Policies and regulatory frameworks for effective administrations:**

- Review mission led by UNCDF by international consultant to undertake Review of Operational Expenditure Block Grant (OEBG) and Options for the Future.
- Mission led by UNCDF by international consultant to finalise new District Development Fund (DDF) Performance Assessment Manual, to up-date DDF MOU and related operation guidelines and manuals, in preparation for new DDF support to districts.
- Consultation and dissemination workshops led by MoHA to update and dialogue on emerging government policy and plans re new order (16/2012) of Prime Minister on mandates and strengthening sub-national administrations. (Shared with Output 2)
- Preparatory work on equity focused block grants for capital and recurrent (operational expenditures) begun under previous related project (GPAR SBSD) and finalized internally by GPAR SCSD.

2. Improved capacities of local administrations:
  - Initial round of meetings with 3 Districts in Xiengkhouang province to prepare MDG focused targets and inform about the Millennium Acceleration Framework (MAF) sub-project, which will be implemented during 2012 under SCSD, leveraging the OEBG approach.
  - Local level dissemination workshops led by MoHA to update and dialogue on emerging government policy and plans re new order (16/2012) of Prime Minister on mandates and strengthening capacities of sub-national administrations. (Shared with Output 1)
3. Improved MDG focused service delivery by districts
  - Procurement process initiated for necessary equipment and office furniture to support target provinces and districts.
4. Improve Access to Citizens Service
  - Procurement process initiated for initial equipment & office furniture.
5. GPAR Capacity Development and Modernisation Fund
  - Internal preparations with no project Budget impact
6. Citizens' Feedback and district mechanisms for responsive and accountable service delivery
  - No activity planned for Q2

#### **Workshops and meetings**

- OEBG Review Workshop  
A de-brief workshop was hosted by MoHA at the end of the in-country mission led by an international consultant to undertake Review of Operational Expenditure Block Grant (OEBG) and Options for the Future. Government agencies, including Ministry of Finance, Ministry of Health, Ministry of Education, Ministry of Planning and investment, UNDP, UNCDF, UNICEF and development partners were among the 27 participants.
- Pre-Inception Workshop  
A de-brief workshop was hosted by MoHA at the end of the in-country mission led by international consultant to finalise new District Development Fund (DDF) Performance Assessment Manual, to up-date DDF MOU and related operation guidelines and manuals, in preparation for new DDF support to districts. Among the 18 participants were representatives from government agencies, including Ministry of Finance, Ministry of Health, Ministry of Education, Ministry of Planning and investment, UNDP, UNCDF, UNICEF and development partners participated.
- Local Workshops ('Sam Sang')  
A series of local level workshops led by MoHA to consult and disseminate on emerging government policy and plans re new order (16/2012) of Prime Minister on mandates and strengthening sub-national administrations. The project prepare budget to support workshops that have plan to implement in third quarterly.

- Local Workshops (MAF-OEBG)

Initial round of meetings with 3 Districts in Xiengkhouang province involving 33 participants, to prepare MDG focused targets and inform about the Millennium Acceleration Framework (MAF) sub-project, which will be implemented during 2012 under SCSD, leveraging the OEBG approach.

Recruitment to most key positions has been completed. Recruitment of GPAR Chief Technical Advisor was initiated and is progressing in accordance with UNDP processes and procedures.
