## II. PURPOSE

The main purpose of this consolidated five-year programme (2011-2015) is to provide more efficient and results-based support to help the Government of Lao PDR achieve the valuable goals of the 7<sup>th</sup> National Socio-Economic Development Plan (NSEDP 2011-2015), especially more inclusive and equitable growth, the Millennium Development Goals (MDGs) and substantial progress towards graduation from Least Developed Country (LDC) status.

The consolidated support programme consists of four mutually supportive components, including (i) support to consultative planning, implementation, monitoring, assessment and reporting on the NSEDP/MDGs; (ii) support to strengthening effective monitoring and evaluation of progress towards goals of NSEDP/MDGs via LaoInfo; (iii) support to strengthening the Round Table Process for the Achievement of NSEDP/MDGs; and (iv) support to advancing Human Development through policy-informing research on Human Development Issues, especially relevant for achieving NSEDP/MDGs.

Although all programme components aim at assisting the Government of Lao PDR to achieve the valuable goals within NSEDP, each has differently specific objectives, outputs and activities, and responsible parties. The main objective of the first component, implementing by DOP, is to strengthen the capacity of MPI to translate the five-year NSEDP into effective results-based annual implementation plans, including public investment programmes, aiming at securing continual progress towards the valuable goals of NSEDP. The second component, implementing by LSB, aims to strengthen the monitoring of the 7<sup>th</sup> plan implementation and progress towards the MDGs, which will be achieved through improvement of the common database (LaoInfo) that contains updated data disaggregated by sex, age group, region and ethnicity to support evidence-based planning and decision-making at both national and sub-national levels in a timely manner. The third component that is executing by DIC aims at further strengthening the capacity of MPI, including the DIC in helping the Government lead and facilitate the effective mobilisation, coordination and management of Official Development Assistance (ODA) provided by the Lao PDR's growing number of Development Partners (DPs). The last component's main objective is to help further develop government capacity to undertake applied policy research on strategically-selected human development issues for achieving the valuable goals of NSEDP/MDGs and advancing the country towards LDC graduation.

### **The programme will help the Government achieving the following outputs:**

*Component 1: Support to consultative planning, implementation, monitoring, assessing and reporting on the NSEDP/MDGs*

1. Poverty reduction and MDG priorities and programmes in the 7th Plan (2011-2015) are incorporated in annual plans, budgets and public investment programmes (PIPs)
2. Macroeconomic analysis and management conducted to contribute to the macroeconomic achievements outlined in the NSEDP
3. Capacity for local planning and implementation improved at the central and local levels
4. Substantially improved monitoring, assessment and reporting framework and enhanced capacity of MPI and three provinces to monitor and report on plan implementation using LaoInfo

- Strengthened capacity of the MDG and LDC Secretariats to coordinate, advocate and facilitate progress towards the MDGs and implementation of the LDC Plan of Action (MOFA)

*Component 2: Support to effective monitoring and evaluation of progress towards goals of NSEDP/MDGs via LaoInfo*

- A Common data base (LaoInfo) supports evidence-based reporting, planning and decision making at the national and sub-national to help guide implementation of NSEDP/MDGs;
- Increased stakeholder awareness and participation, improved advocacy and dissemination to ensure the best use of official statistics and a synchronisation with planning process is increasingly enhanced;
- Improved networking and statistical cooperation and knowledge sharing at the national, regional and international levels.

*Component 3: Support to strengthening the Round Table Process for achievement of NSEDP/MDGs*

- Enhanced greater substantive dialogues and closer partnership with DPs, and effective resource mobilisation and management through the Round Table Process, including improving Sector Working Group Mechanism, in particular the SWG Secretariats for facilitating effective implementation of NSEDP and VDCAP towards achieving the MDGs in Lao PDR;
- Through implementation of the Aid Management Platform (AMP), enhanced reliability, accessibility and transparency of ODA related data, information and results through the established ODA database management system and related quality ODA analytical reports/documents;
- Through the launched of new NIM Standard Operating Procedure (SOP), strengthened capacity of DIC and its Implementing Partners in effectively managing ODA related programmes and projects;
- Provided quality assurance and support to national implementation management through audit and spot checks.

*Component 4: Support to advancing human development through policy-informing research on human development issues especially relevant for achieving NSEDP/MDGs*

- Further enhanced awareness of the concept of Human Development (HD), and capacity for MDG and Human Development reporting at national and sub-national levels;
- Produced one high quality National Human Development Report (NHDR), and/or Human Development aspects at provincial dimension;
- Evidence-based research and analysis to support the implementation of the NSEDP/MDGs.

*Component 2: Support to effective monitoring and evaluation of progress towards goals of NSEDP/MDGs via LaoInfo*

- 1. Production of statistical report to present the status of national socio-economic development of the country using LaoInfo database system and publish it to support effective implementation of NSEDP/MDG
- 2. Updated the MDG and National Socio-economic Database and publish it through LaoInfo offline and website
- 3. Organization of dissemination workshop/training on Notification on Statistical Dissemination and Use of Official Statistics and Statistical Literacy Guide for management level of LMs
- 4. Organization of dissemination workshop/training on Notification on Statistical Dissemination and Use of Official Statistics and Statistical Literacy Guide for Technical level of LMs

*Component 3: Support to strengthening the Round Table Process for achievement of NSEDP/MDGs*

- 1.1.1 The implementation of 11<sup>th</sup> HLRTM recommendations/action points is properly followed up.
- 1.1.2 The Roadmap including key milestones for the 2014 results-based RTIM that focuses on the 7<sup>th</sup> NSEDP implementation progress and 8<sup>th</sup> plan preparation, is prepared, consulted, finalised and approved by the Government through a National RTP Steering Committee Meeting.
- 1.1.3 The Provincial Consultation Meeting with an effective link between local level challenges and the 2014 RTIM's Agenda, is organised and followed up accordingly.
- 1.2.1 The coordination, lessons learned and experience exchange among SWGs, as well as between SWGs and local authorities are strengthened.
- 1.2.2 The issues that contribute to NSEDP annual formulation and implementation are focused by respective SWGs meetings/consultations.
- 1.2.3 The ability of SWG secretariat to prepare and effectively implement the RTP related works is enhanced.
- 1.3.1 The VDCAP Monitoring Framework is prepared and circulated for effective implementation with a quarterly update on progress through SWG Chairs and Co-Chairs Meeting.
- 1.3.2 The Government actively engaged in the regional and global aid effectiveness forums.
- 1.3.3 The development financing gaps are addressed to ensure greater achievement of the 7<sup>th</sup> NSEDP/MDGs by 2015 towards LDC graduation in 2020.
- 2.1.1 All ODA related programmes/projects data and information are included in the Aid Management Platform (AMP) System.
- 2.1.2 DIC is able to effectively use the AMP for ODA data collection, storage and analysis to

- support reporting particularly Semi-Annual and Annual ODA related Reports.
- 2.1.3 AMP Users including DIC admins, LMs, DPs/DFAs have well understood and are able to use AMP system.
  - 2.1.4 ODA related data and information is easily and publicly accessible.
- 3.1.1 NIM Manual (Lao version) is finalised and officially shared with IPs with adequate training for Government officials and UNDP supported project personnel.
  - 3.1.2 Coordination among MPI programme components is strengthened.
- 4.1. Annual 2013 Audit recommendations are regularly followed up and implemented properly.

*Component 4: Support to advancing human development through policy-informing research on human development issues especially relevant for achieving NSEDP/MDGs*

- 1.1.1 Revising and improving Human Development text book
- 1.1.2 Preparation for pre-test of Human Development text book before teaching at University of Laos.
- 2.1.1 Revised Concept note that agreed by both NERI and UNDP which will be used for resource mobilization in the Human Development Report 2014 Launching
- 2.1.3 Identify tentative three research papers ( or TBPs ) that support the production of the 5<sup>th</sup> NHDR
- 3.1.1 Quarterly Macro-Economic Updates Produced and the Semi-Annual Result-Sharing Conference Organised.

**Key results/deliverables of the programme for the quarter:**

*Component 1: Support to consultative planning, implementation, monitoring, assessing and reporting on the NSEDP/MDGs*

- 1.2. Draft 8th NSEDP with incorporation of the results from MTR recommendation produced.
- 1.3. Manual for formulation of the NSEDP is available in draft, further improvement is still required.
- 2.1. Four research areas have been identified together with NERI to support the formulation of the 8th plan. However, implementing researches in these areas will be subject to capacity and resource availability.
- 4.1. A set of 7th NSEDP monitoring indicators identified and being cleared by DOP.
- 4.2. 7th NSEDP M&E framework is underway to finalization as indicators are being cleared by DOP.
- 4.4. Application of the outcome basis M&E framework is tested in Vientiane Province needs to be postponed as awaiting the framework to be finalized.
- 5.1. Findings of the third MDGs report is disseminated to students and young government official through workshops.
- 5.2. Reference materials of the Almaty Programme of Action 2014 have not yet been produced due to complexity in fund allocation from different sources.

*Component 2: Support to effective monitoring and evaluation of progress towards goals of NSEDP/MDGs via Laolinfo*

1. Draft statistical report on national socio-economic development trend of the country using Laolinfo database system has been produced.
2. MDG and National Socio-economic Database has been being updated.
3. Dissemination workshops/trainings on Notification on Statistical Dissemination and Use of

Official Statistics and Statistical Literacy Guide have been organized for both management level and technical staff of LMs. The training proved to be very useful for the participants and LSB has been requested to organize this kind of training regularly.

*Component 3: Support to strengthening the Round Table Process for achievement of NSEDP/MDGs*

- 1.1.1 A follow up matrix for the 16 action points/recommendations of the 11<sup>th</sup> HLRTM 2013 has been developed for discussion and follow up. This was also included in the draft 2014 RTIM roadmap that was already shared and discussed at the RTP Retreat, as well as attached in the Retreat report for reference and further processes
  - 1.1.2 The draft roadmap of the 2014 RTIM has been prepared by the RTP secretariat and consulted with both Government ministries and DPs especially SWGs via the RTP Retreat conducted in April 2014.
  - 1.1.3 The draft concept note of RTP provincial consultation, including tentative agenda and programme have been prepared and shared with both Government and development partners for comments. As a result, The FNS Secretariat (MAF, MOES and MOH) have in principle agreed with the theme, objectives and focused areas of the consultation. Due to the inappropriate time of original plan to organise the provincial consultation in July, it is eventually postponed to take place in September in Saravan province. Therefore, the substantive and logistic arrangements for this consultation are continually prepared and followed up during quarter 2 and upcoming quarter.
  - 1.2.1 A part from regularly attending a number of SWG meetings at both technical and executive levels organised by various sectors, the SWGs/Sub-SWGs Chair and Co-Chair list are regularly updated, as well as the SWGs meeting calendar, ToR and SWGs' reports are collected and uploaded in the RTP Website for easy reference.
  - 1.2.2 The letter updating the preparation of the 2014 RTIM, including the following up 16 points recommendations from 2013 RTM, 2014 RTIM Roadmap and provincial consultation concept note were sent to all SWGs (both government and DPs).
  - 1.2.3 The guideline note on the concept for SWGs to prepare and contribute inputs/progress reports for the background document of 2014 RTIM was developed and will be sent to all SWGs by the end of July. This is one of the effective approaches to enhance ability and better collaboration between RTP and SWG secretariat to prepare and effectively implement the RTP-related works.
  - 1.3.1 In order to ensure effective implementation of the VDCAP (2012-2015), a monitoring framework has been developed, consulted within the VDCAP secretariat and widely circulated/launched to all stakeholders in June 2014 for joining the monitoring and reporting the progress of VDCAP implementation.
  - 1.3.2 The Government has effectively participated in the First High-Level Meeting of the Global Partnership for Effective Development Cooperation held in Mexico City during 15-16 April 2014.
  - 1.3.3 To address the development financing gaps and to inform the financing strategy of the next 8<sup>th</sup> NSEDP, the Government under the leadership of DIC/MPI is in the process of preparing a study on development finance and aid assessment (DFAA). This is the analysis of source of development finance to provide an overview of the current and future flows of development finance in particular ODA trend including a mapping of South-South Cooperation (SSC) in Lao PDR. A generic TOR for this study has been prepared and finalised in consultation with government and DPs concerned, including MPI (DIC, NERI and DOP), MOF, UNDP and ADB regional centre and Lao PDR.
- 2.1.1 Since the official launch of AMP system with newly established public portal in

November 2013, a number of dissemination workshops on using AMP have been conducted for the government ministries and provincial authorities, especially in this quarter AED/AMP team was invited to a brief session on AMP management at the Consultation Meeting on the project implementation management organised by the Ministry of Industry and Commerce (MoIC) in May. In addition, a brief session was also made by the team for Saravane and Savannakhet Provincial Planning and Investment Department and Cooperation Division relevant staffs in June.

The ODA related programmes/projects data and information are entered and regularly updated in the Aid Management Platform (AMP) System by the Aid Effectiveness Division (AED/DIC) and Data Focal Agents (up to 33 DFAs from 26 DPs).

2.1.2 The AED/DIC regularly and effectively use the AMP for ODA data collection, storage and analysis to use data of six months generating a raw data report feeding into the 2014 Semi-Annual ODA report.

2.1.3 AMP Users including DIC admins, LMs, DPs/DFAs have well understood and are able to use AMP system through training and regular communication and discussions if there are any issues occurred.

2.1.4 ODA related data and information is easily and publicly accessible through ODA report publication and RTP Website.

3.1.1 The NIM Standard Operational Procedure (SOP) Manual both Lao and English versions are now ready for circulating to all IPs for further implementation, and there were trainings for UNDP supported programmes and projects' personnel held during this quarter. In addition, there were some discussions and consultations between DIC and UNDP to have common understandings and agreement on the use of new NIM SOP. Therefore, there will be a formal letter from DIC to inform all IPs for the implementation and clear guideline of NIM SOP implementation.

3.1.2 A quarterly meeting of MPI programme was conducted in early June to follow-up the updated implementation progress and key challenges/issues of all four components the programme implementation and management, as well as to strengthen coordination and reporting mechanisms among the programme components.

4.1.1 After receiving the 2013 audit reports from auditors in May, the project has discussed the key issues from audit during the RTP monthly meeting, prepared an Audit Follow-up Action Plan and implemented the recommendations accordingly.

*Component 4: Support to advancing human development through policy-informing research on human development issues especially relevant for achieving NSEDP/MDGs*

## **2. Update on implementation of the Vientiane Declaration and its Action Plan**

- The programme objective is to support the achievement of the 7<sup>th</sup> NSEDP with a more inclusive and equitable growth, the MDGs and substantial further progress towards LDC graduation;
- The programme components have been taking an ownership and leadership in leading the formulation and implementation processes of the 7<sup>th</sup> NSEDP/MDGs and the 8<sup>th</sup> NSEDP preparation, including annual NSEDPs and relevant consultation meetings towards achieving national development goals and priorities;
- The programme activities aim at aligning the national priorities through streamlining activities into relevant departments' work plans;
- The VDCAP 2012-2015 and its Monitoring Framework have been finalised and endorsed based on global monitoring framework arose from the Busan High Level forum on Aid Effectiveness, and emerging aid and development effectiveness agenda;
- The programme has supported the use of HACT/common reporting system which is the FACE form, ICE form and IPOA to keep track of records and follow-up daily transactions occurred during the project implementation;
- The implementation of programme activities has been monitored closely by both the Government and UNDP through a regularly reporting and meetings. However, the collaboration among components is still required an improvement.
- NSEDP M&E framework, LaoInfo, LSIS, ODA Database/AMP system and other relevant monitoring tools have been established under relevant departments to be used in monitoring the programme implementation in order to ensure greater aid and development effectiveness.

## **3. Update on partnerships**

- In terms of planning, the component worked in close collaboration with its strategic partners (both government and non-government) for development cooperation and strove to strengthen and build on those partnerships which included developing further relationships with key development partners;
- Though implementing at MPI, the programme activities regularly involved consultation with line ministries. For instance, through the Round Table mechanism especially via Sector Working Groups, partnerships are being strengthened between the GoL and Development Partners to mobilize resources, ensure better utilization of these resources and push forward the development process. Building these partnerships is a collegial responsibility of all government agencies and their international partners.
- The work on M&E framework requires the LSB team to work closely with line Ministries and other partners. For example on the development of NSEDP monitoring

framework, the project team/LSB tried to involve all the related organizations, LMs and DPs in the process. Furthermore, the LaoInfo team has received from different UN agencies, LaoInfo has advocated for a joint work plan from UNICEF, UNFPA and UNDP;

- In addition to the contribution from Luxembourg to the MPI programme, Swiss Development Cooperation (SDC) also provided a funding support through the joint activities of the PEI programme;
- In this quarter the component 4 continued strengthening its partnership with National University of Laos in introducing the HD course to the university. In addition to that the component has been involved with private sector (Lao Chamber of Commerce) through dissemination of the results of it survey on Business Tendency Index (BTI) and Consumer Sentimental Index (CSI).

#### **4. Update on gender mainstreaming**

- Gender mainstreamed in the preparation process of the 8th NSEDP (2016-2020) as well as annual reporting process on implementation of Annual NSEDP&PIP 2013-2014 and preparation of Annual NSEDP 2014-2015. For instance, involving wide participation in the planning process from all has been promoted and extended to women and children to raise their awareness of the 8<sup>th</sup> plan formulation progress at the "seminar on mother & child", held in Vientiane.
- The Gender is mainstreamed into the work of individual groups and considered as a cross cutting issue in their ToR. The component has supported DIC in facilitating and coordinating with all 10 SWGs to mainstream Gender into the work of SWGs. Currently, gender mainstreaming is being realized and integrated into practice which demonstrated through the updating of VDCAP. Some targets and actions stipulated in the VDCAP have primarily focused on how gender is effectively mainstreamed into work at all sector levels.
- The project will ensure gender aspect is properly mainstreamed into all its research. Gender aspects were taken into account when drafting the concept note of the 5th NHDR. For instance, women are encouraged to attend schools and continue their higher education in college and university despite their family's financial difficulty and problems;

#### **5. Update on audit recommendations**

- All the programme components were audited in March 2014 with some recommendations for further improvement especially related to human resources, finance, procurement and assess management as follows:

- Properly calculate Personal Income Tax
- Obtain adequate information in preparing reports
- Use correct expenditure account code when posting entries
- Obtain receipts of goods and services
- Record reason for selecting suppliers accurately
- Obtain appropriate guidance and approval for activities outside the work plan
- Obtain appropriate guidance and approval for payments outside the NIM Manual
- Follow-up UNDP recruitment process
- Record budget analytical review accordingly
- Record correct recipient on cheques
- Record payments accurately
- Record reason for selecting suppliers accurately
- All purchases over USD 625 (LAK 5 million) require at least three quotations
- Recorded incorrectly in chart of account
- Reconcile the IPOA and CDR of Q4, 2013 not performed correctly
- No surprise cash count was conducted in July, August, and September and November 2013
- No proper record of daily log book with actual meter readings from the vehicle.
- It is noted that some of the 2013 audit recommendations have been repeated with the 2012 ones, especially related to wrong record of financial transactions for example. This is due to human errors.
- After having received the 2013 audit reports from auditors in May 2014, each component has developed an audit action plan for easy follow-up the implementation of audit recommendations. This implementation progress has been regularly updated at the component monthly meetings.
- During the second quarter, many recommendations were already implemented while some of them are still in the process of implementation. However, the programme components will ensure that this all will be implemented within the following quarter taking into account the requirements of NIM (SOP) Manual. Nevertheless, adequate training on NIM Manual application is required for the programme components personnel to ensure all policies and procedures have been followed properly.

## **6. List main challenges and issues (if any) faced during reporting period**

- Effective implementation of the planned programme activities and budget with high delivery results is challenging the programme components. Meeting the requirement of NIM (SOP) Manual particularly in term of project delivery rate (80%) is critical for the programme activity and budget implementation and necessary for requesting for new advance.

- Inter-Governmental coordination and involvement of all stakeholders require a more systematic improvement. A full collaboration with all government agencies in line ministries and provincial authorities is essential to achieve the objectives and outcomes attached to each component. Over the quarter, the collaboration and partnership with all stakeholders particularly the line ministries and local authorities have been improved through the participatory planning process, the RTP including the SWG mechanism and the VDCAP revision process for instance. This momentum needs to be sustained in a proper manner.
- Capacity development for MPI relevant departments is essential for effective programme implementation. The integration of all the programme activities into the work of MPI departments/relevant divisions has been put in place and become the key efforts to ensure greater sustainability of programme activities and capacity building/knowledge transfer for national staff. More efforts are also foreseen in the near future to cope with the requirements of each MPI department's mandate especially related to planning, monitoring and evaluation processes, aid coordination and management as well as policy researching process. Coordinated approach for the capacity development will need to be enhanced in order to ensure, in the spirit of the Vientiane Declaration, the full implementation of effective development cooperation related agendas in Lao PDR.
- As there were continuing challenges of time constraints/arrangement, unavailable of the senior management team and senior government to chair the meeting like NSC meeting to give guidance and approval of each component related activities. As a result, although the programme component staff had regular communication with the UNDP POs/PAs on the planned activities, some planned activities/outputs have been delayed and postponed to next quarter, which reflecting the low delivery rate of 2014 budget after the 2014 mid-year. Therefore, it is crucial to ensure that the quarterly workplan is realistic and some solutions for unexpected issues in place to effectively implement the planned activities in a timely manner.
- Limited understanding of the responsible staff and inadequate training on new NIM guideline especially in the financial and procurement areas caused errors. Although SOP training has been organized recently, specific areas still need to be put on the future trainings to prevent potential errors such as new policy on project staff benefits (so called "bonus"), etc.
- In order to promote greater sustainability and national ownership over the programme activities implementation, the programme components especially LSB has assigned relevant staff to be responsible for project implementation. As a result, LSB has always been delay in submission of quarterly reports to DIC for further actions given the time constraints. This has been internally discussed by the project management team and UNDP, and in this connection, the component will ensure this issue is addressed urgently.

#### **IV. ADDITIONAL ACTIVITIES WHICH CONTRIBUTE TO THE OUTCOME AND/OR OUTPUT**

- A study visit to UK in supporting to the 8<sup>th</sup> NSEDP preparation was conducted in the end of June to strengthen capacity and in-depth understanding on the outcome based planning, implementing and reporting as well as realization on essential partnerships in formulating the plan for the government staff who are the key writers of the 8<sup>th</sup> NSEDP. In achieving this activity, the supporting fund was extracted from local planning activities and printing costs of the Annual NSEDP and PIP 2014-15.

The workshop aim at learning the experiences on long term social economic development strategy formation from Vietnamese experts from the Ministry of Planning and Investment of Vietnam. NERI's staffs understand how to formulate long term strategy more clearly. For example, in identify any target indicator it should have a concept behind. Long term strategy does not need to determine exact number. The Knowledge from the workshop will be applied in 2025 long term social economic development strategy and 2030 vision of Lao PDR. The Lao PDR should reconsider and revise some content of existing draft long term strategy in order to make the strategy close to the internal potential and external for sustainable growth.

- Conduct seminar to share lessons learned from UK study visit to support the 8th NSEDP formulation and to present revised draft of 8th plan with incorporation of DP comments
- Finalize National Manual on Formulation of the National Socio-Economic Development Plan of Lao PDR
- Prepare Annual NSEDP and PIP 2014-15
- Continue supporting on providing substantive inputs to macroeconomic analysis
- Facilitate commission of at least five studies under MTR priorities areas by concerned sectors to support the formulation of the 8th NSEDP.
- Consultation workshop with development partners on green growth proposals for three pilot provinces.
- Develop investment profile for potential projects on green growth.
- Continue supporting activities/processes leading to the finalization of the NSEDP M&E framework.
- Testing outcome based reporting for the implementation of the 7th NSEDP 2013/2014 against 7th NSEDP M&E framework that includes PE indicators and pilot outcome based reporting in Vientiane province.

- Prepare a quality substantive Background Document for informing the discussion in the upcoming 2014 RTIM
- Complete the Study on Development Finance and Aid Assessment with stakeholder consultations and clear preliminary findings
- Closely coordinate with all SWGs ensuring all data and information required by the RTP are updated and submitted on a timely manner
- Closely coordinate and attend both executive and technical meetings held by various SWGs and ensure all issues discussed are in line with the agreed theme and focused areas/topics of the 2014 RTIM
- To ensure all stakeholders including both the Government agencies and development partners are updated regularly on the progress of the 2014 RTIM preparation including the VDCAP implementation via either SWG Chairs and Co-Chairs Meetings, or mailing/emailing.
- To ensure all the regional and global development cooperation effectiveness agendas have been reflected and implemented at the national level through actively participating in the global and regional development cooperation forums
- To ensure full operationalization of the AMP system that can generate ODA related reports
- To ensure the RTM website has been regularly updated in terms of both content and structure
- To ensure NIM (SOP) Manual both Lao and English versions have been properly finalised with proper training for all UNDP Supported programmes and projects personnel to ensure effective implementation of the programme and project activities with better delivery results.
