Evidence:

Knowledge and lessons on the subject of the project obtained during the participation and conferences held by international (FAO, ICARDA, CACILM, ICBA, SGP, JASIL) and national departments (Parliament of the Republic of Uzbekistan, Ministry of Economy and Industry, Ministry of Agriculture, The State Committee on Ecology and Environmental Protection, etc.), leading universities and research institutes of the country were discussed in workshops, trainings and TWG meetings. These include the creation of the Center for introducing innovative technologies and resource-saving developments in rainfed agriculture, seed plots for the production of seeds of desert forage plants, efficient use of natural resources (practical application of technology - vegetariy, atmospheric water generator, drip irrigation technology, etc.).

Evidence:

On May 21, 2019, the Law of the Republic of Uzbekistan "On pastures" was adopted and entered into force, which was initiated by the project in accordance with the project document from 2016. The project team has developed and submitted to the Goskomzangeodezcadastre with the next transfer to the Parliament of the Republic of Uzbekistan a set of measures to make changes and amendments to existing legislation (Land Code of the Republic of Uzbekistan, etc.). A draft Resolution of the Cabinet of Ministers of the Republic of Uzbekistan "On Approval of the Regulations on the Procedure for Developing and Conducting Pasture Turns, Determining the Maximum Permissible Standards for Grazing Livestock on Pastures" was prepared and submitted to the Cabinet of Ministers of the Republic of Uzbekistan.

The project has developed a strategy for the development of the use of the undeveloped dry lands of Uzbekistan, transferred it to the relevant ministries and departments, as well as to the Administration of the President of the Republic of Uzbekistan.

The adoption of the above laws show a change in land use policy, as well as high reliability of the results obtained through a significant coverage of the target groups.

Evidence:

According to the project document, gender aspects were considered on the subject of the project, i.e. information on the activities of women in the whole project area was studied and collected, but with a focus on women living in rain-fed dry territories and working in economic entities.

During the project implementation, support was provided to capacity building and advanced training for 8 rural women entrepreneurs, of whom five women were created for the creation of sewing workshops, two women greenhouses and one woman were built to strengthen the capacity of the poultry farm. Women (about 30% of the participants) actively participated in training workshops and other project activities.

In the reported period, problems associated with social risks were not observed. Environmental risks associated with drought and low water flow were observed in 2018. In order to counteract and reduce the negative impact on the environment and socio-economic situation, the project initiated in two project districts the introduction of Integrated Land Use Management Planning mechanism on the pasture area of 3,600 hectares.

11. Were risks to the project adequately monitored and managed?

- 3: The project monitored risks every quarter and consulted with the key stakeholders, security advisors, to identify continuing and emerging risks to assess if the main assumptions remained valid. There is clear evidence that relevant management plans and mitigating measures were fully implemented to address each key project risk and were updated to reflect the latest risk assessment. (all must be true)
- 2: *The project monitored risks every year, as evidenced by an updated risk log. Some updates were made to management plans and mitigation measures.*

Evidence:

During the project implementation period, 3 main risks were identified and properly monitored:

1. Climatic conditions of 2016-2018 adversely affected the efficiency of phytomeliorative measures. The prevailing weather conditions did not allow the natural stratification of seeds to overcome a long rest period, which led to low germination in field conditions, while in laboratory conditions germination rates were 60-65%.
2. The destruction of crops and young shoots of plants by the locust, which is very actively distributed in the foothill areas of the Zaamin district in 2018. With the assistance of local authorities and farms, pickling measures were taken to reduce losses to a minimum. But it should be noted that the risk remains significant due to the infiltration of locusts from other areas.
3. In the project area, there is a manual harvesting of hay fields, cutting down of bushes and trees. Such actions have a very negative impact on the development of desert forage plants. In addition, the project carried out explanatory work among the local population.
