Summary update

1. ONGOING WORK (NDC-SP according final approved Resource Framework):

Product 1: Evaluation of Chile's commitments and strengthening NDC governance

Indicator: 1.1 NDC's operational structure working (Global Output 2.1)

Progress to target during the period Jan-March 2018

- Assistance to the "talkty in La Moneda" with the President Sebastian Piñera and Laurence Tubiana about climate change and a new Climate Change Law and the International seminar "Towards a law of climate change"
- Collaborated in the implementation of a Climate Governance Workshops with the direction of Climate Change office of MMA, and the support of UNDP LEDS GP and AdaptChile ONG, to discuss about attributions, coordination mechanisms, representativeness and the climate local governance with members of the Inter-ministerial Technical Climate Change Team and representatives of Regional Secretaries of Environment. In this activity participated 60 people.
- Began the organization of workshops to involve the Regional Climate Change Committees in the elaboration process of the climate change Law, in the 15 regions of Chile in the coordination of each Regional Secretary of Environment and the regional climate change focal point.
- On August 29th was the first Workshop in La Serena. Participate and coordinate the implementation of all project with support of Climate Change office team.

- It was postponed the publication of the process to 2019, in order to coordinate both initiatives CBIT and NDC-SP.

Indicator: 3.1 Number of recognitions given by HuellaChile Program

Progress to target during the period

- On July, Sebastián Garín becomes as new Coordinator of HuellaChile Program and on June Pablo Zuñiga began as professional of the HuellaChile Program.
- Period of introduction to different HuellaChile processes and parallel activities that were in development.
- Participation of the HuellaChile team in the "Community of Practice on private sector involvement in climate policy processes in Latin America", launched in Chile by the EUROCLIMA+ Programme with the support of the German Cooperation Agency (GIZ), the Secretariat of the Regional Platform LEDS LAC and INCAE Business School. (Cajon del Maipo, 30 to 31 July)
- Presentation of HuellaChile Program at the II Chilean LCA Conference, held in Santiago on August 10th. A contribution to the agenda country in sustainable consumption and production. Organized by the Chilean LCA Network and the University of Talca.

- Participation of the HuellaChile team with a diffusion stand in the XVIII Encounter of Sustainable Development: CHANGE AND OUT: Last call for Adaptation to Climate Change. Organized by "Acción empresas". (August 21st).

- Participation in the 2nd Workshop Transforming Heavy Transport (THT) - Business Action and WBCSD (September 27).
