Revision Justification

The Project has catalysed very important yet highly complex policy and business practice transformative efforts. However, due to the effects of the pandemic and political instability in the country, more time is required to finalise and anchor the results into relevant domestic frameworks and practices. For example, the process of inclusive design of the SDG Framework in BIH as the single domestic strategic framework that nationalises Agenda 2030 has consolidated otherwise divided institutions across government levels. The institutional structures that are to ensure its future coordination, systemic monitoring and implementation need to be trained and equipped for their new roles.

Therefore, the implementation period was extended for an addition 3 months to allow UNDP to finalise all planned activities disrupted and delayed due to the COVID-19 disease outbreak and political complexities in the country. The request does not entail any budget re-allocation or additional new activities. The estimated deadline for completion of all activities in the project is 31 March 2022.
