Wadajir Framework

Jowhar inter-ministerial consultative forum meeting was conducted on **6-10 June 2017**, and District council formation action plan for three months was developed; Set the ToRs of the technical committees and their criteria; and formation and nomination of MoIFAR Task Force for the implementation of Wadajir Framework established. Somali has made significant progress in recent years toward peace, stability and prosperity. With formation of States (FMS) namely Jubaland State, South West State, Galmudug State and Hirshabelle, the relationship between the government and the population was changing, offering new space for coordination and prioritization of governance interventions at district levels.

July 2017 report on Local Governance on Wadajir Framework drafted and submitted. The achievements during reporting time include Jowhar inter-ministerial consultative forum meeting was conducted on 6-10 June; District council formation action plan for three months was developed; Setting the ToRs of the technical committees and their criteria; formation and nomination of MoIFAR Task Force for the implementation of Wadajir Framework

Local Governance on Wadajir Framework: **August monthly report, 2017**. The key achievement of reporting months include MOI Jubaland launched local government law and District council formation process in line with Wadajir National Framework; conducted local governance and service delivery coordination meeting; Community Dialogue conducted; Community contracting guide training implemented; GPLG3 review meeting executed; UNCDF training conducted.

September 2017, the vigorous discussion in many issues namely in relation to, stabilization, local governance and intergovernmental relation, the forum agreed on the following points:

- The forum Acknowledged for what has been achieved on information sharing in the areas
 of Stabilization interventions, formation of Local Councils as well as Reconciliations and
 urged such a collaboration to continue in the feasible future;
- The forum commended Southwest Interior Ministry and local Government for accelerating the introduction of a local Government Law, which Southwest State Assembly adopted recently.
- The forum also urged other; Federal Member States to hasten approval of the local government laws; The forum adopted and set a schedule for the roadmap of Local Council Formation and district permanent administration processes.
- Council formations will commence in thirteen out of twenty-six priority districts across the states within 90 days;
- The forum agreed on the establishment of a unified center for monitoring and evaluation of Wadajir framework activities implementation called Wadajir M&E platform;
- The forum accepted to expand its membership and extended it to other relevant institutions which maintain close working relations with the Forum;
- The forum consolidated areas of Stabilization, Intergovernmental Relations and Local Governance initiatives into its umbrella and mandates; and

 The forum is committed and agreed to speed up the current ongoing review of the National Stabilization Strategy to build on lessons learnt amongst stabilization stakeholders.

October 2017, Meeting outputs are as follows: The Council praised the activities of the forum, the stabilization of the districts, the establishment of local councils, the reconciliation and strengthening of the co-operation between the states and the federal government; The Council reviewed and agreed on the timetable for the process of the roadmap process and the resettlement resolutions that will be initiated in the pre-eminent districts that are available to the local councils in Jubaland, South west, Galmudug and Hirshabelle; The House commends the formation of the local council in the district and other efforts to establish the resolutions of other local councils in the south-western state; The Council urges the Jubaland and South-west state to start the preparation of the district council formation; The Council encourages the Governments of Galmudug and Hirshabelle to accelerate the completion of the local governments; The Council has agreed to issue a quota for women in the district council seats to be competed solely for women; The Council proposes to accelerate social and economic advances in order to promote sustainable peace and stability; The Council welcomes the cooperation between the different roles of government and industry JPLG a 3rd phase of the program and JPLG agencies to tap into the terms agreed; The Council proposes to hold a technical conference to determine the importance and needs of the next year's 2018-2019 and a workshop for reviewing duties and responsibilities between the Ministries of the federal and state; The council agreed to establish a Unified Monitoring and Evaluation Coordination Unit; The Council agreed that each state should be formed from a joint venture; The Council agreed on the priorities of the stabilization strategy in the draft and demanded that it be completed as soon as possible; To unite and coordinate priorities and needs of federal and state governments and to support donors' support; The Delegation sent a message to the partners that participated in the Wadajir Constituent Assembly on stabilization, local governments and reconciliation to demonstrate a comprehensive, coherent and coherent framework of co-operation and government policy on issues mentioned above.

Wadajir Inter-Ministerial Consultative Forum Meeting conducted **November 13, 2017** in Mogadishu. The Inter-ministerial consultative forum (Wadajir) is delighted to complete successful its consultative meeting to set a clear schedule for establishing local council formation and permanent district administration processes and to discuss the achievements from the last Wadajir meeting held in Jowhar and the 90 days pre-and post-council formation process.

The consultative gathering was one of its kind and 8th one for the forum to hold in Mogadishu between **11-13 November 2017.** The Ministry of Interiors, Federal Affairs and Reconciliation expresses gratitude to the heads of states for their role and participation in this consultative meeting: Jubaland, Southwest, Galmudug, Hirshabelle and Banadir Regional Administration. The council also praised the attendance of all the various federal and provincial governments in the role played by the effective outcome of IMC.

The Ministry of Interior, Federal Affairs and Reconciliation (MOIFAR) planned a three day quarterly Inter-Ministerial Consultative Forum (IMCF) Meeting to be held in Mogadishu City between 11-13 of Nov. 2017. The Meeting intends to bring together 40 participants from Federal MOIFAR, FMS MOIs and Reconciliation Ministries as well as Banadir Regional Administration. The overall objective of the IMCF meeting is to build on the accomplishment of the previous meeting and produce more tangible and concrete agreed action plans and priorities related to stabilization, local governments and reconciliation activities across the nation. In addition, the Consultative Forum will discuss the ways in which the existing donor resources can be linked to government priority programs/projects, mobilize resource for these priority programs, and overcome with the issue of regional imbalances or disparities pertaining in donor resources. It's expected that the outcome of the meeting will contribute to both formation of local councils, peace building work as well as local, national and international stabilization efforts in the following significant ways: enhanced coordination and effectiveness in the deepening of stability, peace and establishment of effective local governance across the Somalia.

It was reported that SFF has agreed with FCA to move out of Galmudug State, thus FCA will now focus only in SWS and Jubaland States while SFF will work in Galmudug.
- ✓ Coordination of Stabilization actors at FGS, FMS, Districts levels: MOIFAR Stabilization team to take a lead in establishing a coordination platform whereby the government will be in position to identify the roles of the stabilization actors.

The reconciliation process ended with both conflicting parts agreements to preserve peace in a ceremony held at Hotel in Mogadishu. Mr. Osman mentioned that SOYDEN played facilitator role as well as offered logistical supports.

Final DBPS lists for Hudur, Warshikh, Adelle and Barawe UNDP/S2S Project team asked SOYDEN director why it does not submit the final DBPS lists for Hudur. Warshikh. Adelle, and Barawe..., understanding the implementation second project delivery (Provision of the Community Reconciliation based on social under QN/TICE based approach foster renewed trust, social cohesion and reconciliation) highly depend upon?

Mr. Osman said that combination of factors delayed the final submission of DPSC lists. In general, it happened on causes of wider community participation in DPSC discussions during the Validation workshop on the essence of the committee and what it stands for in roles and responsibilities, the community asked a fundamental change in regards to DPSC members and an increase in number. They said these additional numbers would allow the inclusion of segregated community members like minority groups, women and youth. In particular, Barawe community politicalized the qualification of DPSC membership. They claimed that the traditional settlers of Barawe town are misrepresented in DPSC members, they only got seven members in total, while others got share disproportional to numbers. The last, not least, the SWA/MoI concern on MoIFA/SOYDEN project discouraged SOYDEN to go on willingly.

Mr. Osman told us that despite all efforts to reach as well as convince SWA/MoI, it ended in vain. He also mentioned that on accounts of the limited time SOYDEN has to finish the job, he approached to SWA President, Mr. Sharif Hassan. I explained everything to the president, and the president in return gave me positive response/gesture that hopefully will eventually finalize the issues once for all.

Prologue: Philip Cooper, UNDP/S2S Project Manager opened the meeting, and the meeting participants' introduction followed. He, then, allowed participants to agree on meeting agenda:

Reflection on 3rd party Monitoring Agency:

Mr. Abdi Karin, 3rd party monitoring agency representatives in the meeting started his saying flashing back on the identified weak points in earlier field missions starting on February 2016 to monitor on existed financial management system in selected four district: War sheik, Hudur, Barawe and Jalaqsi (Bulo-Burde) and remarkable improvements made by district authorities thereafter within six months' periods of time as July 2016 report from 3rd Party Monitoring agency's second round on Warshikh and Hudur highlighted.

Mr. Abdi Karin stated that earlier report showed the lack of financial management system at all at district level. The only verifiable points in effect of earlier field monitoring mission was that the allocated money reached the destination through Hawalat transaction (specified Dahabshil accounts).

Both MoIFA and UNDP S2S Project Teams acknowledged 3rd party Monitoring Agency's assertions on existed gaps which sometimes recorded up to eight deficiencies in financial Management system at district level, and also the remedy efforts that made the recorded 8 deficiencies into less than one, though, MoIFA/S2S Project Team different views on some issues (see MoIFA/S2S Project Team's concerns).

MoIFA/S2S Project Office Concerns:

Even though the MoIFA/S2S Project Team is in agreement principally for what 3rd party monitoring agency is doing and stand for in PBF, yet again they cast some doubts on 3rd party report contextually in general and genius in its recommendation in terms of practicality points of views. MoIFA/S2S Project Team, though not explicitly, accuses on 3rd party failure to incorporate with local realities, and vague recommendations hard to materialize practically at district level.

3rd Party Monitoring Agency answering MoIFA/S2S Team's allegation stressing on making recommendations from their findings first is part of its ToR, and the impetus behind it is that of setting visions for ultimate goals for financial management system.

Agreeing on what 3rd monitoring agency said on recommendation, UNDP/S2S Project team said that

3. Design reporting format capable to absorb other stake holder contribution beside 3rd part.

Conclusion: Despite tough discussions on some meeting agenda, yet again, all meeting participants expressed their good intentions and showed sign of confidence for future collaboration toward each. Mr. Ramadan from MoIFA/S2S Project Coordinator said that in his conclusion remarks that:

- MoIFA/S2S is open to 3rd party's monitoring processes
- MoIFA/S2S is working on MoF improved roles and responsibilities in S2S Project
