The aim of this global programme is to provide policy and programme support for effective implementation and monitoring and reporting on Goal 16. The project supports policy analysis and mainstreaming of SDG 16 (research and technical guidance); measurement and monitoring of SDG 16 indicators including developing measurement standards and tools (Praia Group and the SDG 16 survey); and strengthening multi-stakeholder partnerships (Global Alliance) on SDG 16.

The program is being extended on a no-cost basis through to December 31, 2022 to enable completion of activities under the UK FCDO SDG 16 funding.
