QUESTION 1: How Does the Project Integrate the Programming Principles in Order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the project mainstreams the human rights-based approach

El objetivo principal del proyecto es el de *prevenir y transformar la violencia de exclusión a la que se enfrentan las personas jóvenes en los municipios de La Libertad, Tamanique y Chiltiupán, a través de la promoción de espacios cívicos inclusivos, seguros y significativos dónde las personas jóvenes participan en la toma de decisiones, igualdad de género y empleo decente por la paz.*

Este objetivo implica que los espacios cívicos de diálogo y de toma de decisiones sean compartidos con las personas jóvenes, con prioridad a las y los jóvenes en situación de vulnerabilidad como pueden ser jóvenes rurales, jóvenes mujeres, jóvenes madres y jóvenes retornados para que puedan hacer valer su potencial como agentes de paz. Se busca que estas personas jóvenes puedan liderar y co-crear acciones e iniciativas a favor de una cultura de paz y convivencia reconociendo el impacto del turismo en las dinámicas sociales y ambientales propiciadas por los proyectos, como el de "Surf City". Al tiempo, las comunidades se involucran en las actividades de paz y reconocen el papel fundamental de la igualdad de género y del rol positivo de las juventudes para la construcción de paz.

El proyecto tiene un enfoque de derechos humanos esta alineado a la Resolución del Consejo de Seguridad de las Naciones Unidas (RCSNU) sobre Juventud, Paz y Seguridad (RCSNU 2250), *El elemento que falta para la paz* (Graeme, 2018), dichas barreras estructurales conllevan a la "violencia de la exclusión" que deberá de ser transformada a través de la inclusión significativa. Esto implica una mirada más integradora e integral de la participación significativa de las juventudes en los espacios cívicos, de la igualdad de género, del papel de la educación por la paz y de empleos y trabajo decentes por la paz y la cohesión social.

Briefly describe in the space below how the project is likely to improve gender equality and women's empowerment

El proyecto reconoce el rol de agentes de cambio que las mujeres jóvenes desarrollan en sus comunidades, por lo que las visibiliza y empodera. Por ende, a través de sus resultados se busca transversalizar las cuestiones de género y de empoderamiento de las mujeres jóvenes asegurando un enfoque equitativo y transformativo. También tiene un enfoque que directamente favorece la igualdad de género, participación y empoderamiento de las mujeres jóvenes.

De esta forma, el proyecto contribuirá a deconstruir normas y patrones culturales que toleran y promueven la discriminación contra las mujeres, en especial las jóvenes y adolescentes, que naturalizan la violencia, incluida la violencia de género. Se trabajará en el empoderamiento, autonomía corporal y autonomía

económica de las mujeres jóvenes, así como en el desarrollo de sus habilidades de liderazgo y construcción de paz, y su participación en organizaciones locales y organizaciones juveniles comunitarias.

Briefly describe in the space below how the project mainstreams sustainability and resilience

La zona donde se implementará el proyecto sufre los riesgos medioambientales. Entre los principales desafíos mencionados por la población local está el tema de los desechos y basura, así como un problema de acceso y calidad del agua. Si bien estos municipios tienen excelentes olas, reconocidas a nivel mundial, mucha población queda afectada y es desplazada por los diversos oleajes que afectan a la población y los negocios más cercanos a la costa. Si bien, el principal enfoque del proyecto no es medioambiental, si será uno de los ejes con los que se prevé formar espacios cívicos, donde los jóvenes locales puedan ser agentes de cambio e incidencia en las políticas locales medio ambientales.

Briefly describe in the space below how the project strengthens accountability to stakeholders

El Proyecto contempla dos espacios de gobernanza: el Comité Ejecutivo conformado por los representantes de las agencias del SNU a cargo de la implementación del proyecto, así como por los titulares de las instituciones de gobierno, organizaciones de sociedad civil implementadores, gobiernos municipales que son socios estratégicos del proyecto, así como juventudes locales. Este es el espacio donde se efectúa la conducción estratégica, así como el monitoreo y rendición de cuentas periódico, con relación a la implementación de la presente iniciativa. Por otro lado, el proyecto contempla un espacio de conducción operativa técnica, el cual tiene a su cargo la elaboración y seguimiento de los planes operativos anuales y otros aspectos administrativos y de ejecución presupuestaria.

Adicionalmente, a lo largo del proyecto se establecerán mecanismos de monitoreo para conocer si los resultados del proyecto efectivamente están generando el impacto y los cambios tanto culturales como en las prácticas institucionales y en la percepción de la población que se han fijado en el proyecto. Esto, se realizará a través de varios métodos, entre los que destaca el levantamiento de una línea de base inicial que permitirá identificar las condiciones en las que inicia la implementación del proyecto y compararla con un nuevo levantamiento de la información al finalizar el proyecto.

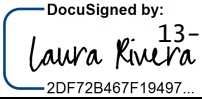
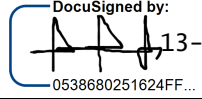
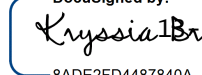
