<p>The project directly contributes to the mission of UNDP Albania to help the fight against crime, violence and discrimination, promotion and enforcement of human rights. UNDP in Albania works with the government and people of Albania, to strengthen the rule of law, promote human rights and freedoms, protect the environment and support economic and social reforms for social inclusion and an equitable society. Hence, the design and implementation of the project is in line with UN Conventions and international human rights norms and standards.</p> <p>Together with other UN agencies, UNDP adopted in 2003 the UN Statement of Common Understanding on Human Rights-Based Approaches to Development Cooperation and Programming. A consistent Human Rights-Based Approach is applied by UNDP during its programming processes at global and regional levels, and especially at the country level, in relation to the CCA and UNDAF. This is also mainstreamed in all programmes and projects implemented by UNDP Albania.</p> <p>Albania adheres to international its human rights commitments, this includes normative reporting (CCR UN TIP Protocol, CPRMW) CEDAW, Istanbul Convention, CRPD and contribution to periodic reviews, national tracking mechanisms, integration of recommendations in the NSDI and sectoral plans and effective ongoing dialogue to change practice. State institutions raise awareness of duty bearers and rights holders, and duty bearers channel concerns, particularly in relation to women, girls and boys, supporting accountability of duty bearers and resolution to cases. Duty bearers and rights holders, pursue policy and its implementation in practice to prevent and address violence against women, children, migrants and marginalized groups; advocating for behavioural change and promoting social cohesion.</p>
Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment
<p>The fulfilment of women's and men's civil, cultural, economic, political and social rights is central to the UNDP human development framework and is vital to achieving sustainable development. UNDP prioritizes gender mainstreaming as the main strategy to achieve gender equality. The UNDP approach to gender mainstreaming is a dual one:</p>

<p>UNDP supports the empowerment of women and girls through gender-specific targeted interventions and also addresses gender concerns in the developing, planning, implementing and evaluating of all policies and programmes.</p> <p>Beneficiaries of this project will be young women and men in selected areas of municipalities of Shkoder, Dibra, and Kukes¹. Participants in the activities will be chosen according to gender balance principles, and monitoring of activities will rigorously produce gender disaggregated analysis of results. However, young women will be particularly encouraged to apply. The project targets to have per each of the measures implemented 60% to 65% of women among the beneficiaries.</p>
