Human Rights-Based Approach (HRBA) is an underlying principle in the project's goals and objectives. HRBA will be mainstreamed through ensuring availability, improving quality, and access to resources created by the project. The project prioritizes informed participation of project stakeholders and beneficiaries, including vulnerable groups at the local level, in needs assessment, design and implementation of project activities and outputs.

##### *Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment*

The Project will mainstream gender equality dimension through 1) ensuring women's participation equally with men and women's access to resources, knowledge and capacity development as will be made available through the project activities. At the same time the project will 2) watch to preclude any adverse impact of project activities on women and men. The Project will also 3) possibly apply gender-sensitive and gender responsive approaches through the design of project's products, including those on public policy.

##### *Briefly describe in the space below how the Project mainstreams environmental sustainability*

The Project will mainstream environmental sustainability by applying innovative mechanisms and tools to the promotion of sustainable practices. More specifically the Project will couple behavioral insights with innovative financial mechanisms to accelerate the installation of solar photovoltaic panels and solar heaters in non-gasified vulnerable communities. This intervention will drastically reduce energy poverty and the environmental impact of logging, freeing up more community and family resources to the pursuit of economic gains, as well as improving in-door air quality by eliminating use of dung. The Project also envisages behavioral experiments to reduce resource consumption (i.e. responsible consumption of drinking water). Overall, the Project will contribute to poverty reduction, more fair distribution of social benefits and applying environmentally-friendly principles in line with the priorities of the Government of Armenia reflected in 2030 Agenda for Sustainable Development, Armenia Development Strategy 2030 and other documents.






