The project fully embraces human rights through increasing access to inclusive vocational programs to children and youth with disabilities tailored to their developmental needs. The major outcome of the project will result in the creation of a VET Center accessible for people with disabilities and ensure its responsiveness to the labor market needs. Teachers and instructors recruited for this project will be equipped with knowledge and skills to teach the youth with disabilities together with the youth without disabilities. The project will contribute to the Sustainable Development Goal 4. “Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all; Target 4.5 “By 2030, eliminate gender disparities in education and ensure equal access to all levels of education and vocational training for the vulnerable, including persons with disabilities, indigenous peoples and children in vulnerable situations”.

Gender balance will be a primary consideration in the project. One of the methodological principles underpinning this intervention is to resist common gender stereotypes related to education and labor existing in the country. The project aims to focus on individual dreams, interests and abilities of the beneficiaries who will get full support from the project to discover and realize their potential and self-fulfillment. Awareness raising about gender equality and balance among trainers and beneficiaries will be a key aspect of the trainings.

*Briefly describe in the space below how the Project mainstreams environmental sustainability*


All the project activities will be implemented in an environmentally friendly manner. Taking into consideration that the beneficiaries will make arts and crafts out of natural resources such as wood and silk, during training sessions special attention will be given to the topic of HSE requirements and responsibilities expected from the beneficiaries as well as project staff. In order to avoid negative effects on the natural resources all Action activities will be implemented in accordance with laws and regulations on protection of environment in Azerbaijan. HSE guidelines will be presented and discussed during the training sessions to both trainers and the students.
