QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

The project focuses on supporting inclusive and participatory approaches to recovery planning and implementation as well as preparedness. In particular, construction and repair of homes and public buildings focuses on reducing climate-related vulnerabilities and creating a platform for greater, non-discriminatory access to safe housing for the most vulnerable. Similarly, the project will not only provide immediate short-term financial support to individuals with the greatest need, but livelihood activities will target those who are most vulnerable to climate change impacts and aim to equip them with the skills and tools necessary to support their access to sustainable livelihood opportunities. The project also focuses on the responsibility of the state as duty-bearers to facilitate ongoing resilience building in each country through the creation of national frameworks dedicated to providing longer-term climate resilience support for the most marginalized.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

Given the disproportionately negative impacts of disasters on women, particularly as it relates to their ability to earn income and support their households, the project will create a gender responsive livelihoods programme that explicitly responds to women's immediate needs and supports the creation of sustainable livelihoods for women. Additionally, the project will attempt to increase women's active participation in national decision-making and governance to catalyse the creation of gender-responsive national plans for climate change adaptation and disaster risk reduction. As such, not only will women will be direct beneficiaries of project interventions in the short-term, but the project will support greater women's inclusion and representation of women's rights in long-term climate-related decisions.

Briefly describe in the space below how the Project mainstreams environmental sustainability

The project will embed environmental sustainability into all of its plans, particularly those related to livelihoods and infrastructural development. On the former, livelihood activities will be developed with a focus on improving or creating opportunities for individuals to engage in work that minimizes adverse environmental impacts. These include providing training and equipment that emphasizes climate smart agricultural practices as well as facilitating access to micro-finance that prioritizes investments in sustainable agriculture and environmentally sustainable business practices in sectors such as tourism. Building back better initiatives will also promote environmental sustainability by adhering to international sustainability and environmental standards related to debris and waste management and design and construction of new houses, among others.
