The project will support the Royal Government of Bhutan to achieve transformational change by using NDC implementation as a mechanism to scale up investments in inclusive, gender-responsive climate actions that help achieve NDC targets and, through this, deliver on the Paris Agreement and the SDGs. GHG reduction in sectors of Industry, transport, waste, will be prioritized thereby ensuring clean air , reduced noise and waste pollution, clean water and clean environment , a basic right for all living beings.

The project at large will contribute to the achievement of Bhutan’s development philosophy of Gross National Happiness, in particular the pillar of environment conservation and sustainability. Bhutan’s has prioritized three SDG for the 12Five Year Plan (2018-2022) and this project will directly impact the SDG – Goal 13. Climate Action and Goal 5 gender equality

Briefly describe in the space below how the Project is likely to improve gender equality and women’s empowerment

The project features a strong gender dimension. An in-depth gender analysis will be conducted to understand gender context of NDC implementation NDC will be used as a tool for scaling up public and private investments and through this effort recognises that the empowerment of women is integral to its success.

Gender and climate change will be better integrated into sectoral strategies, programmes, and budgets, and fragmented policies addressed. Institutional coordination structures for NDC implementation will be strengthened and gender responsive recommendation introduced. The national climate change policy will also be reviewed through a gender lens and made to become gender sensitive. Key government agencies including women and youth groups will be capacitated to improve gender and climate change mainstreaming and measurements of results

Briefly describe in the space below how the Project mainstreams environmental sustainability

NDCs reflect a country’s ambition for reducing greenhouse gas (GHG) emissions, considering domestic circumstances and capabilities, and the majority have also included adaptation goals. Under the provisions of the Paris Agreement, countries are expected to submit updated and more ambitious NDCs every five years. Bhutan’s NDC, therefore, will become the main vision by which national, subnational and sectoral climate change policies and actions are aligned with national development priorities and the Sustainable Development Goals (SDGs).

The RGoB already committed in 2009 to remaining carbon-neutral by ensuring that its forests sequester more carbon than is emitted through other actions (RGoB, 2009). This commitment was reiterated in 2015 in Bhutan’s INDC (now an NDC after being ratified by the Parliament in 2017) and is also reflected in the 11th and 12th Five Year Plans.

Bhutan’s NDC reiterates the RGoB’s commitment to remain carbon neutral and maintain current levels of forest cover. A number of strategies, plans and actions are also outlined for low-emission sustainable development in the sectors of: sustainable forest management and protection of bio-diversity, transport, waste management, industry, energy, agriculture, and human settlements
