#### QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

*Briefly describe in the space below how the Project mainstreams the human-rights based approach*

Water and wastewater management as well as the promotion of green infrastructure have a significant impact on the realization of human rights, including on the human rights to water and sanitation, the rights to health, food, a healthy environment, and others. While the human rights framework demands that ensuring access to sanitation must remain a priority, efforts need to go beyond ensuring access to basic sanitation, in particular in countries that have already achieved (almost) universal coverage, but lack adequate wastewater management. Human rights principles and standards provide a framework for a phased approach of progressive, sustainable improvements in managing wastewater and controlling pollution. Lack of regulation, control and accountability in the process of emptying, collection and transportation of sewage, septage or sludge often results in non-environmental and unhealthy practices. The understanding of wastewater as a resource can be an effective incentive for improved wastewater management, but strict regulation is required to prevent health risks. The Turkish Cypriot community must put in place strong regulators, as well as develop the capacity to oversee and coordinate the sectors. Participation by all concerned communities and stakeholders in decision-making on wastewater management and green infrastructure development shall be promoted. *Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment*

In line with EU and United Nations gender mainstreaming policies, UNDP is to pay particular attention to enable the full participation of Turkish Cypriot women in the construction, implementation and operational phases of the projects as users, beneficiaries, construction and maintenance workers, advisors, managers and political or community decision-makers.

Attention will be given to ensure that, to the extent possible, project committees, management and monitoring arrangements are gender responsive and that gender balance is addressed in their own structures, decision-making processes and selection processes.

During this first phase of the project, attention will be given to mapping gender equality in stakeholders' decision-making bodies and professional categories involved. The mapping exercise will be followed by capacity-building on-the-job trainings and activities aimed at encouraging Turkish Cypriot women's participation in the design and implementation of large infrastructure projects. It is expected that this will contribute to support and promote women role models in positions such as supervisors, contractors, workers etc.

The project involves preparations of master plans for the water, wastewater and drainage for the northern part of Cyprus and as part of the elaboration of the master plans Environmental reviews will be carried out. Based on the outputs and recommendations of the master plans public participatory Environmental Impact Assessments will be carried out.

Projects that will involve infrastructure constructions and excavations specifications will require the contractors to mitigate any environmental hazards that may arise during the works.



