#### QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

##### *Briefly describe in the space below how the Project mainstreams the human-rights based approach*

This Project funded by the UN Peacebuilding Fund has been developed to promote national level institutional coherence, and ground level inter and intra community interaction around a number of issues which have and will pose a challenge to peacebuilding in Sri Lanka, and as part of the overall process, does promote the protection of human rights. It also works through the broader framework of the Peacebuilding Priority Plan which focuses on transitional justice, reconciliation, and good governance. The Project aims to overall support key commitments made by the Government of Sri Lanka to strengthen accountability and human rights further to the report of the comprehensive investigation on Sri Lanka by the Office of the High Commissioner for Human Rights (A/HRC/30/61) as well as the adoption of the Human Rights Council Resolution entitled “Promoting reconciliation, accountability and human rights in Sri Lanka” co-sponsored by Sri Lanka (A/HRC/30/1) in October 2015.

Therefore, this Project mainstreams the human-rights based approach by for example;

- Planning to ensure citizens engagement in implementation and monitoring of the Project
- Developing the capacities of **‘duty-bearers’** to be conflict sensitive in the delivery of its services/when meeting their obligations and/or of **‘rights-holders’** (i.e. communities and victim groups) to claim their rights.
- Strengthening the engagement of civil society to play an advocacy role, which also seeks to empower local communities to address community level issues through dialogue and overall be more resilient.
- Ensuring sound technical advisory support is provided for policy/legal framework formulation in keeping with the international human rights/legal standards and good practices
- Assessing the needs of the people in providing support, and ensuring due conflict analyses is undertaken to ensure the Project does no harm in providing support.

##### *Briefly describe in the space below how the Project is likely to improve gender equality and women’s empowerment*

The Programme will for example

- Undertake a gender analysis for each component of work, to strengthen its understanding of the gender dynamics and also ways to strengthen its gender equality and women's empowerment programming.
- Strengthen civil society engagement to empower women and young people to engage in dialogue initiatives
- Support policy level initiatives to draw attention to the need to implement key policy decisions which will empower women (i.e. the key considerations to be made when designing peacebuilding initiatives and decision making) and strengthen their engagement in peacebuilding processes
- Ensure that planning for the provision of services, and systems development takes into account gender considerations and accordingly incorporates required strategies to provide a gender responsive service.
- Ensure monitoring of Project progress documents gender disaggregated data, and will analyze the impact of results through a gender lens.

The Project aims to ensure;

- That its communications, advocacy and visibility strategy/products are developed ensuring minimal damage to the environment.
- As part of its Project management process, the use of resources (i.e. paper, stationary and other consumables) are used efficiently in order to minimize wastage
- Through its policy advisory support components, alignment with the Sustainable Development Agenda, and advice on ways to strengthen policy decisions on transitional justice taking into account key elements of environment sustainability (i.e. ensure the transitional justice mechanisms in the set-up of its mechanisms takes into account required environmental safe-guards)
- Monitor through its downstream work including through civil society, any negative/positive impacts created on the environment. This would include encouraging/supporting/requiring civil society to adopt environmentally friendly practices/tools as part of advocacy efforts and in undertaking their activities (i.e. not using plastic for candle light vigils etc.)
- Link dialogue efforts to early warning systems/mechanisms that have been built around response to natural disasters, thereby also drawing linkages to the new triggers of conflict (i.e. around depleting natural resources, access to natural resources, politicization of access to resources etc.)
