The project mainstreams the Human rights-based approach in all stages of the Project cycle, since formulation, implementation, monitoring to closure. To ensure that this is applied, the methodology to be used will ensure a participatory approach, regular consultations with key stakeholders, inclusiveness and active participation of vulnerable and minority groups and gender awareness. Access to information will also be taken into consideration by ensuring that the media is capacitated on specialized reporting and the duty bearers have the necessary conditions to produce and disseminate information. 2 specific project outcome's formulation translate the vision and goal of the Project which is increased inclusiveness and participation in the political and development process.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

To ensure gender-sensitivity, the project will adopt several strategies specific to the context of Mozambique. Gender aspects will be addressed and mainstreamed throughout data collection (*Analysis of the root causes of low participation of women and youth in elections (voter registration, voting and candidacy)*), planning, implementation and reporting, and special attention will be given to enhance the rights of women. A specific component of the Project aims at increasing the participation of women in political life of Mozambique in general and in electoral processes, in particular. In each training session, the project will ensure that data reflects disaggregation by sex. To ensure that gender aspects are taken into account throughout project implementation, a Gender specialist will be recruited during the first year of project implementation to advise and produce dedicated tools to meet such objective.
