#### QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

##### **Briefly describe in the space below how the Project mainstreams the human-rights based approach**

The HRBA is at the core of the project, which has been designed to support the State of Palestine to meet its obligations under the human rights treaties and conventions it ratified in 2014, and right holders (in particular disadvantaged groups) to demand and advocate the exercise of their rights.

Specific areas of engagement include: integrating an HRBA in the planning and budgeting processes of the Palestinian government; working with drafters, lawmakers and civil society actors to harmonize national laws with international human rights treaties, and integrating an HRBA to ensuring that justice and security services are delivered in an inclusive manner that respects, protects and fulfils human rights. This includes working with different institutions and stakeholders (such as the police, public prosecution and the judiciary) in strengthening its internal capacity to mainstream human rights principles and standards throughout its work, as well as with civil society to strengthen their capacity to effectively monitor the performance of justice and security institutions in meeting their obligations as duty bearers. It also includes ensuring equal access to competent services for rightsholders, including the protection of the rights of Palestinian citizens under Israeli jurisdiction.

##### **Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment**

The project has SDG 16 and SDG 5 at its core. Overall, this joint UNDP/UN Women/UNICEF project aims to support an inclusive Rule of Law system that respects, protects and fulfils human rights and gender equality, and promotes peace and security. This implies that significant efforts are put into ensuring that justice and security services better respond to the needs of women and girls in particular. This is done through working at the level of policy/legislative frameworks, specialization of services delivery, reducing barriers to access services such as legal aid, enhancing legal literacy and mainstreaming gender and promoting leadership within institutions. The project has developed a gender strategy that sets out a gender transformative approach to redress entrenched gender inequality in terms of access to services, information, decision making power and resources. This is done through a) identifying and addressing underlying factors and root causes of discrimination against women in the law and in practice; b) changing attitudes and behaviors of strategically placed individuals in institutions ('champions'); c) encouraging and creating opportunities for individuals to actively challenge gender norms; and d)

promoting women's positions and influence within institutions and supporting them to reflect on their experiences in transforming institutions. Whilst a specific outcome (4) in the project is dedicated to enhancing access to justice for women, gender considerations are mainstreamed throughout all outcomes and thematic areas (such as planning, accountability and anticorruption, civil society advocacy and legal reform) covered by the project, including its M&E framework:
