The project shall take all the appropriate measures to ensure that the actions funded are inclusive, non-discriminatory, and provide full ownership to the beneficiaries.

Acknowledging the fact that sustainable results cannot be achieved without responding to the differentiated impact that the illegal possession, misuse and trafficking of small arms and light weapons has on women and men, the project shall place a strong emphasis on supporting gender initiatives and ensure gender mainstreaming in all the funded actions. Proposed actions shall be evaluated based on their ability to integrate the gender perspective into their activities and will be required to allocate approximatively 15% of the budget to gender-specific interventions. Funded actions may include actions that enable Governments to collect sex-disaggregated data and make informed gender-sensitive decisions, actions that support gender mainstreaming in the Police and the military, actions that tackle firearm-related domestic violence, etc.

Where relevant, proposed actions shall be evaluated based on the environmental impact they have.
