#### **QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?**

##### **Briefly describe in the space below how the Project mainstreams the human-rights based approach**

The project aims to protect human rights, especially for persons with disabilities. Although the Government of Turkmenistan demonstrates its commitment to advancing human rights of PWDs through development of new more inclusive policies and models, there is profound disconnect between disability legislations, initiatives and everyday reality experienced by PWDs in Turkmenistan. Employers are generally unwilling to hire PWDs, because they perceive them as unqualified and inadequate. The changes are slow and PWDs are facing enormous challenges to access quality vocational training and meaningful jobs and deteriorating specialized/sheltered and subsidized enterprises continue to be the almost only available employment option for PWDs in Turkmenistan.

In this regard, UNDP, DBST, CFPA and Chinese experts on PWDs would like to engage in joint cooperation for creating new job training, employment and income-generation opportunities for deaf and blind people in Turkmenistan. This is in line with the Partnership Framework for Development signed by the United Nations and the Government of Turkmenistan for 2016-2020 and the Country Programme Action Plan for 2016-2020 signed between UNDP and the Government of Turkmenistan which identify that the country's economic growth must create more inclusive and high quality jobs for those who are unemployed or underemployed, and contributes towards achievement of the respective outcome "Strategies and simplified regulations are in place to promote high quality inclusive employment through sustainable economic diversification".

##### **Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment**

The project will take special account of gender equality issues. The project will support BDST to improve knowledge of its staff and members regarding disability, organizational development, gender equality, effective management, evaluation and planning, outreach programs. Taking into account the gender policy of Turkmenistan, as well as the priorities of UNDP and the 25th anniversary of the Beijing Declaration and Platform for Action, adopted By The Fourth World Conference on Women in September 1995, particular attention will be paid to the training and employment of women with disabilities in the framework of this project. The project will also produce necessary training

materials for BDST 3 enterprises, manuals for training and maintenance of the equipment.

**Briefly describe in the space below how the Project mainstreams environmental sustainability**

The project aims to increase employment and income-generation among the people with disabilities in Turkmenistan through vocational training and creating new job opportunities. This project will focus on modernization of business operation of three social enterprises under the Blind and Deaf Society of Turkmenistan (DBST) in Ashgabat, Turkmenabat and Mary cities, on development of the organizational capacities of DBST to better support its members, as well as on awareness and capacity development of other respective stakeholders such as vocational institutions, private sector representatives and policy-makers. The project will implement the above through peer-learning and knowledge exchange between DBST and similar organizations of people with disabilities in China, as well as engage Chinese experts and producers. The environmental standards will be considered both at the design and implementation stage of the project. The project will not have harmful environmental impact.
