Particular attention is paid to minority groups where every effort will be made to make educational materials easily accessible in local languages.

Gender equality, women empowerment, youth and people with disabilities are cross-cutting issues of the project strategy. The project supports improving participation of these groups in the political life by developing strategies on increasing the number of women, young people and people with disabilities as candidates and voters.
