QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

The project will facilitate the human rights-based and human security approaches focusing on people including the most vulnerable groups like women, youth, and migrants. It will facilitate top-down protection and bottom up empowerment mechanisms and participatory mechanism thus ensuring engaging local people into the change process and changing mindsets of local communities in improving their livelihoods and adaptation to changing both economic and climate environments. In its activities the project will consider the needs and priorities of local people in order to consider both the local needs but at the same time making the job green through active engagement of the direct beneficiaries.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

Through jobs creation, the project will focus on creating employment opportunities for women, youth and returned migrants, based on evidence of increased vulnerability due to the crisis. Women, returned migrants and youth are mostly engaged in informal sectors of economy, harder hit by the crisis. In addition to restrictions imposed by the lockdowns and the limited number of people allowed to perform agricultural works, with many migrants unable to leave the country, women have lost comparative advantage and are being squeezed out by the stay-home male migrants in this sector. Therefore, the project will promote women's participation in decision-making at local level, promote their entry in green production and manufacturing processes, development of women's entrepreneurship with the focus on "green" business. Through implementation of social infrastructure projects, better opportunities will be created for women by providing access to household drinking water, improved healthcare services and sanitation, etc. Better conditions will be provided through access to digital services and facilities so they have better opportunities in getting education, qualified jobs and development opportunities.

Briefly describe in the space below how the Project mainstreams environmental sustainability

As the project promotes integration of green and environment friendly green technologies, the proposed business projects and innovative solutions will not affect the ecosystems and environment. The project will make impact assessment of the propose projects pilot prior to starting the implementation of business initiatives and pilots. Engineer will be hired who will verify with special responsible government entities that protective social and environmental measures are ensured during the rehabilitation or construction works.
