The project will promote gender equality and women’s empowerment by collaborating and partnering with Women’s organisations. The project will highlight the crucial roles women have in their communities with respect to environmental protection and reduction of plastic pollution. The jury will be composed by at least 50% of women members. Clear instructions will be produced and disseminated by the project team to the jury to ensure that the selected solutions do not discriminate women or reproduce gender inequalities and promote women empowerment. Further, the project acknowledges a recent report (2019) looking at the critical role of women in the plastic value chain. As such, the project will ensure that the identified and selected solutions do not jeopardize the livelihoods of women.

The project will mainstream environmental sustainability of new and existing organisations which are committed to reduce plastic pollution. As such, it will deliver training to the identified solutions by EPPIC to ensure that they can have a long-lasting impact in the competition sites (4 sites over two years). Furthermore, the project will work in close cooperation with the local and national government to mainstream the issue of plastic pollution in the sustainability agenda. Finally, it will design and deliver local and national awareness campaigns with the objectives of changing consumers behaviours; ultimately encouraging citizens, business and governments to move towards a circular economy.
