The UN works within complex dynamics reflecting competing interests of political actors and member states, limitations of responding to the scale of needs, a society under pressure and trauma, and security and access constraints. The UN maintains its operational integrity through adherence to principles of impartiality, human rights and inclusive humanitarian/civilian assistance/development and engages stakeholders clearly communicating these principles.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The Project has been allocated Gender Marker 2, implying that significant Outputs and Activities will be specifically aimed to improve gender equality and women's empowerment. The project will aim to achieve this in several ways. Firstly, specific activities will be implemented to raise the number of female representatives in local authorities, both at the Governate and District level. Secondly, project activities aimed at the collaboration between local authorities and communities and private sector will, on the one hand, include the mobilization of women's (formal and informal) associations and establishing dedicated platform to voice, participate and collaborate with local authorities on specific women's needs and demands, and on the other hand, realistic but ambitious quota for minimum women's representation on other collaborative platforms will be established. Thirdly, the grant scheme, in addition to the women's representation quota on deliberative and priority setting forums, will have a build-in gender conditionality to ensure that women's needs and interests are covered. Fourthly, the economic resilience component will dedicate special attention to women's participation in training and grant schemes, in addition to specialized workshop on women's MSME.

Briefly describe in the space below how the Project mainstreams environmental sustainability

Consistent with UNDP's Programme and Operations Policies and Procedures, social and environmental sustainability will be enhanced through application of the UNDP Social and Environmental Standards. In addition, the Institutional Resilience Component has dedicated activities to strengthen the capacity of local authorities (in collaboration with local communities) for multiyear environmental, climate resilience and natural disaster risk management/reduction planning and implementation, and, aligned with these new planning capacities, the grant scheme will both reflect and be made conditional upon environmental sustainability within the local context.
