QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

The Access Coordination and Monitoring Support Project (ACMSP) is supporting human rights by opening access to those who do not have access to materials. Therefore, revive projects that supporting different sectors such as health and education. The materials are always secured by more negotiation and strong communication with the Israeli Coordinator of the Government Activities in the Territories (COGAT) and Coordination and Liaison Administration (CLA). The supported projects by ACMSP have level of significance impact on enjoyment of the human rights (civil, political, economic, social and cultural) of the benefited population of Gaza Strip. The presence of the access project enabled access to resources and basic services in particular to marginalized individuals. The restriction on construction materials would potentially restrict availability, quality of and access to these resources and services and would exclude the affected stakeholders from fully participating in decisions that may affect them, and limit their capacity to meet their obligations.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The Access Coordination and Monitoring Support Project is sustaining all UNDP/PAPP projects, and all of them have been already developed based on needs assessments that strongly considered the gender elements through their designs and implementations. The projects were designed to address gender inequities and empower women in Gaza Strip. There is likelihood that deferral or suspension of the access project would have adverse impacts on gender equality and/or those were planned to benefit directly from infrastructure projects, and potentially reproduce discriminations against women based on gender. As a result, this would limit women's ability to use, develop and protect natural resources and could lead to natural resources degradation or depletion in communities who depend on these resources for their livelihoods and well being.

Briefly describe in the space below how the Project mainstreams environmental sustainability

The implementation of Access Coordination and Monitoring Support Project (ACMSP), has an explicitly impact on Environmental sustainability. All the construction projects (supported by access project) are directly aiming for environmental sustainability, and directly tackles different poverty factors, including job creations and exclusions. Therefore, the interruption of these projects' implementations will hinder the environmental and social, the potential relocation of inhabitants, and may cause illegal encroachment on lands by illegal settlers or generate unplanned commercial development along the routes, potentially in sensitive areas as well as decreasing the number of availed job opportunities. Before the implementation of ACMSP, cumulative impacts of multiple activities of construction and infrastructure projects had been hold back. By end of August 2019, the ACMSP injected life into projects with a total value of US\$ 291 million that target different sectors where the different opportunities of environmental sustainability were strongly considered. The conducted projects that implemented by coordinated materials supported different environmental aspects i.e. a) contributed to reserve the cultural heritage; b) Supported the climate change mitigation and adaptation; c) displacement and resettlement; d) supported in pollution prevention and e) availed more than 11.6 million labour days in the construction industry.
