The overall objective of the project is to contribute to the socio-economic development of the regions of Azerbaijan (Balakan, Zaqatala, Gakh, Sheki, Oghuz and Gabala) by fostering the creation of modern and sustainable family businesses in rural areas and enabling equal opportunities. The project fully embraces the human rights based approach, focusing on ensuring fulfilment of human right to employment. The project supports implementation of these human right by introducing improvements of required knowledge and professional skills, technical equipment for qualitative production and subsequent effective distribution of their products in the markets. As a result, through collaboration with and provision of support to the work of "ABAD" public legal entity and selected target families, the project will address the challenges that prevent and impede the development of community-based family businesses and rural entrepreneurship, economic regeneration and job creation in the Sheki-Zaqatala Economic Zone (Balakan, Zaqatala, Gakh, Sheki, Oghuz and Gabala).


