The project directly supports the socio-economic rights of women and war veterans with disabilities by helping them to realise their right to education, information and employment. The project also strives to promote positive attitudes towards PwDs among decision-makers, employees and communities and to combat stereotypes and prejudices relating to PwDs (Article 8 of the CPRD).</p>
Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment	<p>Improving gender equality and women empowerment is the significant objective of the project. Women with Disabilities are the key project beneficiaries that will be helped to strengthen their employability, initiate and develop businesses and to become more socially and economically active. The project also follows up on the concluding observations and recommendations of the Committee on the Elimination of Discrimination against Women issued in March 2015. The project specifically addresses the recommendations to the State Party to ensure the full and equal participation of women in public life; to take measures to increase the participation of women in formal employment, to increase the efforts to encourage and support women's economic empowerment and entrepreneurship, and to adopt special measures targeting women with disabilities.</p>
