The Spotlight regional programme for Central Asia is built on understanding that violence against women is the result of structural, deep-rooted discrimination which the state has an obligation to address. Preventing and addressing gender-based violence requires legislative, administrative and institutional measures and reforms and the eradication of gender stereotypes which perpetuate gender-based violence against women and underpin the structural inequality of women with men. Human rights-based approach is at the core of the Spotlight regional programme. It aims to support better and more sustainable development outcomes for those, whose human rights are left unfulfilled. It seeks to address the inequalities, discriminatory practices and unjust power relations and to contribute to the development of the capacities of “duty-bearers” to meet their obligations and “rights-holders” to claim their rights.

SI will carry out a comprehensive regionally led legislative review to assess progress attained by the countries and as a region in aligning SGBV legislation with CEDAW and related General Recommendations, the Istanbul Convention, the Convention on the Rights of a Child (CRC) General Recommendations, the Istanbul Convention, the CRC and related General Comments , the ICPD Programme of Action, the BPfA and the Convention on the Rights of Persons with Disabilities (CRPD) and related General Comment. It will advocate for participatory approaches in the complex process of gender reform, measure progress through gender-specific performance indicators, garner the support of key stakeholders, and challenge deeply-entrenched gender norms and power structures throughout society.
