Human rights-based approach is at the core of the Spotlight regional programme. It aims to support better and more sustainable development outcomes for those, whose human rights are left unfulfilled. It seeks to address the inequalities, discriminatory practices and unjust power relations and to contribute to the development of the capacities of "duty-bearers" to meet their obligations and "rights-holders" to claim their rights.
