# Russia-UNDP Trust Fund for Development – UNDP "Climate Change Education and Awareness- Climate Box" project

➤ Second Training of Trainers (ToT) was organized for overall 45 public-school teachers and methodologists on 21-22 March 2019. The ToT was facilitated by the team of international trainers from Russian Federation. Best experience and knowledge were shared with the participants, issues and experiences related to the piloting of the CBT at schools were discussed.

- National Contest on environmental initiatives designed by schoolchildren aged 12-17 was organized. Totally fifteen projects were submitted in 2 nominations: "Reducing Carbon Footprint" and "Climate change and Water Resources". The National Jury, comprised of representatives from partner Ministries and project's experts, selected three projects to participate in the International Contest in Almaty, Kazakhstan on 24-27 April, 2019.
- ➤ Climate Box tool was preliminary piloted at 15 public schools.
