MICRO-CAPITAL GRANT AGREEMENT BETWEEN THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP) AND BOUGAINVILLE HOUSE OF REPRESENTATIVES (BHOR) FOR THE PROVISION OF GRANT FUNDS

Micro-Capital Agreement (hereinafter referred to as the "Agreement') made between the Implementing Partner [UNITED NATIONS DEVELOPMENT PROGRAMME - UNDP] and the Recipient Institution [BOUGAINVILLE HOUSE OF REPRESENTATIVES - BHOR].

WHEREAS [UNDP] (hereinafter referred to as "the Implementing Partner") under the project (i) 00099012 — Knowledge Building and Understanding on BPA and (ii) 00099013 — Security and Social Cohesion in Bougainville, to which UNDP has been selected as implementing partner. (hereinafter referred to as "the Project"), implemented at the request of the Government of Papua New Guinea and Autonomous Bougainville Government in [Papua New Guinea]

WHEREAS the Implementing Partner UNDP desire to provide funding to the BOUGAINVILLE HOUSE OF REPRESENTATIVEs in the context of a Project and on the terms and conditions hereinafter set forth, and

WHEREAS the **BOUGAINVILLE HOUSE OF REPRESENTATIVES** is ready and willing to accept such funds from the Implementing Partner **UNDP** through the administration of UNDP for the above mentioned activities on the said terms and conditions.

NOW, therefore, the parties hereto agree as follows:

I. Responsibilities of the RECIPIENT INSTITUTION

- 1.1 The BOUGAINVILLE HOUSE OF REPRESENTATIVES agrees to: 1)
 Undertake the activities described in its Workplan and Budget (attached), and updates related to the subsequent release of funds in one Tranche; 2) Provide reports to the Country Office through the PBF Coordinator; and 3) Submit a financial report as per the due date specified in attachment 3: Schedule of Activities, Facilities and Payments table. Funds provided pursuant to this Agreement shall be used for purposes related to producing results specified in its expected Outputs and Indicators including targets [Attachment 3B].
- 1.2 The BOUGAINVILLE HOUSE OF REPRESENTATIVES agrees to reach the performance targets contained in Attachment 3B. If it fails to meet its responsibilities outlined in article 1.1, or to attain at least specified % of any one performance target for any given period, then this will be considered grounds for the Steering Committee to suspend any further micro-capital grant support. The suspension shall remain in effect until the BOUGAINVILLE HOUSE OF REPRESENTATIVES has achieved the target. In projects with a technical assistance contractor, the contractor may, at its discretion,

continue to provide technical assistance to the BOUGAINVILLE HOUSE OF REPRESENTATIVES during this suspension period.

1.3 BOUGAINVILLE HOUSE OF REPRESENTATIVES agrees to inform the Steering Committee about any problems it may face in attaining the objectives agreed upon.

II. <u>Duration</u>

2.1 This Agreement will come into effect on 15th March 2018 and shall expire on 13 April 2018, covering the anticipated term of the project. It can be extended, if necessary by exchange of letters, noting the new expiration date.

III. Payments

1.1 UNDP shall provide funds to the BOUGAINVILLE HOUSE OF REPRESENTATIVES in an amount up to (PGK353,100.00) USD\$111,037.74 (One Hundred and eleven Thousand thirty seven Dollars and seventy four cents) according to the schedule of the project budget set out below.

- 4.2 The BOUGAINVILLE HOUSE OF REPRESENTATIVES shall furnish, compile and make available at all times to UNDP any records or information, oral or written, which UNDP may reasonably request in respect of the funds received by the Bougainville House of Representatives.
- 4.3 Within sixty days after completion of project activities, BOUGAINVILLE HOUSE OF REPRESENTATIVES shall provide UNDP with a final report with respect to all expenditures made from such funds (including travel, allowances, travel and supplies) and indicating the progress made toward the goals of the activities undertaken, utilizing the reporting format contained in Attachments 5 and 6

V. <u>General Provisions</u>

- 5.1 This Agreement and the Attachments attached hereto shall form the entire Agreement between [UNDP] and Bougainville House of Representatives superseding the contents of any other negotiations and/or agreements, whether oral or in writing, pertaining to the subject of this Agreement.
- 5.2 The BOUGAINVILLE HOUSE OF REPRESENTATIVES shall carry out all activities described in its Workplan with due diligence and efficiency. Subject to the

- 5.7 This Agreement may be terminated by either party before completion of the Agreement by giving thirty (30) days written notice to the other party, and the BOUGAINVILLE HOUSE OF REPRESENTATIVES shall promptly return any unutilized funds to UNDP as per paragraph 5.6 above.
- 5.8 The BOUGAINVILLE HOUSE OF REPRESENTATIVES acknowledges that UNDP and its representatives have made no actual or implied promise of funding except for the amounts specified by this particular tranches Agreement. Although project related documents may indicate a total amount of funds that could be available for Bougainville House of Representatives, actual disbursements will be based upon the BOUGAINVILLE HOUSE OF REPRESENTATIVES meeting performance targets. If any of the funds are returned to UNDP or if this Agreement is rescinded, the BOUGAINVILLE HOUSE OF REPRESENTATIVES acknowledges that the Implementing Partner and UNDP will have no further obligation to the BOUGAINVILLE HOUSE OF REPRESENTATIVES as a result of such return or rescission.
- 5.9 No modification of or change to this Agreement, waiver of any of its provisions or additional contractual provisions shall be valid or enforceable unless previously approved in writing by the parties to this Agreement or their duly authorized representatives in the form of an amendment to this Agreement duly signed by the parties hereto.
- 5.10 Any controversy or claim arising out of, or in accordance with this Agreement or any breach thereof, shall unless it is settled by direct negotiation, be settled in accordance with the UNCITRAL Arbitration Rules as at present in force. Where, in the course of such direct negotiation referred to above, the parties wish to seek an amicable settlement of such dispute, controversy or claim by conciliation, the conciliation shall take place in accordance with the UNCITRAL Conciliation Rules as at present in force.

The parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such controversy or claim.

5.11 Nothing in or relating to this Agreement shall be deemed a waiver of any privileges and immunities of the United Nations, or UNDP.

express terms of this Agreement, it is understood that the BOUGAINVILLE HOUSE OF REPRESENTATIVES shall have exclusive control over the administration and implementation of the activities referred to above in paragraph 1.1 and that the UNDP shall not interfere in the exercise of such control. However, both the qualities of work and the progress being made toward successfully achieving the goals of such activities shall be subject to review by the Steering Committee. If at any time the Steering Committee is not satisfied with the quality of work or the progress being made toward achieving such goals, the Steering Committee may advise UNDP to: (i) withhold payment of funds until in its opinion the situation has been corrected; or (ii) declare this Agreement terminated by written notice to the BOUGAINVILLE HOUSE OF REPRESENTATIVES as described in paragraph 5.7 below; and/or seek any other remedy as may be necessary. The Steering Committee's determination as to the quality of work being performed and the progress being made toward such goals shall be final and shall be binding and conclusive upon the BOUGAINVILLE HOUSE OF REPRESENTATIVES insofar as further payments are concerned.

- 5.3 UNDP undertakes no responsibilities in respect of life, health, accident, travel or any other insurance coverage for any person which may be necessary or desirable for the purpose of this Agreement or for any personnel undertaking activities under this Agreement. Such responsibilities shall be borne by the Bougainville House of Representatives.
- 5.4 The rights and obligations of the BOUGAINVILLE HOUSE OF REPRESENTATIVES are limited to the terms and conditions of this Agreement. Accordingly, the BOUGAINVILLE HOUSE OF REPRESENTATIVES and personnel performing services on its behalf shall not be entitled to any benefit, payment, compensation or entitlement except as expressly provided in this Agreement.
- 5.5 The BOUGAINVILLE HOUSE OF REPRESENTATIVES shall be solely liable for claims by third parties arising from the BOUGAINVILLE HOUSE OF REPRESENTATIVES acts or omissions in the course of performing this Agreement and under no circumstances shall The Implementing Partner and UNDP be held liable for such claims by third parties.
- 5.6 Assets (Equipment) supplied by UNDP funds to the BOUGAINVILLE HOUSE OF REPRESENTATIVES shall be the property of UNDP until the end of the project, at which time UNDP shall determine the best use of these assets. In cases where the BOUGAINVILLE HOUSE OF REPRESENTATIVES has met its responsibilities under this agreement, and handover of the asset would contribute to the sustainability of activities, UNDP would normally handover these assets to the Bougainville House of Representatives. The assets shall be used for the purpose indicated in the Workplan throughout the period of this Agreement.

PBF support to the Bougainville House of Representatives

BACKGROUND

The Autonomous Region of Bougainville (ARoB) is an autonomous region within the state of Papua New Guinea (PNG), with its own Government and parliament. It also has representatives at the National Parliament. It counts a population of about 300,000 people. Following nearly a decade of a bloody conflict (from late 1980s) with estimated deaths of up to 20,000 people, the PNG national Government and the Bougainville actors signed the Bougainville Peace Agreement in 2001 (BPA). Social grievances, political in-fighting and disagreements about the use of the revenue from the Panguna copper mine in Central Bougainville and its environmental effects were key triggers of the conflict.

A Peacebuilding Priority Plan as signed in 2014 which enabled support from the UN Peacebuilding Fund (PBF) to three key priorities identified by the PNG Government (GoPNG) and the Autonomous Bougainville Government (ABG)

The Bougainville House of Representatives (BHOR) has a total membership of 41, comprising 39 elected members, the Speaker and the President. The Speaker is appointed by the House from outside its membership. With respect to the remaining 39 House members: for the first general election of members of the House of Representatives, there were:

- 33 directly elected members each representing a single member constituency;
- three women members, each representing a constituency for a separate Region (North, Central and South)
- three former combatant members, each representing a constituency for a separate Region (North, Central and South)

The most recent election to the House of Representatives was in June 2015 where 25 of the MPs elected at this election are new to Parliament. A woman member was the first to be elected in an open seat and holds a Minister in the ABG. Following requests from the Speaker and the Clerk of the BHOR, UNDP has provided funding and technical assistance on a range of parliamentary strengthening activities as well as the implementation of the Bougainville Peace Agreement (BPA) and referendum preparations.

KEY OUTCOMES OF THE PBF

UNDP's support to the BHOR, ABG and other partners in Bougainville fall under 3 Outcome Areas which have been translated into 3 projects and are intended to be cohesively achieved, consistent with the Peacebuilding Priority Plan.

Outcome 1 - Strengthening partnership and political dialogue between GoPNG and ABG

The first Outcome area of the Priority Plan that is supported by PBF, targets the strengthening of the relationship and trust between the National Government of Papua New Guinea (GoPNG) and the ABG to contribute to effective implementation of autonomy arrangements and of the BPA. This project addresses 2 broad outcomes statements: -

- (1) The key BPA provisions on autonomy arrangements and on the referendum, are progressed through joint decisions and actions of GoPNG and the ABG.
- (2) The National and the Bougainville Parliaments (BHOR) have a shared understanding of the BPA and the referendum provisions and the effectiveness of the BHOR is strengthened, in line with the 2013 Autonomy Review findings

Support is being provided to both the GoPNG and the ABG through mechanisms such as the Joint Referendum Committee, empowering them to progress key processes within the BPA in a

timely and effective manner. The dialogue and engagement between both Governments is being bolstered drawing on the UN 'trusted broker' role and expertise. The focus is on workable autonomy arrangements, constructive relationships between the Governments, and progress made on referendum preparations. There is also ongoing support to the inter-parliamentary dialogue between to the two governments with a view to a shared understanding of the two parliaments' role in the implementation of the BPA, human rights and other key peace-building issues.

Outcome 2 - Support knowledge-building and understanding of the Bougainville Peace Agreement.

One of the key factors contributing to potential instability is a lack of accurate, relevant and trusted information sources amongst much of the population; and widespread skepticism and distrust of those in leadership positions. The people of Bougainville have not had access to accurate, easy to use, information or safe places where they are encouraged to express their views, debate and to question and give feedback to the political leadership. The second Outcome of the Priority Plan that is supported by PBF focuses on creating an enabling environment so that the people of Bougainville are empowered to make informed choices at the Bougainville referendum and to have increased confidence in the BPA process through access to more objective and accurate information. It also supports dialogue and debate on key peace-building issues, both within communities and with their political leaders.

Outcome 3 - Promoting community security and social cohesion in Bougainville

The third Outcome area of the Priority Plan that PBF supports is the strengthening of Community social cohesion and security in Bougainville through opportunities to deal with conflict-related trauma effectively to enable peaceful resolution of local disputes as well as through better access to information to access appropriate post-conflict services or support. Here, the project supports two broad outcome statements: -

- (1) Increased community social cohesion and community security) through access to trauma healing and reconciliation services
- (2) Community police, trauma counselors and health workers dealing with FSV provide more effective and informed services on trauma response and reconciliations.

In addition to the broad categories of support, the project currently includes elements of unification, reconciliation and weapons disposal.

RATIONALE AND KEY AREAS OF FOCUS

Delivery of PBF projects support to the ABG has been through the Direct Implementation Modality (DIM) of UNDP. Based on the strong partnership between the BHOR and UNDP since 2015 and to increase delivery of the planned activities given the timeframe of the projects, the parties have discussed the options to further support the activities of the BHOR in line with the 3 Outcomes areas of the Peacebuilding Priority Plan.

This has prompted the need to assess and identify, from available options, a more effective mode for delivery of support. This best option available that has been identified is a *Grant Agreement (GA)*. While having an effective monitoring mechanism in place, it will allow for better and timely implementation of PBF projects.

It is intended that an GA be signed between the UNDP and the BHOR as part of Project 00099011. The GA will also guarantee a portion of funding from the PBF to be placed in a BRCC Trust Account (Bougainville Referendum Communication Committee (BRCC) Trust Account, Account No.: 7010785371) and managed directly by BHOR, for PBF activities under Project 00099012 supporting referendum and BPA awareness, and Promoting Community Security and Social Cohesion so specifically named in the GA under Project 00099013.

The fund from this GA to be accessed by BHOR. The funding will be accessed, and activities implemented within the terms of the GA and the UNDP 2018 PNG Country Office Annual Work Plan for the No Cost Extension Phase.

The funding that will be made available will be subjected to completed Letter of Requests forms from BHOR. Continuity of the GA will be dependent on the manner in which mandatory milestones of this GA are achieved. While the bulk of PBF projects continue to be supported through DIM, selected activities as outlined below will be addressed through an GA.

The GA will provide support to: -

- a) The Referendum Ready Concept through continued funding for Phase 2 of support to the BHOR Members Constituency Awareness conducted across the region. 21 Members of the BHOR will be supported under this GA. Their constituencies are named as follows:

Support under the GA will be from March 15th to April 13th, 2018 payable based on identified milestones: -

Submission of Letter of Requests for funding completed with all required supporting documents from Constituency members to the GA Project Management Team. Activities for support will have to be aligned with the Referendum Ready Awareness work plan of BHOR and the PNG PBF 2018 Annual Work Plan of the No Cost Extension)

Funding through the GA will be placed in the "Bougainville Referendum Communications Committee Trust Fund". Signatories to cheques drawn on this account will be: -

- A PNG Counterpart in ABG Treasury (Provincial Treasurer)

The project steering committee playing an oversight role to ensure that provisions of the Grant Agreement are adhered to by the Bougainville House of Representative (BHOR), met on the 26^{th} February, 2018 with the agenda as follows:

- 1. Submission and presentation of the Proposal for the BHOR phase 2 outreach programme to UNDP Bougainville.
- 2. Discussion and agreement of the Funding Modality for this programme with strong recommendation for a robust and less complex implementation modality mindful of the very limited time for the PBF No cost Extension (NCE)

The Committee having reviewed the submission (attached), agreed that;

- a) Since this is a sensitive political activity and would require preparations on the ground, a grant will be awarded to the BHOR under a grant agreement to implement the activity;
- As UNDP had previously supported BHOR in its outreach programme through a Trust Account, the same account will be used for the grant that will be awarded to BHOR;
- c) The Honourable Speaker and Clerk of the BHOR consented for the Capacity Assessment to be done on the BHOR.
- d) The risk analysis for the financial component will be linked with the findings of the BHOR earlier implemented Letter of Agreement (LoA) Lessons Learned Exercise (LLE) conducted in February and March 2018, and the management strategies to deal with them will be drawn from the risks identified. This to ensure that due diligence processes are stringently followed. In areas where the overall risk is assessed as high, the Project Manager will consult with UNDP CO and put in place measures such as installments (80/20) to ensure strict adherence to UNDP rules and regulations.

The Committee therefore agreed that a capacity needs assessment would be conducted on the BHOR as soon as possible. As per the work plan and budget, it was agreed that BHOR will be the recipient of the grant.

Background

The Bougainville House of Representatives (BHOR) has a total membership of 41, comprising 39 elected members, the Speaker and the President. The Speaker is appointed by the House from outside its membership. With respect to the remaining 39 House members: for the first general election of members of the House of Representatives, there were:

- 33 directly elected members each representing a single member constituency;
- three women members, each representing a constituency for a separate Region (North, Central and South)
- three former combatant members, each representing a constituency for a separate Region (North, Central and South)

The most recent election to the House of Representatives was in June 2015 where 25 of the MPs elected at this election are new to Parliament. A woman member was the first to be elected in an open seat and holds a Minister in the ABG. Following requests from the Speaker and the Clerk of the BHOR, UNDP has provided funding and technical assistance on a range of parliamentary strengthening activities as well as the implementation of the Bougainville Peace Agreement (BPA) and referendum preparations.

Moreover A Peacebuilding Priority Plan as signed in 2014 which enabled support from the UN Peacebuilding Fund (PBF) to three key priorities identified by the PNG Government (GoPNG) and the Autonomous Bougainville Government (ABG).

UNDP's support to the BHOR, ABG and other partners in Bougainville fall under 3 Outcome Areas which have been translated into 3 projects and are intended to be cohesively achieved, consistent with the Peacebuilding Priority Plan.

Delivery of PBF projects support to the ABG has been through the Direct Implementation Modality (DIM) of UNDP. Based on the strong partnership between the BHOR and UNDP since 2015 and to increase delivery of the planned activities given the timeframe of the projects, the parties have discussed the option of LOA to further support the activities of the BHOR in line with the 3 Outcomes areas of the Peacebuilding Priority Plan. Thus the need for capacity assessment.

Conclusion and Recommendation:


The information provided reflects the current status of the operation of the Parliamentary Service. It is important to note that the statements made are relevant to the scope of the project.
